Wallace Warfield is an Associate Professor at the Institute of Conflict Analysis and Resolution, George Mason University in Arlington. In this capacity, Dr. Warfield teaches laboratory-simulation and practicum courses, as well as theory courses. As a consultant, Dr. Warfield has worked in community, interethnic, and organizational conflict in the U.S. and other countries. He has also authored a number of publications in the field of conflict analysis and resolution.

Prior to his affiliation with ICAR, Dr. Warfield served as a Distinguished Visiting Fellow at the Administrative Conference of the United States (ACUS). At ACUS, he was responsible for helping Federal agencies build alternative dispute resolution processes into their administrative systems, developing and implementing training for government contracting offices, boards of contract appeal judges, administrative law judges and others in the Federal sector.
