To Attorneys, CM/ECF Users, and the Public:

This communication contains information about news, events, and activities at the Bankruptcy Court. While much of this information is contained on the Court's website, I convey it to you for immediate use.

- **Revised Implementation Order** The Court's Implementation Order has been updated to reflect a change in how submission of payment advices and taxes to Chapter 7 and Chapter 13 trustees will be monitored and enforced (effective March 1, 2007). See the Order for details concerning the 45 day deadline of § 521(i) for payment advices and the 7 calendar day deadline of § 521(e)(2) for taxes. - **Statistical Information** The Judiciary relies upon the accuracy of the data entered by attorneys. Please be sure to enter accurate statistical information at case opening.
- **Upgrades to mailing labels from CM/ECF** Attorneys will be able to see the National Preferred Creditor Address now as part of the Mailing Labels feature in CM/ECF. For mailing lists produced by registered CM/ECF users, the BNC contractor modified the label creation process to clearly identify National Creditor Registration Service (NCRS) preferred addresses. The label now includes the original creditor address filed by the debtor along with the preferred creditor address filed with the BNC contractor. In addition, all duplicate and undeliverable addresses are identified on the mailing label sheet in order to reduce the transmission of unnecessary notices locally by the case participant. For attorneys who want to see correct national addresses, choose "utilities", then click "mailings", then click any of the choices.
- **Free Access to Opinions through Opinions Report** In addition to being available on the Court's website, opinions from the CM/ECF Opinions Report are available without charge through PACER. Under the Electronic Public Access (EPA) fee schedule approved by the Judicial Conference, PACER and CM/ECF have been programmed to allow users to run the opinions report and access the opinions that appear on it without charge, preserving the free access to opinions that the public has come to expect.
