FILING A PROOF OF CLAIM - GO FIG CASES

Several Go Fig companies have filed for bankruptcy protection. If you believe that any of the Go Fig companies owe you a pre-bankruptcy debt, you must file a proof of claim. A proof of claim form can be found at http://moeb.uscourts.gov/forms/PDF/poc_404.pdf. Instructions on filling out the proof of claim form can be found at http://moeb.uscourts.gov/forms/PDF/inst_poc404.pdf. To file a proof of claim in any of the Go Fig bankruptcy cases, you must determine the Go Fig company against which you believe you have a claim. For ease of administration, the Court has allowed the Go Fig cases to be jointly administered. This means that most documents, etc. are only to be filed in the main Go Fig case - Go fig, Inc., Case no. 08-40116. https://moeb.uscourts.gov/forms/PDF/poc_404.pdf. Instructions on filling out the Fig. Description of the Go Fig bankruptcy cases, you must determine the Go Fig company against which you administered. This means that most documents, etc. are only to be filed in the main Go Fig case - Go fig, Inc., Case no. 08-40116. https://moeb.uscourts.gov/forms/PDF/poc_404.pdf. Instructions on filling out the Go Fig cases, you must determine the Go Fig company against which you believe you have a claim. For example, if you believe that you have a claim against Fig. Dallas, LP, you would file the proof of claim in Case no. 08-40120, not in the main Go Fig case. Of course, if your claim happens to be against Go fig, Inc., you would file your proof of claim in the main case, Case no.08-40116. Please be sure to include the proper debtor name and case number on the proof of claim form. The deadline for filing proofs of claim is 5/23/2008. For government entities, the deadline to file proofs of claim is 7/22/2008.

PATIENT-CREDITORS MUST FILE THEIR PROOFS OF CLAIM BY MAIL, EVEN IF THEY ARE REPRESENTED BY AN ATTORNEY. THIS IS AN EXCEPTION TO THE NORMAL PRACTICE FOR ATTORNEYS FILING PROOFS OF CLAIM. Proofs of claim may be mailed (postage pre-paid) to

Please enclose an extra copy of the proof of claim and a self addressed stamped envelope if you would like a time-stamped copy of the proof of claim by the Court for your records. The proof of claim must be **RECEIVED** on or before the deadline. Claims against multiple debtors may <u>not</u> be filed in a single proof of claim. If you have claims against more than one Go Fig company, you must file a separate proof of claim for each company.

Neither the Court nor the Clerk of Court may assist you with completing and/or filing the proof of claim except for answering general questions regarding, for example, where to mail the proof of claim (see above), how many copies to include (2 if you want one back), etc. For further assistance regarding, for example, your rights and strategy for proceeding in the case, you should consult with an attorney.
