3	PREPARATION FOR SETTLEMENT CONFERENCE		
4	No later than seven business days before the settlement conference, the parties shall		
5	exchange written settlement offers. No later than four business days before the settlement		
6	conference each party shall submit a confidential settlement conference statement, which will		
7	<i>include a copy of the last settlement offer,</i> to the chambers of for <u>in</u>		
8	camera review. If not timely submitted, sanctions may be imposed. The settlement conference		
9	statement shall be no longer than 5 double-spaced pages. The settlement conference statement shall		11
10	contain the following:		
11	1.	A brief statement of the nature of the action.	
12	2.	A concise summary of the evidence that supports your theory of the case, includin	g
13	information documenting your damages claims. You may attach to your statement a limited number		
14	of documents or exhibits that are <u>especially</u> relevant to key factual or legal issues.		
15	3.	A brief analysis of the key issues involved in the litigation.	
16	4.	A discussion of the strongest points in your case, both legal and factual, and a fran	<u>k</u>
17	discussion of the weakest points as well. The court expects you to present a candid evaluation of		
18	the merits of your case.		
19	5.	A further discussion of the strongest and weakest points in your opponents' case	e,
20	but only if they are more than simply the converse of the weakest and strongest points in your case.		e.
21	6.	A history of settlement discussions, if any, which details the demands and offer	rs
22	which have been made, and the reasons they have been rejected.		
23	7.	The settlement proposal that you believe would be fair.	
24	8.	The settlement proposal that you would honestly be willing to make in order t	0
25	conclude this matter and stop the expense of litigation.		
26	The settlement conference statement should be delivered to chambers in an envelope

each statement will be strictly maintained and following the conference, the statements will be
destroyed.

10 The settlement conference shall not be continued or vacated without prior approval
 11 of the judge assigned to the case.
 12 FAILURE TO APPEAR WILL RESULT IN THE IMPOSITION OF SANCTIONS. IF
 13 THE MATTER IS SETTLED BEFORE THE SETTLEMENT CONFERENCE DATE, THE

14 PARTIES MUST NOTIFY THE SETTLEMENT CONFERENCE JUDGE'S CALENDAR CLERK

15 SO THAT THE MATTER CAN BE TAKEN OFF CALENDAR.
