The Defense Contract Management Agency is a Department of Defense combat support agency responsible for ensuring the integrity of contractual processes and providing a broad range of contract-procurement management services for America's warfighters. The agency's team of professionals ensures that federal acquisition programs, supplies and services are delivered on time and within cost and meet performance requirements. Managing 291,000 prime contracts currently valued at \$950 billion, DCMA directly contributes to U.S. military readiness and preservation of the nation's freedom.

Headquartered in Alexandria, Va., DCMA is organized into six divisions — Aeronautical Systems, Space & Missile Systems, Ground Systems & Munitions, Naval Sea Systems, Special Programs and International — that oversee 50 contract management offices responsible for work performed at over 900 locations worldwide.

Approximately 10,000 civilian and military professionals in plants throughout the United States and in 26 countries around the world carry out DCMA's mission — provide customer-focused acquisition support and contract management services to ensure worldwide warfighter readiness 24/7. DCMA's professionals serve as information brokers for military buying agencies both during the acquisition cycle and throughout the life of the contract. The DCMA team interacts on a daily basis with customers to ensure that the services provided meet customers' needs.
