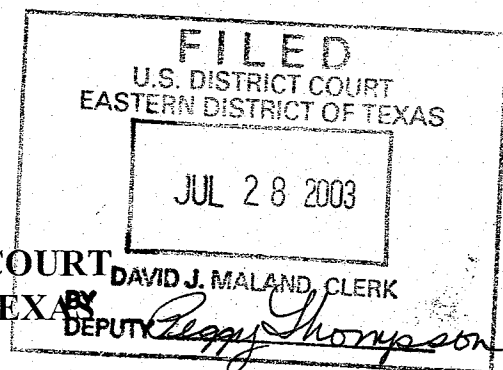

**GENERAL ORDER TRANSFERRING
SELECTED MARSHALL DIVISION TORT CASES
TO JUDGE LEONARD DAVIS**

There has been an unusual number of tort cases filed in the Marshall Division during the months of May and June 2003. To redistribute the caseload the Court has determined that one-third of these filings will be transferred to Judge Leonard Davis.

Judge T. John Ward and Judge David Folsom have consented to this transfer and have arranged for the use of the Harrison County District Court facilities for the trial of any case not otherwise disposed of.

A listing of all tort cases filed during these two months is attached with every third case listed being transferred. Exhibit A attached is the number and style of the cases randomly selected for transfer.


