The program focuses on creating and delivering practical legal tools, training materials, and authoritative information for public health policy makers and practitioners. To strengthen the science base, we direct a peer-reviewed, extramural program of research evaluating the impact of public health laws. In all our work, we partner closely with CDC colleagues and, extramurally, with public health policy makers and practitioners, elected officials, public health and healthcare attorneys, the judiciary and law enforcement agencies, emergency management professionals, researchers, educators, and many others committed to better public health.



### How Does Law Contribute to Public Health?

aw is a traditional tool for preventing disease, injury, and disability. Law was critical to the dramatic public health advances of the 20th century. The success of childhood immunization, seat belts and bicycle helmets, smoking prevention, drinking water protection, occupational safety programs, and many other public health interventions hinges significantly on appropriate application of law and legal tools.

Law already is making important contributions to the public's health in the 21st century. Tobacco, poor diet and physical inactivity, alcohol, infectious diseases, and motor vehicle injuries are among the greatest underlying causes of preventable disease and premature death for Americans. Working in concert with other interventions, law can be an effective tool to attack these problems, to address such emerging threats as terrorism and pandemic influenza, and to take full advantage of scientific breakthroughs in genomics and other fields with new potential for public health benefits.

CDC's Public Health Law Program develops and provides products that public health practitioners and policy makers, as well as their partners in many fields, can use to apply law to the public health priorities of their communities.




#### **Public Health Emergency Law**

To develop a practical grounding in the laws supporting effective response to public health emergencies, this new course for frontline public health and emergency management professionals clarifies the relevant state and federal legal powers and also includes a simulated emergency case study.

#### Forensic Epidemiology

A one- or two-day course in joint investigative techniques for public health and law enforcement professionals when responding to a suspected or confirmed bioterrorist attack; developed in partnership with public health professional associations, the U.S. Department of Justice, and state and local law enforcement organizations.



#### **Community Public Health Legal Preparedness**

This initiative gives healthcare attorneys insight into the legal framework for response to public health emergencies by hospitals and other healthcare providers. Strategically, it fosters partnerships between healthcare attorneys and public health attorneys across the full range of their practice.

#### The Public Health Legal Preparedness Clearinghouse

This web-based resource holds an expanding collection of state, local, and federal public health laws, executive orders, rulings, and related legal documents for ready access by policy makers and practitioners. Special emphasis is on public health emergency law. Also included is a directory to the legal counsel to all state public health departments.

#### Law for Chronic Disease Prevention
