


Historically large colonies in abandoned mines along the Colorado River

Marked declines attributable to loss of cottonwood riparian and roost disturbance



















Mine Locations Along the Lower Colorado River




Moon Phase Effect January 2003






Homestake Mine winter and spring exit counts




Jackpot Mine spring exit count






Californian Mine winter exit counts






Mountaineer Mine winter exit count




Stonehouse Mine complex winter and spring exit counts




Hart Mine winter exit counts



Eureka Mine spring and summer exit counts




Golden Dream shaft spring and summer exit counts






3C Mine winter exit counts
