**AEMA sends over \$500,000 to communities in Alabama for mitigation projects**

CLANTON - Sixteen Alabama communities received Federal Emergency Management Agency (FEMA) hazard mitigation reimbursements totaling \$568,529.16 over the past two weeks. These grants are administered by the Alabama Emergency Management Agency and are paying for ongoing mitigation projects designed to reduce disaster losses and protect life and property from future disaster damages in Alabama.

The Pre-Disaster Mitigation (PDM) program provides funds to states, territories, Indian tribal governments, communities, and universities for hazard mitigation planning and the implementation of mitigation projects prior to a disaster event.

Most grant payments above were a part of HMGP funds resulting from Hurricane Katrina.
