

I-Suite 11.01.00 Release Notes

Date: June 13, 2011

Version: I-Suite Version 11.01.00

• **Description:** The primary focus of this release is to support the Windows 7 and Server 2008 operating systems, improve Cost Module calculations, improve Supply Module functionality, and to address several outstanding application defects.

Important things to know prior to installing I-Suite Full Server Windows 7 and Windows Server 2008

- Windows 7 or Server 2008must use the Version 11.01.00 Full Server Install. A Windows 7 or Server 2008 Client install for version 11.01.00 is not available at this time.
- System Administrative privileges <u>are</u> required to install the application.
- The I-Suite Server machine must <u>run as Administrator</u> to perform many of the database administrative functions, e.g. Attach and Detach databases
- Server Installs configured as clients will operate without administrative privileges
- The new database version is 11.01.01. Previous Version 10 databases are automatically updated to the new database version the first time the database is connected to the server computer. This may take several minutes depending on the size of the database. (New reference data will not be included in updated 10.01.02 databases)
- Install the same version of I-Suite on all server and client computers.

Important things to know prior to installing I-Suite Version 11.01.00 Full Server and I-Suite Version 11.01.00 Client Windows XP

- The Full Server and Full Client install can both be installed mid-incident. Run a backup of your database prior to updating I-Suite.
- System Administrative privileges <u>are</u> required to install the application.
- The new database version is 11.01.01. Previous Version 10 databases are automatically updated to the new database version the first time the database is connected to the server computer. This may take several minutes depending on the size of database. (New reference data will not be included in updated 10.01.02 databases)
- Install the same version of I-Suite on all server and client computers.

Important things to know prior to installing I-Suite Version 11.01.00 Server Update and I-Suite Version 11.01.00 Client Update Windows XP Only

- Only install this update on a computer with I-Suite version 10.01.02 already installed
- The Full Server and Full Client install can both be installed mid-incident. Run a backup of your database prior to updating I-Suite.
- System Administrative privileges <u>are</u> required to install the application.
- The new database version is 11.01.01. Previous Version 10 databases are automatically updated to the new database version the first time the database is connected to the server computer. This may take several minutes depending on the size of database. (New reference data will not be included in updated 10.01.02 databases)
- Install the same version of I-Suite on all server and client computers.

Important Note: When uninstalling Version 11 that was updated from Version 10, Install Shield will reference Version 10 on the uninstall screens. The displayed Version will not affect the uninstall process.
