



Subject: I-Suite Application Version 12.01.00

Version 12.01.00 of the I-Suite Application is now available for download at <u>http://isuite.nwcg.gov</u>.

The primary focus of this release is to allow I-Suite to run on Windows 7 and Windows Server operating systems as a standard user and to upgrade the installation software to support both 32 and 64 bit operating systems. Module highlights include adding safety nets to check for invalid dates in Check-in and Demob, correct Time contract guarantee calculations, and improve Supply Module functionality.

The Release Notes are posted on the I-Suite Web Site.

The Full Server, Full Client, Server Update and Client Update installs can be installed midincident. Run a backup of your database prior to updating I-Suite.

System Administrative privileges <u>are</u> required to properly install all I-Suite versions. A reboot must be performed after the installation is finished and re-login with System Administration privileges for the install to complete.
