Version 13.01.01 of the I-Suite Application is now available for download at http://isuite.nwcg.gov.

The primary focus of this release is to address several outstanding application defects and add minor improvements to meet the current business need. For more details on what is included in this release, please read the Summary Release Information below.

The Full Server, Full Client, Server Update and Client Update installs can be installed midincident. Run a backup of your database prior to updating I-Suite.

System Administrative privileges <u>are</u> required to properly install all I-Suite versions. A reboot must be performed after the installation is finished and re-login with System Administration privileges for the install to complete.
