

I-Suite Patch 12-2 Release Notes

Date: September 05, 2012 **Version:** I-Suite 12.01.02

Description: The primary focus of this patch is to address two cost calculation issues and minor application defects.

Things to know prior to installing I-Suite Patch 12-2, Version 12.01.02

 There are two different patches available depending on your configuration and operating system. See chart below:

Note: Has not been tested on Windows Vista or Windows XP 64 Bit operating systems.			

- This patch must be installed on all computers running I-Suite version12.01.XX.
- This patch includes all updates in Patch 12-1.
- This patch can be applied to a server or client installation of I-Suite.
- Recommend updating the server machine prior to updating the clients.
- System Administrative privileges are required to properly install this patch.
- This patch can be installed mid-incident.
- For both Server and Client computers, close the I-Suite application and all related windows on the local computer before installing this patch.
- It is recommended that a back-up of the I-Suite database be made prior to any application updates.
- The installation of I-Suite Patch 12-2 will replace the following files: ISuite.exe, Reports Folder.
- Opening the I-Suite application on the server computer, attaching a database, and creating a new database will update the database to version 12.01.11.
