Description: The primary focus of this patch is to make corrections to the merge function to allow combining select incidents when merging databases. Other changes included in this patch are identified in the Summary Release Information section of this document.

Things to know prior to installing I-Suite 8.01.04

- Includes all previous patches released since I-Suite version 8.01.02, May 2008.
- Recommend that this patch be installed on all computers running I-Suite 8.01.02 with or without previous patches.
- This patch can be applied to a server or client installation of I-Suite.
- System Administrative privileges are NOT required to properly install this patch.
- This patch can be installed mid-incident.
- Close the I-Suite application and all related windows on the local computer before installing this patch.
- The installation of I-Suite Patch 2008-2 will replace the following files: ISuite.exe (new version 8.01.04), I-Suite_Help.chm and ISuiteBlank.mdf.gpg (new version 8.01.19). A new merge_report.rpt file is also included in this release.
- It is recommended that a back-up of the I-Suite database be made prior to any application updates.
