Dear Chairman LaFleur, Commissioner Dardenne and Mr. Purpera:

In accordance with Section 18B of Act 16 of the 2015 Regular Legislative Session, attached you will find a report which shows specific data regarding compliance with this Section by line item appropriations to public or quasi-public entities in Schedule 20-901, Sales Tax Dedication and Schedule 20-945, State Aid to Local Government Entities.

In order for the recipient to receive the appropriated funds, a Cooperative Endeavor Agreement (Agreement) must be signed and approved by the Louisiana Department of the Treasury, the transferring agency, and the recipient. This Agreement shows the approved use of the appropriation, duration of the project and a plan showing specific goals and objectives to be attained by the recipient including measures of performance. The Department of the Treasury submits a copy of the line item budget and goals and objectives of each Agreement to the Legislative Auditor. The Agreement requires the recipient to submit to Treasury quarterly progress and cost reports with backup documentation to justify the expenditures made during the quarter.
