- **SUBJECT:** NEW BAY-DELTA CRITICAL CONSERVATION AREA RCPP 2014 FARM BILL CONSERVATION PARTNERSHIP PROGRAM

The Natural Resources Conservation Service (NRCS) has developed a new program called the Regional Conservation Partnership Program (RCPP) that may be of interest to irrigated agricultural stakeholders. The RCPP promotes coordination between NRCS and its partners to deliver conservation assistance to producers and landowners. NRCS provides assistance to producers through partnership agreements and through program contracts or easement agreements.

On May 27, 2014, USDA Secretary Vilsack announced the eight Secretarial designated Critical Conservation Areas (CCA) and the Bay-Delta Watershed was chosen as a CCA of national significance [note the Bay-Delta watershed includes the whole Central Valley]. The program combines and replaces the Agricultural Watershed Enhancement Program (AWEP) and the Cooperative Conservation Partnership Initiative (CCPI) both of which were widely used in California and both of which brought needed additional funding for financial assistance on-farm. The RCPP has other unique aspects, for example the opportunity to also include easements in RCPP projects and new opportunities for Technical Assistance for partnering organizations.
