Trans-Alaska Pipeline System Right-of-Way Renewal

BLM, DNR Invite Public to Review, Comment on Draft Environmental Impact Statement, DNR Commissioner's Statement of Reasons and Proposed Written Determination

ANCHORAGE, Alaska – The Bureau of Land Management (BLM) and the Alaska Department of Natural Resources (ADNR) of the federal/state Joint Pipeline Office (JPO) announce the availability of the following two documents regarding the Trans-Alaska Pipeline System (TAPS) Right-of-Way Renewal. The BLM is releasing its Draft Environmental Impact Statement (DEIS) and the ADNR is releasing its Commissioner's Statement of Reasons and Proposed Written Determination (Proposed Determination) for public review beginning July 5, 2002. The public will have 45 days or until 5 p.m. (ADT) August 20, 2002 to review and comment on both.

The DEIS – a four volume, 1,700 page document – addresses the physical, environmental, economic and social impacts of renewing TAPS. DEIS Alternatives

The DEIS addressed three alternatives

- **Preferred Alternative:** Renew the Federal Agreement and Grant (Grant) of Right of Way for 30 years. This alternative discusses the impacts of the maximum renewal period and analyzes future operating conditions. Renewal is required under the current grant if the pipeline is operational and in compliance.
- Time-Dependent Alternative: Renew for less than 30 years. This alternative reflects public comments received during scoping in Fall 2001 and it analyzes impacts/issues that might be affected differently if TAPS were renewed for less than 30 years.
- **No-Action Alternative**: Do not renew the Grant of Right of Way. This alternative, required by the National Environmental Policy Act (NEPA), not only examines how termination activities will impact the physical and biological environment but also examines the impacts to Alaska's economy.

Joint Public Hearings

For public convenience, the BLM and Alaska Department of Natural Resources will offer joint public hearings for BLM's TAPS Renewal Draft EIS, the State Proposed Determination, and the ANILCA 810 Subsistence evaluation contained in the DEIS. Comments can be made at each of the following locations on the dates specified (these dates and locations will be announced again in mid-July):



Why the EIS was Prepared

On May 2, 2001, the six owners of TAPS filed to renew the Federal Grant and State Lease of right of way for TAPS for another 30 years. The TAPS right of way on federal lands is authorized by a Federal Grant that expires on January 22, 2004. For the pipeline to remain in place and in operation, a new federal right-of-way authorization must be issued. The TAPS Renewal EIS is needed to comply with the NEPA and provide full public disclosure of the affects of TAPS renewal.

State Lease Renewal

Likewise, the State of Alaska entered into a formal renewal process on its Right-of-Way Lease that expires May 2, 2004. The State Pipeline Coordinator (SPC) prepared a report to the Commissioner addressing the leaseholders' compliance with the right-of-way lease and applicable state laws and regulations. The Commissioner used the SPC report to evaluate lease renewal.
