It was determined that a quorum was present.

The proposed meeting agenda was reviewed. The new agenda items were briefed.

13-136. IT WAS MOVED by Mr. Wilbanks and seconded by Mr. Barter to adopt the revised agenda. MOTION CARRIED 6-0.

Minutes of the fourth meeting of the 2012-2013 Board held April 17. 2013 were received for approval.

13-137. IT WAS MOVED by Mr. Santora and seconded by Mr. Wilbanks that the minutes of the fourth meeting of the 2012-2013 Board held on April 17, 2013 be approved as presented. MOTION CARRIED 5-0 Mr. Christy abstained

Actions from previous board meetings were reviewed.

The Board was briefed on the status of letter regarding professional engineer certifications on subdivision plats. Executive Director informed the Board that the letter would be ready for their review at the July meeting.

HEARINGS

The Board was informed that a scheduled Formal Hearing had been postponed.

APPLICATIONS – Mr. Phillip E. Santora, Advisor

The Board previously authorized Executive Director to approve applications for licensure, intern certification, and examinations if the application is in order and all requirements have been met. All applications for licensure, intern certification and examinations issued since the April 17, 2013 Board Meeting were reviewed.

Applications of those applying for Professional Engineer licensure by comity, as provided by Section 34-11-4(1)(b) of the Licensure Law, were considered.

Applications of those applying for Professional Engineer licensure by examination, as provided by Section 34-11-4(1)a. and b. of the Licensure Law having previously passed the FE Examination in Alabama or in another jurisdiction, were considered.

Applications of those applying for Engineer Intern certification, as provided by Section 34-11-4(2) of the Licensure Law, were considered.

Applications of those applying for Land Surveyor licensure by examination, as provided by Section 34-11-4(3)a., b., and c. of the Licensure Law, were considered. Applications of those applying for Professional Land Surveyor licensure by examination having previously passed the Fundamentals of Land Surveying Examination and the Principles and Practice of Land Surveying Examination in Alabama or in another jurisdiction were considered and were approved for the Alabama Land Surveying Standards, History, and Law Examination.

- 13-141. IT WAS MOVED by Mr. Santora and seconded by Mr. Foust that the Board ratify the approval for examination those applicants approved since the April 17, 2013 meeting and listed as approved on **Attachment #3**. MOTION CARRIED 6-0.

Mr. Ben Albritton, the Board Attorney, at the request of the Executive Director, briefed Board Members regarding the Open Meetings Law and the requirements for open and closed sessions during meetings. Mr. Albritton provided Board Members with a copy of the Open Meetings Law and the Manual for Public Officials.

The Board made the decision to stay in Open Session to review and consider applications with issues.

- 13-142. IT WAS MOVED by Mr. Santora and seconded by Mr. Foust that the Board deny Everett Alan Horton's professional engineer license by comity application MOTION CARRIED 5-1 Mr. Barter voted no.
- 13-143. IT WAS MOVED by Mr. Santora and seconded by Mr. Wilbanks that the Board approve Mr. Russell Royds' professional engineer license by comity application.

 MOTION CARRIED 6-0
- 13-144. IT WAS MOVED by Mr. Wilbanks and seconded by Mr. Foust that the Board approve Mr. Blake Tuomy's professional engineer license by comity application. MOTION CARRIED 6-0

LAW ENFORCEMENT - Mr. W. Gerald Wilbanks, Advisor

The Board reviewed the status of the files pending with the Board, the Investigator, and/or the Investigative Committee. The Board was briefed on the 2012 - 2013 statistics.

The Board reviewed enforcement actions taken against Alabama licensees by other licensing jurisdictions.

13-145. IT WAS MOVED by Mr. Santora and seconded by Mr. Wilbanks that a Complaint investigation be initiated regarding MS1, and MS2. MOTION CARRIED 6-0.

The Board discussed methods to address actions taken against Alabama licensees by other licensing jurisdictions involving noncompliance with continuing professional competency requirements. The Board directed staff to perform a continuing professional competency audit of all licensees disciplined in other jurisdictions for matters related to continuing professional competency to insure they complied with the Board's continuing professional competency requirements.

- 13-146. IT WAS MOVED by Mr. Foust and seconded by Mr. Santora to rescind Board's last vote regarding MS1 and MS2. MOTION CARRIED 6-0.
- 13-147. IT WAS MOVED by Mr. Santora and seconded by Mr. Foust that cases listed as MS1, MS2, MS3, and KY2 be notified by letter that their 2013 Alabama license had been selected for audit of continuing professional competency requirements. MOTION CARRIED 6-0.
- 13-148. IT WAS MOVED by Mr. Wilbanks and seconded by Mr. Christy the cases listed as "CO1" and "OK1" be cautioned to insure they comply with the Board's law and rules when practicing in Alabama and a copy of the letter be placed in their licensing files. MOTION CARRIED 6-0.

The Board reviewed pending cases that the investigative committees have completed to accept, modify, or reject the suggested courses of action.

- 13-149. IT WAS MOVED by Mr. Wilbanks and seconded by Mr. Foust that there was probable cause that Jerry Hutcherson PE #18212 placed his signature and professional engineer seal upon design plans prepared for Construction & Building Logistics of Daphne, Alabama which may have contained violations of applicable building codes and the standards of practice for engineering in the State of Alabama. The accepted terms of the Consent Order are that Mr. Hutcherson and his firm pay \$1,250 fine to the Board, his professional engineer license will be subject to a 2 year stayed suspension period, he must complete a ten professional development hour engineering ethics course and the matter will become a public record. The Board accepted the Consent Order and issued the Final Order. MOTION CARRIED 5-0 with Mr. Santora recused. (Case 2011-42-B)
- 13-150. IT WAS MOVED by Mr. Santora and seconded by Mr. Barter that there was probable cause that Philip Fretwell, PLS # 8113 was employed by Mr. and Mrs. Austin to perform land surveying services that would divide one acre from a multiple acreage property. Mr. Fretwell performed the necessary field work as requested and received payment in the amount of \$500.00. Mr. Austin later requested that Mr. Fretwell return to the property to increase the size of the lot and Mr. Fretwell advised him the work would require an additional \$250.00. The two of them could never reach an agreement on the additional fee therefore Mr. Fretwell never returned to the property to provide land surveying services and never provided Mr. Austin with a survey. The accepted terms of the Consent Order are that Mr. Fretwell must provide the client's wife a completed survey within 14 days of the date of Final Order, and the matter will become a public record. The Board accepted the Consent Order and issued the Final Order. MOTION CARRIED 5-0 with Mr. Foust recused. (Case 2013-02-B)
- 13-151. IT WAS MOVED by Mr. Barter and seconded by Mr. Wilbanks to close Case 2013-15-B with a letter of caution. MOTION CARRIED 5-0 with Mr. Foust recused.

CERTIFICATES OF AUTHORIZATION – Mr. Marc S. Barter, Advisor

The Board previously authorized the Executive Director to issue certificates of authorization to applying firms if the application is in order and all requirements have been met. A list of 15 Certificates of Authorization issued to engineering firms (CA-4612-E through CA-4626-E) since the April 17, 2013 Board Meeting were reviewed.

13-152. IT WAS MOVED by Mr. Wilbanks and seconded by Mr. Santora that the Board ratify the approval of Engineering Certificates of Authorization CA-4612-E through CA-4626-E issued since the April 17, 2013 Board Meeting and that the list of those issued be included in the minutes on **Attachment #4.** MOTION CARRIED 6-0.

Certificates of Authorization applications which had anomalies were discussed by the Board

13-153. IT WAS MOVED by Mr. Foust and seconded by Mr. Wilbanks that the Board approve the Certificate of Authorization application of Gann Engineering. MOTION CARRIED 6-0.

The Board was asked by Fontaine Engineered Products, Inc that they be allowed to register with the Secretary of State's office without meeting the certificate of authorization requirements of the Board. The Secretary of State's office will not issue them a certificate of authority (qualify them to do business) until the Board identifies that there is not an issue with the use of the protected term "Engineered" in the firm's name.

The information provided by the firm identifies their engineering activities are restricted to the design and modification of their unique/patented products. The firm will not offer engineering services to the public but it does have the term "Engineered" in its name.

13-154. IT WAS MOVED by Mr. Foust and seconded by Mr. Wilbanks that the name Fontaine Engineered Products, Inc fits within the current law and the firm may retain the title "Engineered" in its name and is not required to obtain a certificate of authorization. MOTION CARRIED 6-0.

LEGISLATIVE – Mr. W. Gerald Wilbanks, Advisor

The Board discussed the status of its pending legislation that was introduced in the 2013 General Session. (HB 355/SB 232). The passing of this legislation is urgent since the Board may not be able to offer the Fundamental Exams once they convert to computer based exams under its current law.

CONTINUING PROFESSIONAL COMPETENCY – Mr. Earl R. Foust, Advisor

The Board was updated on the on-going audit of the 2013 renewals.

FINANCE – Dr. Daniel S. Turner, Advisor

End of month financial reports for March and April, 2013 were reviewed.

The Board was briefed regarding the current 5-year lease of the Board office space terminating on July 31, 2013. It was suggested that due to a reduction of staff, that floor space be decreased.

13-155. IT WAS MOVED by Mr. Foust and seconded by Mr. Christy that the Board should continue renting space in the RSA Union Building and enter into a lease with RSA for Suite 382 and 387 for a five year period. MOTION CARRIED 6-0.

The Board discussed the current fee schedule and was briefed regarding items that will have an impact on revenue/expenses for the next fiscal year. The Board discussed the process necessary to make changes in current fees and made the decision to maintain fees as currently set.

The Board recessed for lunch at 11:50 PM and reconvened at 1:00 P.M.

LAND SURVEYING – Mr. A. Frazier Christy, Advisor

- 13-157. IT WAS MOVED by Dr. Turner and seconded by Mr. Santora to accept NCEES' recommended cutoff score for the FS examination and to approve the results of the FS Exam given April 2013. MOTION CARRIED 6-0.

CHAIR'S REPORT

The current List of Board Committees and Advisors was reviewed. With the changing of board members the list of committee advisors required updating.

Mr. Arnold was replaced by new Board Member Frazier Christy as Advisor for the Land Surveying Education/Examination Committee.

The Board was briefed and a discussion was held regarding an appointment of Emeritus Member to NCEES.

13-158. IT WAS MOVED by Mr. Foust and seconded by Mr. Wilbanks that the Board recommend Mr. Arnold to NCEES for emeritus status subject to Mr. Arnold's agreement. MOTION CARRIED 6-0.

The Board, at the April 2013 Board meeting approved a policy that authorized the Board Chair and the Executive Director to approve travel to the various meeting/conferences. The Board was briefed on these upcoming conferences and travel dates.
