To: CalHFA Approved Lenders

Update to CalHFA's Wire Account Policy and Elimination of the MSV-II Document

In an effort to streamline the purchase of subordinate loans, CalHFA will require all lenders to complete an updated and simplified wire instructions form.

- Effective December 1, 2016 Lenders will be limited to two active wire accounts at one time.
- By November 14, 2016, all Lenders must submit the new CalHFA wire instruction form to <u>purchasing@calhfa.ca.gov</u> that indicates which account(s) will be active, with a maximum of two.
- Starting April 1, 2017, Lenders may substitute their active wire account(s) quarterly by submitting an updated wire instruction form to purchasing@calhfa.ca.gov.
 - o Requests must be received 10 business days prior to the close of each quarter.
- Loan closing packages will not be accepted after December 1, 2016 from any lender who has not submitted the new wire instructions form.
 - For Lenders that have not submitted their new wire instructions form, the Rate Lock timeframes on loans will continue to run and loans will be subject to all applicable extension fees.

Effective December 1, 2016:

- The Mortgage Submission Voucher Part II (MSV-II) will no longer be required for new submissions.
- Lenders will confirm their wire instructions and provide loan closing package and contact information via MAS.
