## FOR A LOVED ONE

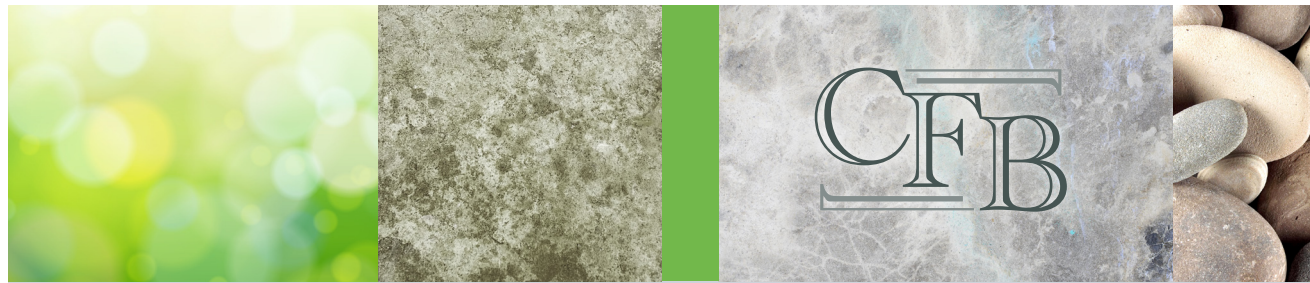
Planning in advance for the death of a loved one relieves you of that burden at the time of death. Take time now to find out what your loved ones want.

2. Visit several locations and ask about prices of products and services, then verify the license status of the business you select by visiting the Bureau's Web site at [www.cfb.ca.gov](http://www.cfb.ca.gov), "License Verification."
3. Understand the terms of any contract before you sign and know what products or services, if any, are not included, and consider your payment options.
