## Presidential Message

Dear colleagues and clinic owners:

I would like to thank everyone who assisted in getting HB 337 passed. This is the third year similar legislation was introduced but the bill did not complete the process the previous two years. Without the efforts of everyone involved we would not have been able to obtain passage of this much needed legislation. The bill was signed by the Governor June 10, 2013 and is now Act 2013-414.

The law made changes to license and clinic owner requirements. The Board proposed amendments to the rules that are effected by this legislation at the June meeting. Please watch the Newsletter for these rule changes to ensure your compliance.

I want to remind everyone that the online 2013-14 Renewal application

will open August 15, 2013. Please submit your required continuing education hours and the business license that expires September 30, 2013 to the Board office before you attempt the online application. The online application will give you a warning if you are missing hours or the business license. Having your documents in prior to starting the online renewal makes the renewal process go much more smoothly. If you are unsure what you need please contact the Board staff.

Just a reminder the Board staff strives to enter hours and update your information daily, but that is not always possible during the renewal period.

# Alabama Law Hours Required for All Licensees

Per an amendment to RULE <u>190-X-2-.11 Renewal of License</u> effective March 6, 2013 all licensees except those with a retired -R status are required to obtain 2 hours of Alabama Law as part of the 18 continuing education hours required for renewal. This includes active and inactive licensees, in or out of Alabama.
First year licensees must obtain 4 hours.



## **DOT Regulations for Physicals**

New Federal Motor Carrier Safety Administration (FMCSA) regulations will require medical examiners across the state who perform DOT physicals to be trained and certified in FMCSA physical qualification standards. Beginning May 21, 2014, a DOT Medical Certificate must be performed by a medical examiner who is on the National Registry to be accepted.
