# Oswego County Town Justice Reneges on Pledge to Resign, Making the Charges Against Him Public

The New York State Commission on Judicial Conduct has made public a stipulation that includes formal charges against Michael R. Clark, a Justice of the Hastings Town Court, Oswego County.

Judge Clark had agreed on February 24, 2015, in writing, to "vacate his judicial office on May 31, 2015" and never to seek or accept judicial office at any time in the future. Now he has rescinded his resignation and declared he is running for reelection this year. Therefore, his February stipulation becomes public, the proceedings against him are revived and the matter will proceed to a hearing before a referee.

This is the third time in the Commission's history that a judge has abrogated the terms of a stipulation. Hudson Falls Village Justice Michael M. Feeder (Washington County), was censured in 2009 and removed from office in 2012,

and Macomb Town Court Justice Lafayette D. Young (St. Lawrence County) was removed from office in 2011.<sup>1</sup>

Judge Clark was served with a Formal Written Complaint dated July 2, 2014, containing six charges, which alleged, *inter alia*, that he:

- Engaged in prohibited *ex parte* conversations with defendants and dismissed and/or reduced charges against them, without notice or consent of the prosecution;
- Failed to afford a defendant an opportunity to be heard on bail and did not make a bail determination on the basis of the required factors and criteria;
- During an arraignment spoke to a defendant in a rude, discourteous and retaliatory manner and acted without basis in law in issuing an order of protection;
- Imposed conditions upon a defendant's recognizance release that were without basis in law and unrelated to the purpose of bail;
- Spoke to a defendant in a discourteous and demeaning manner about his physical appearance and while imposing sentence, imposed a condition pertaining to the defendant's physical appearance; and,
- Failed to protect an unrepresented minor's rights by (1) failing to advise the defendant that he had the right to an attorney, (2) asking the defendant potentially incriminatory questions, notwithstanding that the defendant had not entered a guilty plea, (3) coerced the defendant to return to his parents' home and directed him to bring his report card to court as a condition to negotiate a plea agreement with the District Attorney and (4) threatened to impose a jail sentence if the defendant did not do as the judge directed.

Judge Clark filed an Answer dated August 5, 2014.

Judge Clark, who is not an attorney, has served as a Justice of the Hastings Town Court since 2000, and his current term expires on December 31, 2015.
