**PASSENGER-COMMERCIAL REVENUE ANALYSIS**

NOTE 1 IN THE YEAR 2001 THE NEW YORK STATE BRIDGE AUTHORITY BEGAN PARTICIPATION IN THE **EZPASS** PROGRAM WHICH RESULTED IN ADDITIONAL REVENUE KNOWN AS **UNUSED COMMUTER TRIP FEES**. NYSBA ALSO INSTITUTED THE COLLECTION OF TRUCK **OVER-WEIGHT FEES**.  
 NOTE 2 THE **UNUSED COMMUTER TRIP FEES** ARE INCLUDED IN THE PASSENGER VEHICLE REVENUE, LESS ANY ADJUSTMENTS DUE TO CUSTOMER DISPUTED TOLLS OR RECONCILIATION OF RECEIVABLES BY JOURNAL ENTRIES.  
 NOTE 3 THE **OVER-WEIGHT FEES** ARE INCLUDED IN THE COMMERCIAL REVENUE.
