1.Welcome and Introductions,5 Minutes

Vice Chairman JT Martin welcomed everyone to the meeting and asked each person present to introduce themselves.

3. Approve Minutes from December 2010 Meeting , ACTION ITEM: Approve Minutes

4. Presentation on the Genuine Progress Indicators Report 30 Minutes Dr. Erica Gaddis and Dr. Gunseli Burek

Mr. Wayne Martinson, Dr. Erica Gaddis and Dr. Gunseli Burrick presented the Genuine Progress indicators report to the Commission. They Represent the Utah Population and Environment Coalition. This organization also did the Carbon Footprint Study for Utah several years ago.

According to UPEC, Genuine Progress Indicators provide alternative measures that offer more holistic view of our quality of life. By placing a dollar value on many factors that contribute to our well being (economic, societal, and environmental), the GPI provides a useful tool to look at the trade-offs policy makers face when making decisions about using resources and planning for the future. 5. McAllister Program Funding Report Outstanding Grants—Status Report Current Funding Situation

John Bennett, 20 Minutes

John Bennett discussed the statues of outstanding grants. He indicated that all grants were proceeding, but that some may need extensions in the future.

John Bennett also discussed the status of commission funding with the Commission. He indicated that the legislature was proposing to zero out the line item for the LeRay McAllister Fund in the next fiscal year. This means that the fund will have only what carry over funds might be available this year, approximately \$600,000. Commissioners were given information about the membership of the subcommittee overseeing our budget, and encouraged to make contact with those members to encourage them to provide some funding.
