# Plugged In: EVs & Changes to Rule 2202

The South Coast Air Quality Management District (SCAQMD) may soon allow companies Rule 2202 compliance credits when they install and operate electric vehicle charging stations at the worksite.

Currently under Rule 2202, employers are allowed to count a trip made by a solo driver in an electric vehicle as a "zero trip" for vehicle ridership tracking purposes. These changes would expand the rule's support of electric vehicles by also giving credits to employers for providing charging for those vehicles once they arrive at the office.

The AQMD is creating an emission reduction quantification protocol for electric vehicle charging stations credits. The draft is available at agmd.gov, and the final is expected to be adopted early this year.

# Metro Is Rolling Out Better, Easier **TAP Vending Machines**

Metro this month is unveiling the first phase of its new TAP vending

machine screens, starting at Union Station. Based on feedback from commuters, Metro redesigned screens to make purchases easier for first time riders, as well as faster for all users.

New features include:

- Color display screens with bigger fonts;
- A green task bar added to the top of each screen to let customers know where they are in the purchasing process and to ensure transactions are properly completed;
- Customized help screens;
- User-friendly graphics and animation.

The next phase of improvements will focus on new functionality, adding eight additional languages and group

# The Newest to the TAP Network: PV, Monterey Park and Santa Monica

The TAP network continues to grow with its newest additions, the Palos Verdes Peninsula Transit Authority, the Monterey Park Spirit Bus, and in March, Santa Monica's Big Blue Bus.

"Instead of handling cash and tokens, now riders can tap their

> valid TAP card on the validator when boarding. TAP officials say they will continue to add local bus systems in Los Angeles County to TAP in order to provide a seamless, regional transportation system," according to Steve Hymon with Metro's The Source blog.

Current TAP partners include: Access Services, Antelope Valley Transit Authority, Culver City, Foothill, Gardena, Long Beach, Los Angeles Department of Transportation, Montebello, Norwalk, PV Transit, Pasadena ARTS, Santa Clarita and Torrance (line 4 only). **Carpool Lane Connectors** Open Between I-405, SR-22 and I-605

Drivers can now travel in the carpool lanes from the Garden Grove Freeway (SR-22) to the San Diego Freeway (I-405) to the San Gabriel Freeway (I-605), and the reverse, without ever having to exit the carpool lanes, thanks to the opening of carpool lane connectors last month.

The \$297 million project allows for seamless transitions between the three freeways eliminating the merging and weaving of cars that previously occurred, a major cause More >

of congestion, according to Orange County Transportation Authority (OCTA). In addition, the project adds a second carpool lane on I-405 in both directions between SR-22 and I-605.

"The opening of the West County Connectors means the long road of construction in the area is winding down and we want to thank all of the commuters and the surrounding communities who have patiently endured the work throughout the past four years," says OCTA Chairman Shawn Nelson.

# Guess Where You'll Find the Best Streets in the State?

The condition of Orange County's streets and roads is ranked the best in the state, according to a report released this week by SaveCaliforniaStreets.org

The report, compiled with the help of the League of California Cities and regional transportation agencies, ranks streets on a scale of 0 (worst) to 100 (best). Orange County's streets average a 77,

while the state average is 66.



OCTA credits part of the reason their streets are so good to Measure M, the county's half-cent sales tax



for transportation projects. Last year the county administered nearly \$70 million

for local improvements and other transportation projects.

Los Angeles rated a 66; Ventura County 70 and San Bernardino, 71. The county with the worst streets: Amador County in central California, which rated half the national average at 33.


# Saluting Those Who Served

# Study Gives Glimpse of a Traffic-Clogged 101

Daily trips and miles traveled in Ventura County are expected to increase significantly in the next 20 years, potentially putting a strain on Highway 101 where much of the increase is expected to occur, according to a recent study by VCTC.

The study, which points out that nearly 80% of all work trips originating

in Ventura County stay there,



predicts bumper-to-bumper traffic for several hours in the morning and even longer in the afternoon unless improvements are made.

It recommends carpool lanes and increased intercity bus service, as well as cities taking an active role by making transportation improvements locally.

Changes are already underway: the county plans to open its first carpool lane on the 101 later this year.
