## Responsible & Problem Gambling Training

Recreational Gaming Association and Evergreen Council on Problem Gambling train thousands of RGA Members in Responsible & Problem Gambling Practices.

The Recreational Gaming Association (RGA) and the Evergreen Council on Problem Gambling (ECPG) are continuing their commitment to responsible gaming practices they began in 2013 when they trained approximately 1,200 industry employees.

In October 2015, more than 150 employees of Washington Gold Casino properties in Pasco and Kennewick were trained in responsible and problem gambling practices by Evergreen Council on Problem Gambling staff and guest trainer Jennifer Shatley.

Jennifer Shatley, consultant and formerly the VP of Responsible Gaming Policies and Compliance for Caesars Entertainment Corporation, shared her industry background and expertise from the perspective of a peer in the gaming industry.

In early December 2015, 600 additional employees will be trained in the Tukwila area, bringing the total to nearly 2,000 employees since 2013. This is thanks to the commitment of RGA President Victor Mena, Vice President David Fretz, and all of the members of RGA, who are dedicated to promoting healthy, sustainable gaming practices to ensure the continued success and viability of the industry. The training is funded by an industry tax to support problem gambling awareness. Both the RGA and ECPG believe good corporate social responsibility is critical to reach people with gambling problems.

In addition to reviewing responsible gaming practices and company policies, the training covers problem gambling, from signs and symptoms, myths and facts, and crime risks associated with gambling problems. Supervisors receive additional, in-depth training, including how to respectfully and discretely talk to guests about potential gambling-related issues; as well as covering the property-specific benefits offered to employees, who are at a higher risk of problem gambling than the general population.

The Washington State Gambling Commission encourages responsible gambling training and welcomes the industry's efforts to train and raise awareness of employees that directly interact with the public.

The Washington State Gambling Commission is a limited jurisdiction law enforcement agency and the only statewide agency devoted to gambling licensing, regulation and enforcement. Five citizens are appointed by the Governor, with the consent of the Senate, to act as part-time Commissioners for a single six-year term. The Commission holds public meetings once a month to discuss administrative issues and rule changes, approve new gambling licenses, and take action regarding the revocation or suspension of gambling licenses.
