
1. External Customers



1.2 MID Detail Page

Mailers will have the capability to choose, both, Full/Basic Service and Confirmation Services when selecting the program options during MID Creation. However, if eVS is selected no other options can be chosen.



1.3 Data Distribution Profile

Mailers will have the capability to update MIDs that are delegated by other CRIDs via the Data Distribution Profile. Previously, mailers could only update the profile based on MIDs owned by the same CRID.
