





#### Elimination Parcel Return Service Return Network Distribution Center (RNDC)

#### **Rationale:**

- Parcel Return Service (PRS) prices are based on weight, whether items are machinable or nonmachinable, and have the choice of three pickup locations: Returns Destination Unit (RDU), Returns Sectional Center Facility (RSCF) and Returns Network Distribution Center (RDNC). Permit holders or their agents must pick up parcels on a regular schedule.
- This service was eliminated to simplify the offering and due to decline in volume.







- After six months the identified STCs will be fully retired and potentially repurposed




