**DISCUSSION AND ACTION BY THE BOARD ON THE APPLICATION FOR LICENSE TO CONDUCT A HORSE RACING MEETING OF THE BAY MEADOWS OPERATING COMPANY, LLC (T) AT BAY MEADOWS, COMMENCING APRIL 3 THROUGH JUNE 16, 2002, INCLUSIVE.**

---

Jacqueline Wagner, CHRB staff, said the Bay Meadows Operating Company (BMOC) proposed to run 55 days, one day less than in 2001, for a total of 473 races. BMOC requested the option to increase the number of races if there were sufficient horses. The first post time would be 12:45 p.m. Ms. Wagner stated the horsemen's agreement had been received, and staff recommended approval of the application conditioned upon the receipt of missing items noted in the analysis. Commissioner Harris asked if a California patron could have an advance deposit wagering (ADW) account in Pennsylvania and place wagers on BMOC races. Jack Liebau of BMOC said a California resident would only be able to use an ADW entity that was licensed in California. Commissioner Harris said his concern was that if the signal was sold to an entity such as a New York OTB, or an entity in Kentucky, the return to California in purses and track commissions would be less than if wagers had been placed through XpressBet. Mr. Liebau said if patrons placed wagers with XpressBet purses and track commissions would receive more money. Vice-Chairman Licht asked what was being done about off-shore wagering and entities that offered rebates. Mr. Liebau said an effort was being

made to increase the commissions paid by entities that were perceived to be paying rebates. He stated he did not think the tracks were in a position to threaten to pull the signal as the entities would go someplace else, however, he thought the industry would continue to try to control its mutual pools. Mr. Liebau commented that licensing entities for ADW was a step in the right direction. Vice-Chairman Licht said he believed rebating was a major issue. He stated he spoke with Hollywood Park regarding an effort to monitor the issue and withhold the signal from rebate shops. Chairman Landsburg said the Board took steps to notify media outlets that accepting advertising for illegal activities could cause problems for their licenses and continuing operation. He said the Board was in the process of taking what steps it could, and he was sure the racetracks would support it. Mr. Liebau said the industry supported the Board's efforts. The industry did not condone the practice of offering rebates, but it must be recognized that in some jurisdictions the practice was legal and was being carried out by some of the major racetracks in the United States. Chairman Landsburg commented it was regrettable a national consensus could not be reached regarding rebates. Commissioner Harris said there was also a problem with ads in the Daily Racing Form (DRF) that offered accounts at Internet websites, and other wagering facilities. He stated it would be prudent for racetracks to look at who was advertising and the viability of allowing such ads to be distributed at their facilities. He stated such ads were clearly a violation of California law, and he hoped the tracks would take a proactive approach with advertisers. Mr. Liebau said the racetracks would continue their discussions with the DRF regarding such ads. He commented the tracks had been talking to the DRF since 1992-93, but there were issues of free speech and interstate commerce. Commissioner Harris said he understood about free speech, but he did not think the right included advertising something that was clearly illegal in California. Mr. Liebau said the

DRF was distributed in several jurisdictions and that was where the problem of interstate commerce entered. Commissioner Harris said the tracks could make such ads an issue with the DRF by denying them the opportunity to distribute the paper on their facilities. Mr. Liebau stated he did not know how such an approach would work as the handle might be affected without the availability of past performances. Chairman Landsburg asked if BMOC's horsemen's agreement was the same as Santa Anita's horsemen's agreement. Mr. Liebau said the agreement was the same as it related to XpressBet. Commissioner Bianco asked how many jobs related to XpressBet's marketing and administration had been created at BMOC. Mr. Liebau said there were two kiosks at Golden Gate Fields and one at BMOC. Each kiosk was staffed with five or six persons. Commissioner Moretti **motioned** to approve the application for license to conduct a horse racing meeting of BMOC. Commissioner Bianco **seconded** the motion, which was **unanimously carried**.

**DISCUSSION AND ACTION BY THE BOARD ON THE APPLICATION FOR LICENSE TO CONDUCT A HORSE RACING MEETING OF THE CHURCHILL DOWNS CALIFORNIA COMPANY (T) AT HOLLYWOOD PARK, COMMENCING APRIL 24 THROUGH JULY 21, 2002, INCLUSIVE.**

Jacqueline Wagner, CHRB staff, said the Churchill Downs California Company (CDCC) proposed to run 65 days, one day less than in 2001, for a total of 559 races. The first post time would be 1:20 p.m. daily and 7:05 p.m. Fridays. The horsemen's agreement had been received, however, the fire clearance was missing and CDCC's workers' compensation insurance would require a renewal notice after March 2002. Ms. Wagner said staff recommended approval of the application conditioned upon the receipt of missing items noted in the analysis. Vice-Chairman Licht asked why CDCC would not open on a Friday. Rick Baedeker of CDCC said the opening day was a result of the Dates Committee negotiations. Vice-Chairman Licht asked

for Mr. Baedeker's thoughts on the rebate discussion. Mr. Baedeker said CDCC's simulcast agreements were specific regarding rebates. Simulcast entities could not accept less than the face amount of wagers from patrons and could not refund or rebate any consideration based on the face amount of any wagers. He added policing the agreements was difficult, but CDCC had staff dedicated to the task. There had been occasions when CDCC threatened to withhold its signal and had withheld it from a recipient in Idaho two years ago. Mr. Baedeker said a new problem had appeared when CDCC became aware that one of its partners was conducting account wagering without a license. He stated CDCC had to notify the entity to stop or the signal would be withheld. Commissioner Harris said he noted the post times were not synchronized with the Northern meeting. Mr. Baedeker said the tracks discussed the issue and probably would have to ask the Board for adjustments in their post times, and he believed the issue would be resolved. Commissioner Harris said he was concerned the CDCC post times were arranged to coincide with Churchill Down (CD) post times. It would cost California money as the CD signal was paid for while the Northern California signal was free. Mr. Baedeker said with patrons in mind, he would have liked a later post time. The 1:20 p.m. post time was set in the context of the major signals nation wide, and was not entirely self serving on the part of CD. Mr. Baedeker said he agreed with Commissioner Harris regarding cooperation in California. Commissioner Harris stated there had to be cooperation to synchronize post times in California. Chairman Landsburg said the goal of the Board was to see that California horse racing was properly served. If CDCC's post time did not benefit California, the Board would ask that it be changed. He asked if CDCC would change its time to accommodate Northern California. Executive Director Roy Wood said he believed CDCC needed to clarify what their post time would be. Once the Board approved the application, the



association would need to appear before the Board again to amend the post time – unless the change was under the ten-minute administrative leeway. Jack Liebau of Bay Meadow Operating Company (BMO) said the 12:45 post time in Northern California has historically provided a 15 minute break between California races North and South. Horse racing law required that races be staggered by a minimum of ten minutes. Mr. Liebau stated BMO would work with CDCC to solve the problem. Commissioner Harris commented that he believed the situation had become more complicated with national simulcasting and common ownership of racetracks. Mr. Baedeker said the post time decisions were made with the patron in mind. He stated BMO had always been accommodating and CDCC would work with the same attitude. Commissioner Bianco **motioned** to approve the application for license to conduct a horse racing meeting of the CDCC at Hollywood Park subject to resolution of the post time issue. Commissioner Granzella **seconded** the motion, which was **unanimously carried**.

**DISCUSSION AND ACTION BY THE BOARD ON THE APPLICATION FOR LICENSE TO CONDUCT ADVANCE DEPOSIT WAGERING BY YOUTBET.COM, INC.**

---

Jacqueline Wagner, CHRB staff, said YouBet.com, Inc. (YouBet) had filed an application to act as an out-of-state advance deposit wagering hub. The term of the approval was two years and would commence upon approval of the application. YouBet proposed to operate seven days a week between the hours of 7:00 a.m. and 11:00 p.m. Pacific Standard Time. YouBet had entered into an agreement with TVG to utilize TVG's patents and the rights to accept pari-mutuel wagers on horse races from all of TVG's exclusive partner racetracks. YouBet did not have a direct contractual agreement with any racing association. It did, however, have sublicenses with Los Alamitos, Del Mar, Hollywood Park and Oak Tree at Santa Anita, as well

as a horsemen's agreement with the horsemen at Los Alamitos and an agreement with TOC. YouBet proposed to provide ADW services on racing at Los Alamitos Racing Association, Churchill Downs California Company at Hollywood Park, Del Mar Thoroughbred Club, and Oak Tree Racing Association at Santa Anita. Vice-Chairman Licht asked if YouBet had provide a financial bond. Ms. Wagner said on February 19, 2002, staff was informed by telephone that International Fidelity Insurance Company would issue a bond, but no bond had been received. Ms. Wagner commented that a \$500,000 cashiers' check had been received from YouBet. Vice-Chairman Licht said he visited YouBet and was impressed with management and its technological capabilities. He stated he was confident California labor would be a factor in YouBet and would grow with the company. Vice-Chairman Licht said he received a letter from Ron Liccardo of the Pari-Mutuel Employees Guild Local 280 (local 280) endorsing YouBet's application. Vice-Chairman Licht said he was confident YouBet met the ADW requirements through its sublicense with TVG and the consent of racetracks and horsemen. Deputy attorney general Thomas Blake said there was nothing in the law that prohibited a hub or an interstate wagering system from using other agents or assigning the contracts. He stated he believed YouBet's arrangements were valid, subject to meeting the statutory requirements and receiving Board approval. Mr. Blake said the law generally allowed contracts to be assigned unless there was a provision in a law or particular contract preventing it. Commissioner Moretti said the Board approved TVG for one year only. How did YouBet's request for a two year approval fit? Mr. Blake stated the one-year limitation on TVG would effectively end the arrangement at the end of the year. Ron Luniewski of YouBet gave a brief overview of YouBet's operations and a product demonstration. Commissioner Harris asked if YouBet was exclusively an Internet wagering system. Mr. Luniewski said YouBet offered

Internet-based wagering, a voice recognition wagering system, and would offer live-operator wagering services in conjunction with the Pari-Mutuel Employees Union. Drew Couto of TOC said his organization had an agreement with YouBet for non-TVG racetrack signals, but had not reached an agreement regarding any of the California TVG signals for out-of-state. Mr. Couto commented that TOC supported the application. Richard Castro of local 280 said his organization supported the application. Tom Tucker of the California Council on Problem Gambling spoke about his organization. Commissioner Sperry **motioned** to approve the application for license to conduct ADW by YouBet. Commissioner Harris **seconded** the motion, which was **carried** with Chairman Landsburg **recusing**.

**DISCUSSION AND ACTION BY THE BOARD ON THE APPLICATION FOR LICENSE TO CONDUCT ADVANCE DEPOSIT WAGERING BY WASHINGTON TROTTING ASSOCIATION, INC. AND LAUREL RACING, INC., JOINTLY D.B.A. CALL-A-BET.**

Chairman Landsburg said the item had been removed from the agenda.

**REPORT ON THE IMPLEMENTATION OF ADVANCE DEPOSIT WAGERING.**

John Reagan, CHRB staff, said the report reflected advance deposit wagering (ADW) through February 18, 2002, the last racing date in California prior to the Board meeting. The ADW handle totaled 5.1 million dollars as of February 18, 2002. Mr. Reagan stated ADW was in a growth mode and staff would continue to monitor the handle. Commissioner Moretti asked if the total handle had increased. Mr. Reagan stated the California on-track and off-track handle as compared before and after ADW were about even. The on-track handle was slightly lower and the off-track handle was slightly higher. The ADW handle was less than 2 percent of the

total California handle, so it did not have a lot of impact. Commissioner Sperry asked if there had been a change in the on-track attendance numbers. Mr. Reagan said it appeared as if on-track attendance was unaffected. Commissioner Harris said it would be helpful to see the distribution from ADW. Mr. Reagan stated the CHRIMS database was working towards verifying and generating the information, and in a week to ten days access to distribution numbers should be available on a daily basis. Chairman Landsburg asked if there had been any complaints regarding ADW. Mr. Reagan said in the first two weeks of ADW he had received numerous complaints regarding the level of customer service. Most of the complaints were regarding XpressBet's system. Staff spoke to XpressBet regarding the complaints, and received assurances that XpressBet was working to resolve its problems. Ed Hannah of XpressBet said his organization was in its 27<sup>th</sup> day of operation as a California ADW hub. Mr. Hannah gave a slide presentation regarding XpressBet's experiences with ADW in California since January 24, 2002, and XpressBet's plans for expansion of its ADW operations. Commissioner Granzella asked if the additional call center customer service representatives mentioned by Mr. Hannah in his presentation would be located in California. Mr. Hannah said the call center was located in Pennsylvania. Commissioner Sperry asked if XpressBet had made progress with its talks with labor. Jack Liebau of Magna Entertainment Corporation (MEC) said his organization presented a written proposal to Pari-Mutuel Employees Guild Local 280 (local 280) and had not received a response. He stated he was optimistic a mutually satisfactory agreement could be reached between XpressBet and the union. Richard Castro of local 280 said there had been collective bargaining sessions; however, at the last session the offer was rejected. He stated there would be an additional meeting where he would present local 280's position on several issues. Commissioner Sperry suggested that Mr. Castro might

give the Board an indication of what local 280 wanted from the negotiations. Mr. Castro said he felt the process worked better if the terms were not made public, but with the offer he had received from MEC he would like to see higher wages, a discussion of more benefits, how the employees would be taken into the union, and how the new employees would be trained. Mr. Liebau said he believed the negotiations would relate solely to the employees working at the kiosk at Santa Anita, Bay Meadows and Golden Gate Park. He stated he had informed the Board in writing he would be willing to enter into binding arbitration. Mr. Liebau said MEC presented a written proposal within the week it was allotted, but the proposal was rejected. He added he would contact Mr. Liccardo of local 280 to arrange a new meeting. Chairman Landsburg said he hoped the parties could come to an agreement as an important aspect of the ADW enabling legislation was labor's inclusion. Chairman Landsburg commented that in Mr. Hannah's presentation he mentioned there would be three channels available. He asked if the channels were racetrack television network (RTN) channels, and when would they be available. Mr. Hannah said three channels would be produced. Two channels would feature live racing, one would be an all odds channel, and all three channels would be available on RTN. Chairman Landsburg asked if it was correct that XpressBet was currently available only on the Internet, and would remain so for approximately the next six months. Mr. Hannah said XpressBet would have an Internet and an RTN presence. XpressBet would be broadly available through video-streaming on the Internet. Chairman Landsburg commented that XpressBet had live racing at least four or five times during its racing season at Santa Anita. He asked if XpressBet had any sense of how that might contribute to ADW. Andrew Gaughan of XpressBet said the numbers had not been tracked, but based on prior experience, live racing would contribute to increased wagering. Commissioner Harris said he found the XpressBet

phone-based system complicated. It seemed cumbersome for a patron watching television to punch all the correct numbers into a telephone. Mr. Hannah said XpressBet was hoping the speech-recognition telephone system would make telephone wagering easier for patrons. Chairman Landsburg asked if XpressBet would consider moving its Pennsylvania customer service center to California to be closer to its audience. Mr. Hannah said XpressBet was a California hub. All of its wagers were handled by the California tote system. XpressBet might consider moving its call center, but it was difficult to commit to such an action. Mr. Hannah said he thought XpressBet had shown its commitment to California through the improvements MEC had made at its racetracks. XpressBet was committed to benefiting California, however, the Pittsburgh call center had been set up prior to the launch of California ADW and it was easier to use experienced staff. Chairman Landsburg said he appreciated the problems connected with operating a business. He stated, however, that the Board's role was to concern itself with California. If XpressBet could not begin the process of accumulating more activity within California, it would become an out-bound system. Chairman Landsburg said he would like to see XpressBet take the idea of operating from California and using California labor more seriously. Chairman Landsburg stated XpressBet was offering its customers what amounted to a rebate through its rewards network, which was illegal in California. Mr. Hannah said XpressBet was prepared to abide by the Board's determination regarding rebates. He stated the purpose of the rewards network was to encourage greater television distribution, not to encourage greater wagering. If the Board determined XpressBet could not offer the rewards network to California residents, it would cease immediately. Chairman Landsburg said the issue would have to be presented to the deputy attorney general for a ruling. Chairman Landsburg asked if XpressBet knew how many of its accounts consistently attend live race

meetings and how many were returning to racing. Mr. Hannah said one could assume that accounts opened at racetrack kiosks represented live racing patrons, but XpressBet had not yet conducted such research. Vice-Chairman Licht asked what was the status of XpressBets's formal agreement with TOC. Mr. Hannah said that within a week he hoped to be able to present a draft to Mr. Van de Kamp of TOC. Vice-Chairman Licht said he thought XpressBet's 5,000 accounts demonstrated the depth of the market for ADW. He commented that he had used XpressBet and found it to be user-friendly. Vice-Chairman Licht said he agreed with Chairman Landsburg that it was imperative there be more distribution of the product – especially on television. John Hindman of TVG read a report regarding TVG's first 28 days of ADW in California. Chairman Landsburg asked how many homes within Adelphia Digital Cable System's (Adelphia) reach had cable television. Mr. Hindman said between 25 to 38 percent of all households would initially receive TVG. Mike Martin, CHRB staff, said he had spoken with the regional manager of Adelphia and was told that the number of households receiving digital cable was 50,000. At the end of 2003, Adelphia predicted the number would be over one million households. Chairman Landsburg commented that 50,000 homes was a small percentage compared to the 30 million homes in California's market. Mr. Hindman said TVG agreed, however, it believed it had an excellent opportunity to market its product and grow with digital distribution. Chairman Landsburg asked Mr. Hindman to clarify the tax rate issue raised at the January 24, 2002, Regular Board Meeting. Mr. Hindman said there were several issues related to TVG operating as a hub out of California. He stated TVG had been operating out of Oregon for two and a half years prior to the advent of ADW in California. Mr. Hindman said the second issue was the license fee for ADW. He stated he had talked to Executive Director Roy Wood who informed him there was no ADW license fee in California.

Mr. Hindman said TVG was pleased and would act accordingly in evaluating its future plans. Chairman Landsburg asked what the one quarter percent tax in Oregon would mean for California's horsemen. Mr. Couto of TOC said he did not know the impact of Oregon's tax, but his organization had completed an analysis of the NTRA one-half percent assessment and depending on where a wager was made the net impact was between 5 percent and just under 15 percent. He stated that was exclusive of the one quarter percent Oregon tax – which he figured to have between a 2.5 and a 7.5 percent impact. Chairman Landsburg said at future Board meetings he would like TVG to discuss the possibility of creating a hub in California where practical. Mr. Hindman said he understood the Board's position on the issue.

**REPORT BY MAGNA ENTERTAINMENT CORPORATION ON THE PROGRESS OF THE VETERINARY HOSPITAL AT GOLDEN GATE FIELDS RACE TRACK.**

Frank De Marco of Magna Entertainment Corporation (MEC) stated there had been a contractual dispute with the original contractor of the veterinary hospital. A settlement was made and a new contract was issued in November 2001. Currently MEC was in the process of getting a site plan approved by the City of Albany. Once the site plan was approved, permits could be issued. Peter Tunney of Golden Gate Fields gave a short over-view of the history of the project. He concluded by stating the City of Albany had promised to expedite the permit process. Commissioner Harris commented he understood the equipment for the hospital would come from other parties. Mr. Tunney said MEC would complete the exterior and interior of the building, which would then be turned over to veterinarians who would administer the facility. Dr. Hunter, a practicing veterinarian, said he was concerned that the building have an overhead system for the x-ray unit and cabinet storage and countertops necessary for a functioning hospital. He stated that in the 1980s a nonprofit corporation was established to run the original



hospital at Bay Meadows. The corporation was still operating and was collecting surgical and x-ray fees and had approximately \$70,000 in a fund for equipment. Dr. Hunter said the fund would not cover all the costs and the corporation would have to explore other avenues of funding. Mr. Tunney said it was MRC's intention to build a building with the structural ability to transport horses in and out and cordon off certain areas to do x-rays. Regarding equipment and what was currently in storage, it would be up to the veterinarians to outfit the building. Commissioner Harris said he did not believe the Board wished to become involved in the negotiations regarding the hospital. He stated it would be up to MEC and the veterinarians to work together to finish the project.

**DISCUSSION AND ACTION BY THE BOARD ON THE REQUEST OF THE LOS ANGELES TURF CLUB TO DISTRIBUTE \$281,250 IN CHARITY PROCEEDS TO 35 BENEFICIARIES.**

---

John Reagan, CHRB staff, said the request by Los Angeles Turf Club (LATC) was in order. He stated 86 percent of the charitable funds would be distributed to horse racing related charities. Mr. Reagan said staff recommended approval of the request. Chairman Landsburg asked what the Ed Gregson Foundation did. Jack Liebau of LATC said the foundation organized and supported programs and activities for backstretch workers. Mr. Liebau said he would provide Chairman Landsburg with additional information regarding the foundation. Commissioner Sperry **motioned** to approve the application of LATC to distribute \$281,250 in charity proceeds to 35 beneficiaries. Commissioner Granzella **seconded** the motion, which was **unanimously carried**.

**REPORT FROM THE BENEVOLENT PROGRAMS COMMITTEE.**

---

Commissioner Granzella said the Benevolent Programs Committee met February 20, 2002. The committee heard proposals from the California Thoroughbred Horsemen's Foundation (CTHF) to amend Board Rule 2049, Designation and Approval of Horsemen's Welfare Fund, and Rule 2050, Beneficiaries, Welfare Programs and Activities. The proposed amendment to Rule 2049 would increase the number of directors of the CTHF from five to a minimum of five and a maximum of nine. Commissioner Granzella stated the committee voted to recommend the amendment be noticed for a 45-day public comment period. The proposal to amend Rule 2050 would define the term "dependent" to include the beneficiary's spouse and dependent children. In addition, it would allow backstretch workers who had left the industry to apply for benefits up to twelve months after leaving their employment. The amendment would also increase the minimum allowable administrative expense from 10 to 15 percent of the total expenditures for any fiscal year. Commissioner Granzella said the committee voted to recommend the amendment be noticed for a 45-day public comment period. Vice-Chairman Licht asked if a step-child would be considered a dependent. Commissioner Granzella said if the child was listed as a dependent on the beneficiary's tax return, it would be considered a dependent.

**GENERAL BUSINESS**

---

Charles Dougherty of the California Thoroughbred Trainers said that California horse racing would soon be facing a catastrophic situation with regards to workmen's compensation insurance. He stated there were three insurance carriers in California, however, as of March 1, 2002, there would only be one company – State Fund - offering such insurance. In addition,

State Fund had announced premiums would be increased by 25 percent. Mr. Dougherty said it was important that the Board take a proactive stance towards an industry-wide solution. Chairman Landsburg said he understood the problem, but a long term solution would have to come from the legislature. He recommended staff in cooperation with the Board work to contact insurance carriers and the insurance commission to see if some type of emergency relief could be offered. Chairman Landsburg formed an ad-hoc committee to address the issue. Jack Liebau said the industry was looking at some sort of state-sponsored workmen's compensation for the industry. He stated it would take legislation and could necessitate a slight increase in the takeout on exotic wagers. Mr. Liebau said that within the market place California was competitive regarding the takeout for exotic wagers. The insurance fund would be similar to the one in New York. Chairman Landsburg said that a comment had been made regarding the California Marketing Committee (CMC) making rebates. Vice-Chairman Licht said the Pari-Mutuel Committee could look at the matter. Mr. Liebau, chairman of the CMC, stated that in preparation for the Pari-Mutuel Committee's meeting it might be helpful if a review of the law regarding rebates be made as he believed the law might apply only to simulcasting facilities operating out-of-state. Laura Rosier of San Luis Rey Down Horsemen's Committee reviewed the results of races run by horses stabled at San Luis Rey Downs (SLRD) and provided statistics regarding the number of SLRD horses entered in races. Mr. Rosier said the SLRD horsemen were still waiting for SCOTWINC to present its findings and recommendations.





**BACKGROUND**

Business and Professions (B&P) Code Section 19440 provides that the California Horse Racing Board (Board/CHRB) shall have all powers necessary and proper to enable it to carry out fully and effectually the purposes of the Horse Racing Law. Assembly Bill (AB) 471, Chapter 198, Statutes of 2001, became effective January 1, 2002. AB 471 amended B&P Code Section 19481.5 to provide that the Board adopt emergency backstretch worker housing regulations within 120 days of the effective date of the statute.

**ANALYSIS**

Article 28 is not intended to supplant local regulations and ordinances. The proposed regulations provide a minimum standard for housing backstretch workers as well as health and safety measures. During the development of these regulations, staff met with association representatives, horsemen's organizations, and state and local officials.

Upon adoption by the Board, staff will submit Article 28 to the Office of Administrative Law (OAL) as emergency regulations. The OAL has ten days to review the regulations. The public may comment on the emergency regulations – in writing – directly to the OAL within five days of their submission. After reviewing the regulations the OAL will file them with the Secretary of State and they will become effective upon filing. In accordance with the provisions of AB 471, the Board has 18 months from the date Article 28 is filed with the Secretary of State to submit permanent regulations.

**RECOMMENDATION**

Staff recommends that the Board adopt the proposed emergency regulations as presented.

As used in this article:

(a) “Backstretch worker” means a person required to be licensed under Rule 1481(c) of this Division.

(b) “Backstretch worker housing”, “habitable room” means any structure or portion of a structure whose primary purpose is for sleeping or living and is located within the restricted area of the inclosure as defined in Rule 1420(v) of this Division.

(c) “Damaged” means property in a condition in which its worth or usefulness is impaired. Damage includes, but is not limited to backstretch worker housing whose components are split, buckled, sagging, rotting, broken or defective.

(d) “Substandard housing” means backstretch worker housing or a habitable room, or any portion thereof, which through lack of maintenance or repair there exists any of the following conditions to an extent that endangers the health, safety or welfare of the occupants.

(1) Lack of toilet or privy structure, bathtub or shower, or hot and cold running water.

(2) Plumbing fixtures and piping which have become unsanitary or damaged.

(3) Lack of exterior wall or roof covering adequate to protect the occupants from the elements.

- (4) Damaged exterior wall or roof coverings.
- (5) Damaged windows, exterior window coverings, or doors.
- (6) Lack of natural light and ventilation.
- (7) Damaged interior walls, ceilings or floors.
- (8) Lack of interior flooring adequate to protect occupants from the elements.
- (9) Dampness of habitable rooms.
- (10) Lack of garbage and rubbish removal as required under Rule 3010 of this article.
- (11) Infestation of insects, rodents or other vermin.
- (12) Lack of smoke detector in working order, or other fire alarm system as required under Rule 1927 this Division.
- (13) Lack of emergency evacuation plan as required under Rule 1928 of this Division.

The inspection shall be conducted by a designated representative of the Board and/or a local housing authority for the jurisdiction in which the track is located. This subsection shall expire December 31, 2003.

(a) Associations and racing fairs that provide backstretch worker housing shall, at least annually, submit to an inspection of such housing. The inspection shall be conducted by a designated representative of the Board with the California Department of Housing and Community Development or a local housing authority for the jurisdiction in which the track is located. This subsection shall become operative January 1, 2004.

(b) Racing Fairs with race meetings of 19 days or less shall comply with this section contingent upon the provisions of Business and Professions Code Section 19481.5(b)(3).

(c) No license to conduct a horse racing meeting shall be issued unless the applicant association's backstretch worker housing is found to be in compliance with the standards established in this article. This subsection shall become operative January 1, 2004.

(d) The Board shall be reimbursed by the association or racing fair for the costs incurred to conduct the backstretch worker housing inspection. This subsection shall become operative January 1, 2004.

3008. Habitable Rooms.

- (a) Habitable rooms used for sleeping shall have natural light by means of at least one exterior window that, if openable, has screening with a tight fitting frame. Natural ventilation shall be provided by openable exterior openings, or in lieu of exterior openings a mechanical ventilating system.
- (b) Habitable room exterior doors shall be tight fitting and outfitted with door sweeps.
- (c) Interior walls, ceilings and floors of habitable rooms may not be damaged or cause exposure to outside elements or exposed earth.
- (d) Habitable rooms shall be provided with electrical switches, outlets and at least one electric light. Electric components in a habitable room shall be installed to state or local building codes and maintained in a manner that does not endanger the health or safety of the occupants.
- (e) Habitable rooms used for sleeping shall be provided with a battery operated smoke detectors which shall be maintained in working order, or any other approved fire alarm system as provided under Rule 1927 of this Division. Fire regulations and an emergency evacuation plan shall be posted in backstretch worker housing areas as provided under Rule 1928 of this Division.

(f) The dimensions of a habitable room shall not be less than seven feet in any direction and shall provide not less than 50 square feet of space per person.

(c) No person shall violate the posted fire regulations.

STAFF REPORT ON ADW HANDLE**

**REGULAR BOARD MEETING  
APRIL 25, 2002**

**Background:**

The unaudited Advance Deposit Wagering (ADW) handle from January 25, 2002 through April 14, 2002 totals \$22,990,000. This represents approximately 4% of the \$573 million combined California ontrack, offtrack, and ADW handle accumulated since January 25. The attached graph shows the weekly handle for each of the ADW hubs.

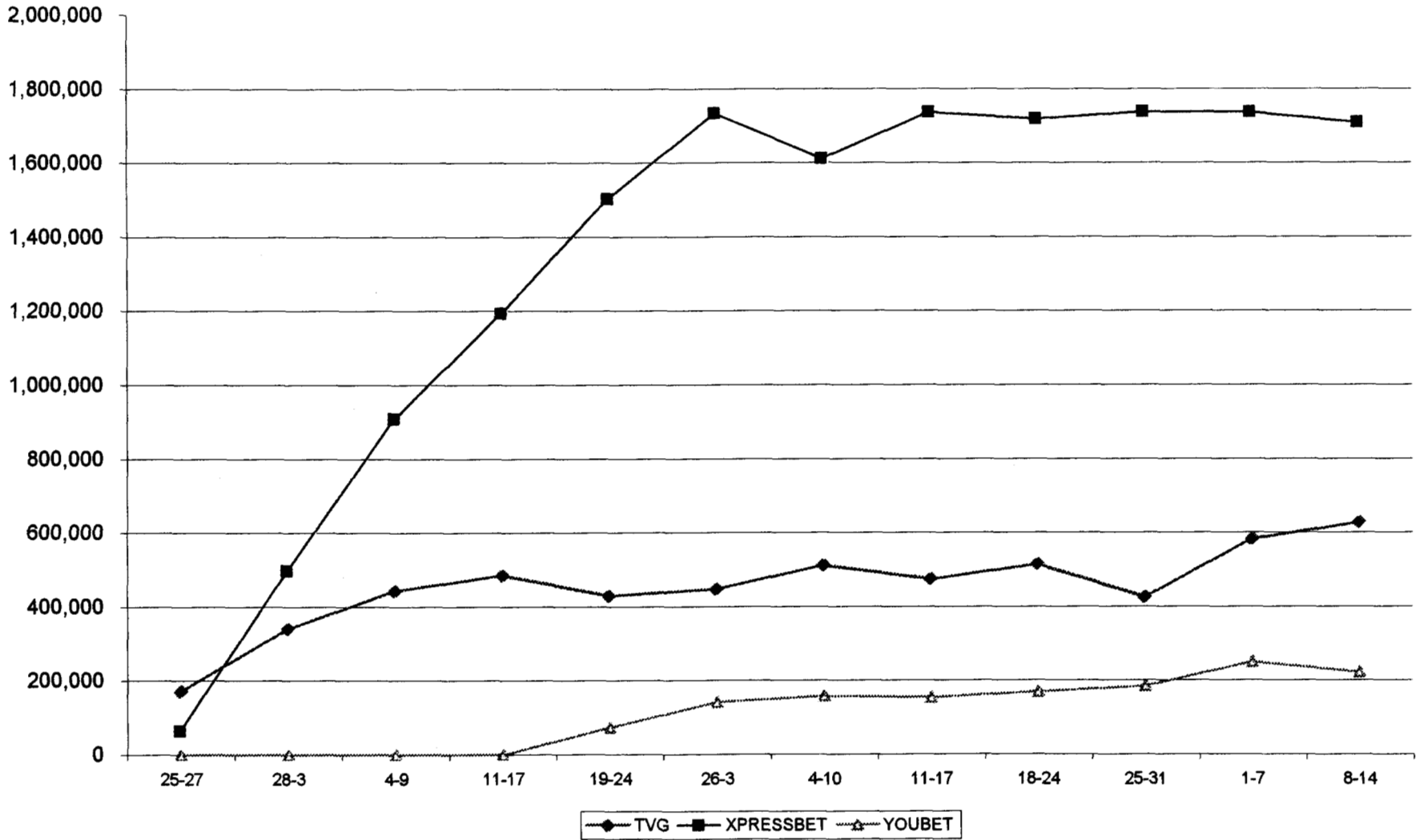
The ADW handle to date has been approximately 85% thoroughbred, 10.5% harness and 4.5% quarter horse. These breed percentages are fairly consistent between the northern and southern zones. The zones themselves show that of the total wagers, 70% are on southern races and 30% on northern races. Although a little early to tell, representatives for the current race meets do not attribute the variations in their year to date handle numbers (as compared to last year) to ADW. Since the current ADW handle is a relatively small percent of the total handle, its impact is minimal but worth watching closely.

Staff is prepared to answer any questions about the data presented.
