## **MINUTES**

---

Chairman Shapiro asked for approval of the minutes of the Regular Meeting of May 22, 2007.

Vice-Chairman Harris **motioned** to approve the minutes. Commissioner Moss **seconded** the motion, which was **unanimously carried**.

## **DISCUSSION AND ACTION BY THE BOARD ON THE APPLICATION TO CONDUCT A HORSE RACING MEETING OF THE SAN MATEO COUNTY FAIR (F) AT BAY MEADOWS FROM AUGUST 8 THROUGH AUGUST 19, 2007, INCLUSIVE.**

---

Jacqueline Wagner, CHRB staff, said the San Mateo County Fair (SMCF) proposed to run 11 days, one day less than in 2006, for a total of 103 races, 11 fewer races than in 2006. Ms. Wagner stated the first post time would be 1:45 p.m. daily, and 1:15 p.m. on Pacific Classic Day. The stabling and vanning contract, which the analysis indicated were missing, were received, and staff recommended the Board approve the application as presented. Chairman Shapiro asked if SMCF would run nine or ten races on Saturday and Sunday. Bernie Thurman of SMCF said during the weekend her organization would run nine races for thoroughbreds and one for other breeds. Chairman Shapiro asked why SMCF did not have stakes races

for thoroughbreds. Ms. Thurman stated SMCF did not receive an allocation of supplemental purse funds, so it was difficult to balance the purse account. However, she noted in 2006 SMCF was able to fill five thoroughbred allowance races. Vice-Chairman Harris stated Northern California needed to reestablish itself as a venue for year-round opportunities for horses that could run in all categories, and a stakes program was important to California breeders. He said he hoped SMCF could find a stakes category that would work, because with its turf course SMCF had a lot of advantages over other tracks. Vice-Chairman Harris added he hated to see a loss of stakes opportunities as the overall circuit was hurt when there were none. Ms. Thurman said there was always the opportunity to fill an overnight stake with Thoroughbred Owners of California permission. If SMCF found a unique category that it thought it could fill it could write such a race. Chairman Shapiro asked what efforts besides shuttle buses were being made to bring fair-goers to the track. Chris Carpenter of SMCF said the shuttle buses would also pick up fans at the Hillsdale CalTrans station and deliver them to track. Jeff Hinds of SMCF spoke about the fair's marketing plans. SMCF would use such devices as free track admission for all fair attendees and free grandstand passes upon entry of the main gate at the fair. Racing promotional materials would also be distributed on the fair grounds. In addition, jockeys would be available at the fair during non-racing hours, and Bay Meadows staff would be available at the fair to provide wagering information. SMCF would also hold a family day at the races; pass out free t-shirts; and experiment with new technology – including a text-based horse racing game. Chairman Shapiro said SMCF's promotional campaign was very impressive. He asked if SMCF would use all the California licensed advance deposit wagering providers. Ms. Thurman said that was correct. Chairman Shapiro

asked if there were any problems with agreements that could interfere with the continuous signal. Ms. Thurman stated there were no foreseeable problems. Commissioner Choper **motioned** to approve the application for license to conduct a horse racing meeting of SMCF. Commissioner Moss **seconded** the motion, which was **unanimously carried**.

**DISCUSSION AND ACTION BY THE BOARD ON THE APPLICATION TO CONDUCT A HORSE RACING MEETING OF THE HUMBOLDT COUNTY FAIR (F) AT FERNDALE FROM AUGUST 9 THROUGH AUGUST 19, 2007, INCLUSIVE.**

---

Jacqueline Wagner, CHRB staff, said the Humboldt County Fair (HCF) proposed to run ten days, the same number of days as in 2006, for a total of 75 races, the same number of races as in 2006. The first post time would be 1:55 p.m. on the weekend; 2:25 p.m. Monday, Wednesday and Thursday; and 2:55 p.m. Friday. The stabling and vanning agreements, which the analysis indicated were missing, were received, and staff recommended the Board approve the application as presented. Chairman Shapiro asked if HCF had the necessary camera equipment for the stewards to properly officiate racing. Stuart Titus of HCF said there were cameras at the finish line and on each of the turns. He stated there was also a head-on camera from the front side and the backside. Chairman Shapiro asked why there were six races on Wednesdays and seven or nine on Sundays. Mr. Titus said that was the case for nearly 16 years. It was a matter of managing racing opportunities for horses and going with a stronger program on days with more attendance. Chairman Shapiro asked what was the maximum field size. Mr. Titus said the maximum field was eight. Chairman Shapiro asked if HCF would run later to match Del Mar's four o'clock Fridays. Mr. Titus stated there was a fine line between fitting in with the Del Mar signal and satisfying the concerns of local fans. It was the HCF

board's recommendation that the Friday first post be moved to 2:55 p.m. Mr. Titus added fog was a problem – despite the extended daylight hours. Chairman Shapiro asked if HCF had any future plans for improvements that would benefit the fans. Mr. Titus said with HCF's limited resources the fair focused on one project at a time. In 2007, the focus was on the racing office and jockey's quarters, and there were plans to upgrade the grandstands. Vice-Chairman Harris asked if HCF thought its dates were appropriate, and if they tied into other activities. Mr. Titus stated the August dates were traditional, and although there had been conversations regarding moving the dates, there were other community events during the summer that presented difficulties. Commissioner Moss **motioned** to approve the application for license to conduct a horse racing meeting of HCF. Vice-Chairman Harris **seconded** the motion, which was **unanimously carried**.

**DISCUSSION AND ACTION BY THE BOARD ON THE APPLICATION TO CONDUCT A HORSE RACING MEETING OF THE SACRAMENTO HARNESS ASSOCIATION (H) AT CAL-EXPO FROM AUGUST 1 THROUGH DECEMBER 22, 2007, INCLUSIVE.**

Jacqueline Wagner, CHRB staff, said the Sacramento Harness Association (SHA) proposed to run 77 nights, three more nights than in 2006, for a total of 1,046 races. The first post time would be 5:35 p.m., Wednesdays and Thursdays; 6:20 p.m. Fridays and Saturdays through September 30, 2007; and 5:35 p.m. beginning October 3, 2007, until the end of the race meeting. Ms. Wagner stated SHA would coordinate its post time with Los Alamitos Quarter Horse Racing Association, and the racing fairs' thoroughbred twilight and evening races. She added the advance deposit wagering providers would be TVG and YouBet. Staff recommended the Board approve the application as submitted. Chairman Shapiro asked if the

California Exposition and State Fair (CESF) elected to run a meet in 2007. Richard Feinberg of SHA said CESF would not run a meeting. SHA would lease the facility and run a harness meeting during the fair. Chairman Shapiro stated the application indicated the average daily purse would be down for the meeting. He asked why that would happen. Mr. Feinberg said there was an overpayment of up to \$1.4 million, so purses were cut to make up the difference. As much as \$400,000 of the overpayment was erased, and if it was reduced a little more SHA would like to raise purses. Vice-Chairman Harris asked why SHA would not run on Labor Day. Mr. Feinberg stated that was a night SHA was not normally open, and the historical return in dollars wagered was not favorable. Chairman Shapiro said he understood the harness industry was going through some uncertainty regarding a venue at which to operate. He stated there needed to be a meeting to try and solidify where harness racing would go, so the industry could have some assurance regarding its future in California. Ralph Scurfield of SHA said he agreed with Chairman Shapiro and stated he would take the lead in working with the industry. He commented the uncertain situation at Cal-Expo caused an outflow of horses that SHA was working to reverse. SHA was also working to increase purses, which had been cut. Chairman Shapiro said he thought SHA was to provide a half-million dollar bond or letter of credit to ensure its financial obligations. He stated he did not see such an instrument in SHA's financial statement. Mr. Scurfield said he would have to look into the matter. Chairman Shapiro stated SHA was a nonprofit and there needed to be sufficient capital available for any possible liabilities. Chairman Shapiro asked how many Cal-bred standardbred horses were in the State of California. Jim Perez of California Harness Horsemen's Association (CHHA) stated there were approximately 250 Cal-bred standardbreds foaled in 2007 in California. Chairman



Shapiro said the application indicated \$800,000 was allocated to the California Sires Stakes program. He asked how many horses were participating in the different stakes. Mr. Perez said there were four categories of stakes, and the participation depended on which horses qualified. Chairman Shapiro asked if the same horses were winning the races. Mr. Perez said the winning horses were spread around, and only one horse in the three-year-old colts dominated. He commented the colt was exceptional and probably the best trotter seen in California in a long time. Chairman Shapiro asked if the Sires Stakes program was growing and stimulating breeding. Mr. Perez said the program had improved tremendously. With the help of SHA, the CHHA and others, the purses were up and the awareness of California's breeding program was also increasing. Commissioner Moss **motioned** to approve the application for license to conduct a horse racing meeting of SHA conditioned on a \$500,000 bond for payment of obligations in connection with the operation of the meeting being on deposit with the Board. Vice-Chairman Harris **seconded** the motion, which was **unanimously carried**.

**UPDATE BY REPRESENTATIVES OF MAGNA ENTERTAINMENT CORPORATION (MEC) CONCERNING THE STATUS OF THE REDEVELOPMENT OF THE BARN AREA AT THE SANTA ANITA PARK RACE TRACK.**

Chairman Shapiro read a statement issued by Frank Stronach of Magna Entertainment Corporation (MEC).

"I appreciate the opportunity to be here today before the California Horse Racing Board to talk about two important matters. The first matter is a question of reputation, which I am very concerned about. I pride myself on always being

one to keep my word. I can always make money but it's very difficult to rebuild a damaged reputation. Last month our CEO, Michael Neuman, wrote a letter to the City of Arcadia regarding the barn area at Santa Anita. Unfortunately, the letter contained a very poor choice of words in stating that there were never any plans to build barns at Santa Anita. I did not see the language in Mr. Neuman's letter until after it was sent. Had I seen the letter before it was sent, I would have made clear that MEC has always been committed to repairing, renovating, and rebuilding the barns and dorms at Santa Anita. Over the years, many conceptual ideas have been discussed both within MEC and with the City of Arcadia. In fact, numerous conceptual drawings have been generated over the years. MEC remains committed to repairing, renovating and rebuilding the barns and dorms at Santa Anita, although there are not definitive construction plans or drawings at this time, detailing these renovations. We all know it is very complex and difficult to satisfy the legal, historical and environmental issues surrounding development at Santa Anita and at present we do not have definitive plans that could be submitted to the City. In order to be able to formulate such plans, I propose forming a small committee composed of three horse owners, three trainers and two people from MEC's corporate office. Ron Charles would chair the committee. This committee would immediately hire a planning and historical consultant to expedite the approval process for synthetic racing surfaces at Santa Anita and Golden Gate Fields, and for rebuilding and repairing of barns and dorms at

Santa Anita. MEC will allocate a total budget for these projects of \$24 million. This committee will prepare the definitive plans for both the track resurfacing and the barns and dorms, and then those definitive plans will be presented to the City for approval. Under the present circumstances, the return of our investment is very unsatisfactory. For the record, we have invested close to \$350 million in California and our return is practically nil. Nevertheless, the additional \$24 million is a sign of goodwill towards the thoroughbred horse racing industry in California. The second matter I want to discuss is the importance of regulatory reform. I am proposing that we create a thoroughbred horse industry stakeholder committee, which will look at regulatory reforms for the California horse racing industry. We believe that the present regulations are outdated and that left unchanged the existing regulatory framework will cause the California horse racing industry to continue to deteriorate. Even though MEC is a major player in the race horse industry in America, we do not seek to dominate horse racing. We would like to ensure the key stakeholders are represented and have an important voice in this process. I am convinced that together we can create a viable future, but we need to take action. I hope the CHRB would play a major role in this exercise. I will leave you with a booklet with some ideas of what could be done to help our industry prosper in the future. I believe these proposals would lead to a viable horse industry business for the long term, and thereby, I believe I could convince my Board to commit our California racing lands to perpetuity as racetracks if we adopt the right

framework, but we must act now before it is too late. Thank you, Chairman Shapiro. I would be happy to answer any questions.”

Chairman Shapiro asked if Santa Anita would install a synthetic racing surface in the near future. Mr. Stronach said the capital was committed and management had full authority to proceed with the installation of a synthetic racing surface; the same was true for Golden Gate Fields (GGF). Chairman Shapiro asked if a synthetic track would be installed at Santa Anita prior to the Oak Tree meeting. Mr. Stronach stated Santa Anita management assured him a synthetic surface would be installed prior to the Oak Tree meeting. Mr. Stronach said upon his purchase of Santa Anita extensive plans for rejuvenation of the entire facility were developed. About \$70 million was spent on modifications to the grandstand and the installation of a dining room. In total, MEC spent approximately \$350 million in California with little return. However, MEC was providing another \$24 million that would be used to install the synthetic surfaces at Santa Anita and GGF, as well as the renovation of the barn area at Santa Anita. Mr. Stronach stated MEC also developed ideas he believed would benefit the entire horse racing industry in California. He proceeded to talk about a brochure that outlined those ideas, and his recent meeting with the horsemen at Santa Anita. Chairman Shapiro asked how MEC would handle the rodent problem in its barn area. Mr. Stronach stated that problem would be addressed when the horses were moved out for the installation of the synthetic track. Chairman Shapiro asked if he understood correctly that: 1) a committee composed of horsemen and MEC management would make recommendations regarding backside repairs and renovations at Santa Anita, and 2) the repairs and renovations would be made using the balance of the \$24 million after synthetic tracks were installed at Santa Anita and GGF. Mr.

Stronach said that was correct. Commissioner Choper asked if Santa Anita would begin improving the barn area when it installed its synthetic track. Mr. Stronach stated he spoke with Santa Anita management regarding some ideas he had for the barn area, and was told work would begin soon. Chairman Shapiro said the Board should be kept apprised of the formation of the committee and work that might be taking place. Ron Charles of MEC stated the committee would be formed shortly and he would keep the Board informed. Vice-Chairman Harris asked if MEC saw any problems with the synthetic track. Mr. Charles stated there were currently no problems, and installation would begin July 5, 2007. Candy Young, a trainer, spoke about the backside at Santa Anita. Jerry Jamgotchian, a horse owner, spoke about his concerns regarding Santa Anita.

**PUBLIC HEARING BY THE BOARD ON THE PROPOSED AMENDMENT OF CHRB RULE 1690.1, TOE GRABS PROHIBITED, TO PROHIBIT THE USE OF TOE GRABS GREATER THAN FOUR MILLIMETERS ON THE FRONT SHOES OF QUARTER HORSES WHILE RACING.**

---

Jacqueline Wagner, CHRB staff, said the proposed amendment of Board Rule 1690.1, Toe Grabs Prohibited, would prohibit the use of toe grabs greater than four millimeters in height on the front shoes of quarter horses while racing. Ms. Wagner stated the current rule prohibited the use of such shoes on thoroughbred horses. She spoke about the history of the regulation, stated no comments were received during the 45-day public comment period, and said staff recommended the Board adopt the amendment as presented. Chairman Shapiro said he understood Dr. Edward Allred, the owner of Los Alamitos, supported the proposed amendment. Paul Jones, a quarter horse trainer, stated he started all his horses with toe grabs. He said he was aware that the University of California at Davis had not conducted studies on

quarter horses; all the studies were on thoroughbred horses. Mr. Jones stated he used a regular toe grab with a high toe grab on the back, and he had few catastrophic injuries in the past ten years. He said it was crucial for quarter horses to get traction out of the gate, as when the horses slipped and could not get a hold of the ground, there were probably more injuries. Mr. Jones stated if a trainer did not believe toe grabs were good for a horse, he had the option of not using them. He added in all racing states the majority of quarter horses ran on toe grabs. Vice-Chairman Harris stated if there had not been enough comment from the quarter horse industry, perhaps the item should be put over. Dino Perez of the Pacific Coast Quarter Horse Racing Association said his organization polled its members during the 45-day public comment period and did not find any opposition to the proposed regulation. Mr. Perez stated his board did not vote on the issue, but it did not oppose the regulation. Dr. Rick Arthur, CHRB Equine Medical Director, said there was no data to prove high toe grabs put quarter horses at risk, but approving the proposed amendment was not a detriment. Dr. Arthur stated it did not matter if a horse was a quarter horse or thoroughbred when one looked at the biomechanics of the process. He added there was a disturbingly high incidence of fetlock breakdowns at Los Alamitos. Mr. Jones said if one looked at the record, the majority of breakdowns at Los Alamitos were thoroughbreds that ran in \$5,000 claiming races, and were not running with toe grabs. Commissioner Choper asked why Mr. Jones objected to changing to smaller toe grabs. Mr. Jones stated he did not believe he would be at a disadvantage if everyone ran without toe grabs. He stated he felt the Board was overlooking the differences between quarter horse racing and thoroughbred racing. Quarter horses raced out of the gate and needed traction. When horses did not get a hold of the track, they slipped, and that

created more injuries than toe grabs. No studies were done on quarter horses, and if the Board wished to ban toe grabs for quarter horses it needed to prove its hypotheses. Vice-Chairman Harris asked if Mr. Jones was aware that the rule only banned front toe grabs, and a trainer could use any toe grabs he wished on the hind end of the horse. Mr. Jones said he was aware of the provisions of the rule. He stated he felt the hind end was more important than the front, but quarter horses dug into the track to get out of the gate and the first three or four jumps were crucial. Chairman Shapiro said the item would be **deferred** until additional input could be received from the quarter horse industry.

**DISCUSSION AND ACTION BY THE BOARD REGARDING MANDATING THE USE OF SAFETY REINS AT CALIFORNIA RACETRACKS.**

Mike Martin, CHRB staff, said there were two types of safety reins. One type of safety rein, the "Sure Lines" rein, had a nylon safety rein sewn into the leather rein. The nylon rein emerged at the end and was independently attached to the bit. The second type of safety rein, the "Peck" safety rein, looped around the bit, and the nylon rein looped with the rein. If the rein broke, the nylon remained. Mr. Martin said the safety reins added approximately \$10 to \$20 – plus the patient fee – to the cost of a set of reins. The jockeys supported the use of safety reins, while trainers seemed to have a mixed reaction. Trainers in opposition tended to believe it was a matter of individual responsibility and nongovernmental interference. Arthur Gray, the developer of Sure Lines safety reins spoke about his product, the reason he developed safety reins, and how the reins worked. Chairman Shapiro asked how many races were run in the United States in 2006 in which reins broke. Mr. Gray said there were no statistics; however, the Association of Racing Commissioners International (ARCI) was

working on accident information and documentation. Chairman Shapiro asked if Mr. Gray was advocating using safety reins in all cases, or only during galloping, exercising and racing. Mr. Gray stated his research indicated there were more accidents in the mornings during workouts. There was also the issue of liability if safety reins were not mandated for the full racetrack facility. Chairman Shapiro said that meant the mandate would be the use of safety reins at all times. Chairman Shapiro asked if Ohio was going to mandate safety reins beginning in July 2008. Mr. Gray said Ohio did mandate the reins, but horsemen were trying to get the State to reconsider the issue. Other states were waiting to see what would happen in California, and the ARCI adopted a model rule in May 2007. Mr. Gray stated he knew horsemen were worried about the additional costs, and that was why he recommended an 18-month transition period. That would give horsemen time to replace conventional reins without creating a financial burden. Chairman Shapiro stated the Board was always concerned about safety, but the issue was the ability of riders to make decisions regarding the equipment they wished to use. Vice-Chairman Harris said the trainer usually brought the reins to the horse, and every trainer might use different bits on different horses. There should be an understanding between the rider and the trainer regarding the use of safety reins. Mr. Gray said that was something he did not think would happen. Half the time if a driver or rider insisted on using safety reins, the trainer would simply get another driver or rider. Another argument for making such reins mandatory was to ensure everyone was using them. If the horse that did not have safety reins lost a rein, it would not matter that another jockey or driver did use safety reins; unless there was full compliance, the horse without safety reins was a danger to the remainder of the field. Darryl Haire of the Jockey's Guild (Guild) said the



bottom line was that reins were breaking too often. Safety reins were as important as synthetic surfaces and they needed to be mandated just like safety vests. Brain Peck of "Peck" safety reins spoke about the design of his reins. Chairman Shapiro asked if the "Peck" rein would break. Mr. Peck said if the reins went over the horse's head, and the horse stepped on them, they would break at the end of the rubbers. Mr. Peck stated the head of the engineering department at Western Kentucky University tested his reins. Chairman Shapiro said one issue was how to define safety reins. Mr. Peck stated that was a problem in most states. Ohio was going to look into the issue, as it was not sure how to define such reins, though it mandated their use by July 2008. Chairman Shapiro said he was not opposed to mandating safety reins, but how did the Board regulate a rein when it had no definition? Ms. Wagner said Assembly Bill (AB) 1180 defined safety reins as: "...a type of rein that is reinforced with wire cable, nylon strap, or other safety device or material that is attached to the bit and designed to maintain control of the horse should the rein break." She added AB 1180 defined a conventional rein as any rein other than a safety rein. Ed Halpern of California Thoroughbred Trainers (CTT) said the issue was safety, but it was not clear which was safer: a rein that would break under certain circumstances, or a rein that would not break under other circumstances. Mr. Halpern stated he spoke with several prominent, long-standing trainers who have said they were against mandating safety reins. The reason those trainers used leather, as opposed to nylon or other materials, was that they wanted the reins to be able to break. Mr. Halpern said there had been no injuries based on or created by conventional reins breaking in CTT's experience with running the trainers' worker's compensation program for over four years. He stated that included a hundred thousand mounts in afternoon racing and

four and a half years of morning training. Mr. Halpern said liability would cut both ways; the Board was going to be sued regardless of what safety rein it mandated because there could always be a situation in which the rein might cause injury. Vice-Chairman Harris asked if it were clear safety reins would not break. He said he thought there was some amount of tension at which they would break. Mr. Halpern said the "Peck" reins were designed to break. The Sure Lines safety rein was 30 to 40 pounds stronger than conventional reins, but they would break. Commissioner Choper asked if Sure Lines safety reins would break under the conditions described by Mr. Halpern. Mr. Gray stated his reins would break. Mr. Halpern said the CTT worker's compensation program ordered approximately 110 sets of the safety reins, and was planning to distribute them. He stated the CTT planned to obtain safety reins from other manufacturers for distribution. Mr. Halpern asked that the Board defer the issue to give the CTT time to make a determination as to whether safety reins did prevent injuries. He stated CTT would like up to four months of use to see what the results might be. Vice-Chairman Harris asked if some trainers were currently using safety reins. Mr. Halpern said some trainers were using such reins, but there had not been a complete or extensive trial. Jerry Jamgotchian, a horse owner, spoke about his concerns regarding safety reins. Paul Jones, a trainer, spoke about the pair of nylon reins he crafted to replace traditional leather reins. Vice-Chairman Harris asked if the Guild had a position on nylon reins. Mr. Haire said some of the conventional reins were nylon. The safety aspect was their ability to break, and have backup from a safety rein. Vice-Chairman Harris asked what the breaking point of nylon was, because one aspect of the issue is at some point, one might want the rein to break. Mr. Gray said on nylon reins the buckle would break. Nylon would not break over time, as the

weather would not deteriorate the material. Mr. Jones said his reins were safe. Nylon would not dry rot inside and tear easily. Chairman Shapiro stated the issue was going to be how the Board described safety reins and how a rule would be enforced. Dino Perez, a trainer, said the various breeds could not be compared with regards to accidents involving conventional reins. He stated the harness industry saw many fewer accidents with reins than thoroughbreds or quarter horses. Harness drivers also supplied their own reins, so if a driver wanted to use safety reins, there would be no problem. Mr. Perez stated if a harness driver wanted to use safety reins, the Board should let the drivers buy their own. Commissioner Moss said he thought the issue involved jockeys and trainers, and for the Board to create a mandate without completely understanding the difference between nylon and leather made the Board liable; there needed to be more study. Commissioner Moss also said he agreed that if the jockeys wanted to use safety reins, they should negotiate with the trainer. Chairman Shapiro said the issue would be **deferred** until such time as a satisfactory test of the various types of safety reins could be completed.

**REPORT AND DISCUSSION BY THE BOARD REGARDING THE SENATE COMMITTEE ON GOVERNMENTAL ORGANIZATION'S JUNE 13, 2007, MEETING CONCERNING "CALIFORNIA HORSE RACING BOARD OVERSIGHT: SYNTHETIC TRACKS AND RACING DATES."**

---

Chairman Shapiro said the Senate Committee on Governmental Organization held a hearing on June 13, 2007. The intent of the meeting was to look at issues relating to horse racing and synthetic racing surfaces. He stated the meeting was informative and useful, and those who attended voiced the Board's desire to work with the Legislature to help the industry meet common goals.

**DISCUSSION AND ACTION BY THE BOARD REGARDING THE STATUS OF BAY MEADOWS RACE TRACK AND THE NORTHERN CALIFORNIA RACING CALENDAR.**

---

Chairman Shapiro said there was some confusion regarding his stance on granting Bay Meadows a waiver. He stated he was not opposed to a waiver for a defined period of time. The Board wished to maintain a cohesive, ongoing racing program in Northern California, so it should look at granting a 2008 racing year waiver to Bay Meadows. Commissioner Moss asked what was the status of Golden Gate Field's (GGF) synthetic racing surface. Robert Hartman of GGF said the City of Albany informed him it would make a decision regarding a permit to install a synthetic racing surface at GGF by the end of business on June 19, 2007. He stated there was some concern regarding the appeals process. Several groups, including the Sierra Club, indicated they would appeal a permit. To install a synthetic track in 2007, GGF would need a quick appeals process and all of the suppliers and vendors would have to be lined up and ready. Vice-Chairman Harris asked where the materials for the synthetic track were located. Mr. Hartman said the materials for the track were on the East Coast. He stated the first part of the project was construction, so the manufacturer would have some time to mix the materials, which would happen on the West Coast. Mr. Hartman said the new rail was at GGF, and the contractor stated a minimum of two weeks would be needed to purchase the supplies for the subsurface. Vice-Chairman Harris asked how much time was allowed for appeals to be filed. Mr. Hartman said 14-days would pass before GGF knew if there were appeals. If the appeals went through City planning and zoning, then to the city council, it could take a month. Otherwise, appeals could be taken directly to the city council. Mr. Hartman added the Bay Conservation and Development Council (BCDC) would also have to

issue a permit to GGF. He stated GGF could not apply for a BCDC permit until the City of Albany made its determination. Commissioner Choper asked if GGF had any reason to believe there would be a judicial appeal. Mr. Hartman said he did not know of any party who would resort to a judicial appeal. He stated he believed the work that GGF and the City of Albany did during the permit process would facilitate any appeal because of the city staff's level of detail. Chairman Shapiro asked if it would be possible for GGF to trade some days with Bay Meadows to be able to complete the installation. Mr. Hartman said it would take a creative solution. One obstacle was the number of days allowed for racing in 2008. If GGF traded two or three weeks, it would want to make them up in 2008, and that might put it over the 22-week maximum. Bernie Thurman of Bay Meadows said her organization would be willing to work with GGF to find a way to allow it to install a synthetic surface. Vice-Chairman Harris asked if there was anything that could be done to expedite the process. Mr. Hartman said input from the Board could help. He stated GGF was working with its Assembly and Senate representatives, but political pressure on the City had not succeeded. Mr. Hartman commented the City of Berkeley was looking for dirt for its ball field, and the dirt from GGF would be ideal. If the dirt was donated it could save Berkeley a quarter million dollars. If the process was expedited, it could be a win/win situation for Berkeley and GGF. Commissioner Moss said the Board received support from all facets of the industry for its decision not to grant Bay Meadow a waiver. He stated, however, the Board could not afford to close down racing in Northern California. Commissioner Moss said he would suggest that GGF be included in the waiver if one was granted to Bay Meadows. Ron Charles of Magna Entertainment Corporation said GGF was cautiously optimistic that it could install its synthetic

track in 2007. He stated he would hesitate to take a premature position regarding a waiver, but by the July Regular Meeting GGF would have a better idea of its timelines. Vice-Chairman Harris said he would hesitate to issue a blanket waiver to both tracks unless it was the only alternative. Bay Meadows might not be operating in a year's time, while GGF would be around for a long time, so it made sense to install a synthetic track surface. Vice-Chairman Harris asked how long it would take GGF to install its synthetic track. Mr. Hartman said because of the city's restrictions on construction hours it would take between three and a half to four months. If construction hours could be extended, installation time could be reduced to a little as three months. Commissioner Moss asked if 2008 was Bay Meadows last year to operate. Jack Liebau of Bay Meadows said it was likely that 2008 would be Bay Meadows last year. Chairman Shapiro asked if Bay Meadows would be available throughout 2008 for racing and training. Mr. Liebau said Bay Meadows would prefer to run as early as possible in 2008, and it felt it had an obligation to accommodate the San Mateo County Fair, which ran in August. He added Bay Meadows would also be willing to swap dates with GGF so it could install its synthetic track. Chairman Shapiro said as the Board moved to decide the 2008 dates it had to figure in the closure of Bay Meadows, as well as stabling and housing, so it needed to know how much notice there would be to prepare. Mr. Liebau said Bay Meadows would have an answer when race dates were allocated in August or September 2007. Once the dates were allocated, Bay Meadows would do everything to run. Mr. Liebau stated there could be some arrangement wherein sufficient notice could be given regarding the availability of the barns. Or, the barns might be available as long as the dismantling of the grandstand did not endanger horses. Chairman Shapiro asked if Bay Meadows was able to meet with the Northern

California stakeholders to discuss a 2008 racing calendar. Mr. Liebau said a meeting took place, but things were being tried in Northern California with the fairs and it was a bit premature to make decisions. He stated all options were still open. Commissioner Choper asked when the stakeholders would meet again and reach some decisions. Mr. Liebau said the stakeholders would meet in mid to late June 2007. Tom Bachman of Thoroughbred Owners of California (TOC) stated GGF faced many difficulties with the installation of its synthetic racing surface. The BCDC was a powerful organization, and there were others that could delay the process. It would probably be 2008 before GGF could install its racing surface. Mr. Bachman said he would propose that the 2007 racing calendar be used if the question of 2008 Northern California race dates could not be settled by August 2007, and the synthetic track at GGF were not installed in a timely manner. Mr. Bachman stated if Bay Meadows refused, then it could close in 2007 and the industry in Northern California could move forward. The Northern California tracks that wanted to step forward to fill the void left by Bay Meadow's closure could not make plans unless they had a definite date. He reminded the Board that such tracks would also have a permit process, and as Northern California had a definite rainy season, there would be times when the construction process would be restricted. Chairman Shapiro said the parties should meet and return to the Board at a future date with a consensus. He asked if any member of the Board had a problem granting Bay Meadows a one-year waiver for 2008. Commissioner Choper said it seemed the discussion at the May 2007 Regular Meeting was on the condition that Bay Meadows operated for the allocated number of dates it was trying to achieve, and it seemed there was general sympathy with that point of view. Chairman Shapiro said that was correct, but there were two issues: 1) granting a waiver and 2)

2008 racing dates. No dates would be decided by simply agreeing that for 2008 Bay Meadows would receive a waiver regarding the installation of a synthetic racing surface. Commissioner Moss said he would like to include GGF in a waiver because of the uncertainty of installing a synthetic track at that facility. Chairman Shapiro stated he would like to limit the issue to Bay Meadows – unless there was a real need to address GGF. Commissioner Moss said granting Bay Meadows a waiver would be a reversal of the previous vote. If there were circumstances that necessitated granting a waiver, other than politics, they should be cited and explained. Vice-Chairman Harris said the original request was for a two-year waiver. The current issue was a one-year waiver. There was some thought that other tracks would install synthetic surfaces, but only GGF made such a commitment. That presented a reasonable reason to grant Bay Meadows a one-year waiver, as there was no place else to run. Chairman Shapiro said the item was **deferred**.

**DISCUSSION AND ACTION BY THE BOARD REGARDING THE STATUS OF THE SHORTFALL PAYABLE TO THE STATE BY THE RACING ASSOCIATIONS AND FAIRS PURSUANT TO BUSINESS AND PROFESSIONS CODE SECTION 19616.51.**

Roberto Zavala, CHRB staff, said the State's charge of horse racing revenue was deposited to the State's General Fund or a Special Fund, one of which was the Fairs and Exposition (F&E) fund. The total amount paid to the State by racing associations and racing fairs for the years 2005 and 2006 did not reach the \$40 million threshold contained in Business and Professions (B&P) Code Section 19616.51 by a combined \$1.528 million. On January 26, 2007, the Board sent a letter notifying racing associations and racing fairs of the shortfall. B&P Code 19616.51 required that the racing associations and racing fairs pay a pro rata share of the



shortfall by March 1, 2007. To date, \$101,361 had been submitted. Some associations questioned the dollar amounts reported. Mr. Zavala stated staff was recommending that a discussion of the shortfall be undertaken and any action await final determination and legal opinion regarding all amounts that should or must be included in the calculation of the \$40 million baseline. Vice-Chairman Harris asked if the racing associations and horsemen were able to access backup data for the item. Bernie Thurman of Bay Meadows Racing Association said the industry received information regarding the shortfall. Ms. Thurman stated in November 2006 she and CHRB staff met with F&E staff to review the F&E figures. The parties were comfortable with the figures, and a letter was sent to the industry. The first response was from Jack Liebau who stated he thought the calculations were incorrect. The monies that were submitted have been placed in an account until a Legislative Council opinion can be obtained regarding what should transpire and who owed what, if anything. Chairman Shapiro said he did not think the Board was in a position to discuss the item. He noted there were conflicting opinions regarding the issue, and the Deputy Attorney General had not had time to conduct research critical to the Board's understanding. Commissioner Choper said the Board should have a legal opinion regarding how the statute defined where the funds ought to go. Richard "Bon" Smith, CHRB staff, said staff intended to seek legal guidance from Legislative Counsel regarding the specific intent of the statute. Staff received assurances from the F&E staff that the F&E Fund, the Satellite Wagering account, and the Equine Research Fund were to be the recipients of \$40 million. However, questions about when monies went in the fund, and when it was accounted for, needed to be answered. Mr. Smith stated staff wanted to ensure the Board was aware of the issue before the end of the fiscal year. Chairman

Shapiro **deferred** the item. Richard English, a Certified Public Accountant, spoke about his concerns regarding issues surrounding the shortfall. Jerry Jamgotchian, a horse owner, spoke about his concerns regarding the shortfall.

**DISCUSSION AND ACTION BY THE BOARD ON THE DISTRIBUTION OF RACE DAY CHARITY PROCEEDS OF THE OAK TREE CHARITABLE FOUNDATION IN THE AMOUNT OF \$66,800 TO 25 BENEFICIARIES.**

---

Roberto Zavala, CHRB staff, said the Oak Tree Charitable Foundation (OTCF) proposed to distribute \$66,800 in charity race day proceeds to 25 beneficiaries. Mr. Zavala stated the distribution provided more than 83 percent to industry related organizations, and staff recommended the Board approve the request as presented. Vice-Chairman Harris **motioned** to approve the request by OTCF to distribute charity race day proceeds. Commissioner Moss **seconded** the motion, which was **unanimously carried**.

**REPORT OF THE MEDICATION COMMITTEE**

---

Chairman Shapiro said the Medication Committee (committee) met on June 18, 2007. The committee heard a number of issues, including the reclassification of drugs, tracking injuries and accidents, and pre-race examination procedures.

**DISCUSSION AND ACTION BY THE BOARD ON THE PROPOSED AMENDMENT TO RULE 1843.2, CLASSIFICATION OF DRUG SUBSTANCES, TO RECLASSIFY SPECIFIED DRUG SUBSTANCES.**

---

Dr. Rick Arthur, CHRB Equine Medical Director, said the proposed amendment to Board Rule 1843.2, Classification of Drug Substances, was a technical change that encompassed

approximately 48 drugs that had not previously been classified. The drugs were primarily non-steroidal anti-inflammatory drugs, similar to Phenylbutazone and Advil, and anabolic steroids, which also needed classification. Dr. Arthur added the Association of Racing Commissioners International Veterinary Pharmacy Committee recommended the drugs. He spoke about specific drugs and his recommendations for classifying them. Vice-Chairman Harris said if anabolic steroids were something the Board was testing for, how would the Board enforce its rule if horses shipped in from other states were administered such drugs. They could have been administered in California, or they could have been administered out of state. Dr. Arthur said the drugs were Category "D" drugs, which would only result in a warning. He stated that would not change. The Board would take action on some of the exotic anabolic steroids that were rarely used. The most commonly used anabolic steroids were rarely called unless they were used too close to a race. Vice-Chairman Harris said many horses on the backstretch were on Winstrol or Equipoise. He asked if a positive would come back with a warning every time. Dr. Arthur stated the Board tested for those drugs; they were Class 4 drugs, but they were only called in unusual circumstances. Commissioner Moss **motioned** to instruct staff to initiate a 45-day public comment period for the proposed amendment of Board Rule 1843.2. Vice-Chairman Harris **seconded** the motion, which was **unanimously carried**.

#### **PUBLIC COMMENT**

---

Cliff Goodrich, representing Fairplex Park Pomona (Fairplex), spoke about the future of horse racing in California. He stated September 23, 2008, was the last date Hollywood Park was

committed to run unless there was acceptable mitigation. The industry could plan a long-term calendar with Hollywood Park, or it could plan one without that facility, but the planning needed to be done. Fairplex suggested the reactivation of the Strategic Planning Committee to commence discussions on a calendar for 2008, 2009 and beyond, and that the industry continue to push for significant legislation. More importantly, Hollywood Park needed to inform the Board of its plans, so the industry could have certainty and could move forward. Vice-Chairman Harris said the Attorney General's office needed to research the Board's ability to construct a multi-year racing calendar. Deputy Attorney General Derry Knight said the Board had the ability to issue race dates for multiple years. Jerry Jamgotchian, a horse owner, spoke to the Board about his concerns regarding horse racing in California. Commissioner Choper and Executive Director Ingrid Fermin addressed the nature of Mr. Jamgotchian's comments, and his view of the workings of the Board. Chairman Shapiro added his thoughts on the input provided by Mr. Jamgotchian. In addition, he stated he was sad to acknowledge the death of Mr. Ed Friendly, a well-respected horse owner, and founder of Thoroughbred Owners of California.

#### Plan for Graded Stakes/Races of \$100,000 or more

When a Graded Stakes Race or race with a purse of \$100,000 or more is conducted at Bay Meadows, the following procedures are implemented to enhance security:

- Richard Lewis, Coordinator of Racing Operations, provides a list of starters to Michael Scalzo, VP Operations and Security. The list, which is compared to the day's official racing program, contains the following information:
  1. Name of Horse
  2. Name of Trainer or Substitute Trainer
  3. Name of Groom
  4. Name of Veterinarian
  5. Barn number where horse is stabled
  6. Stall number in barn where horse is stabled
- To supplement the normal security staff assigned to the barn area, "Special security" personnel are assigned to each horse's stall and surveillance begins six (6) hours before the official start of the race. The number of special security personnel is dependent upon the number of entrants in the race.
- The special security people attend an instructional meeting early in the morning of the race; instructions include:
  1. The specific assignment details for the individual horse assigned each guard.
  2. A briefing on race day medication rules, provided by a California Horse Racing Board representative.
  3. A briefing on the dynamics of horse racing and racing operations by Richard Lewis, Coordinator of Racing Operations.
  4. A briefing on general operations procedures as they relate specifically to the Bay Meadows Racecourse.
  5. Each guard is given a packet which includes an official racing program and a form provided by the CHRB which is to be signed by the attending veterinarian at the time of the administration of furosemide or estrogens for all horses registered as bleeders. The form notes the name of the Horse, Trainer, Veterinarian, Race Number, Barn Number, Stall Number, Official Post Time, Administered Time of Bleeder Medication and Number of injections/syringes.
  6. Each individual is given a video camera to record any and all activity involving individuals entering and exiting their assigned horse's stall. Guards are instructed to first direct their camera recording to the posted number of the stall to confirm that the video is directed at the assigned runner. Guards are instructed to videotape the attending veterinarian at the time of his or her administering the furosemide and/or estrogen shot for those horses registered as bleeders.
  7. Each guard is instructed to monitor any suspicious activity or activity they don't understand, and to contact the VP of Operations and Security if and when suspicious activities may take place.

8. Guards are instructed to station themselves as close to the assigned horses' stall as possible, without jeopardizing safety, and are to remain in view of the horses' stall.
  9. Each guard is instructed to follow, on foot, the horse and handlers to the receiving barn before the race is run.
  10. Each guard is instructed to meet the VP of Operations & Security at the receiving barn, where he or she will return the video camera and any notes he/she may have taken pertaining to the day's surveillance. At this time, there will be a discussion with all guards relating to the day's activities.
- Video surveillance tapes are saved until all test results have been determined to be negative.
  - CHRIB investigators coordinate with the BMRA special surveillance team. Investigators are encouraged to visit the location of all participating horses in the graded/stakes race(s) of the day.

Detention Barn Plan & Number and Location of surveillance cameras in detention barn area:

In January, 2005, a new surveillance system was installed in Barn One, which is the barn mostly frequently utilized by horses shipping in to run at Bay Meadows. Barn One is 360' long by 180' wide, and has ten exits and entrances. It contains approximately 162 stalls, and houses the receiving barn area, transit and detention stalls. Surveillance equipment includes a 16 camera, 180 GB digital recording system. The installation of surveillance equipment in Barn One enables the company to better monitor the activity of horses and persons entering and exiting Barn One and the stable gate area, which is roughly fifty feet away.

One camera has been strategically placed to monitor the stable gate entrance, two cameras monitor designated detention stalls, and the balance have been placed to provide surveillance of the entrances and exits to the barn.

The recorder is kept in a secure housing in a locked communications room in the Barn building. A password is required before any action can be taken on the recording system.

The cameras are powered from a common power supply located, with the recorder, in the communications room. The entire system is powered with a UPS power back-up, and will continue to operate during a power failure.

All cameras generate their own infra-red light source, so they provide a viewable image even in "total" darkness. They operate in color during the day, and convert to black-and-white in dark lighting conditions.

The digital recorder records all cameras at full frame. Recording options include resolution quality and motion detection. In motion detection mode, video frame recording commences only when motion is detected within selected areas, which saves on hard-drive storage space. The amount of time that can be stored before re-recording over existing material occurs is dependant upon the amount of barn activity. If all cameras recorded 24 hours a day, 7 days a week, at the highest resolution setting, the 180 GB drive would begin re-writing over existing data within about 48 hours. With standard resolution and motion detection engaged, recording time falls between 5 and 10 days before re-writing begins.

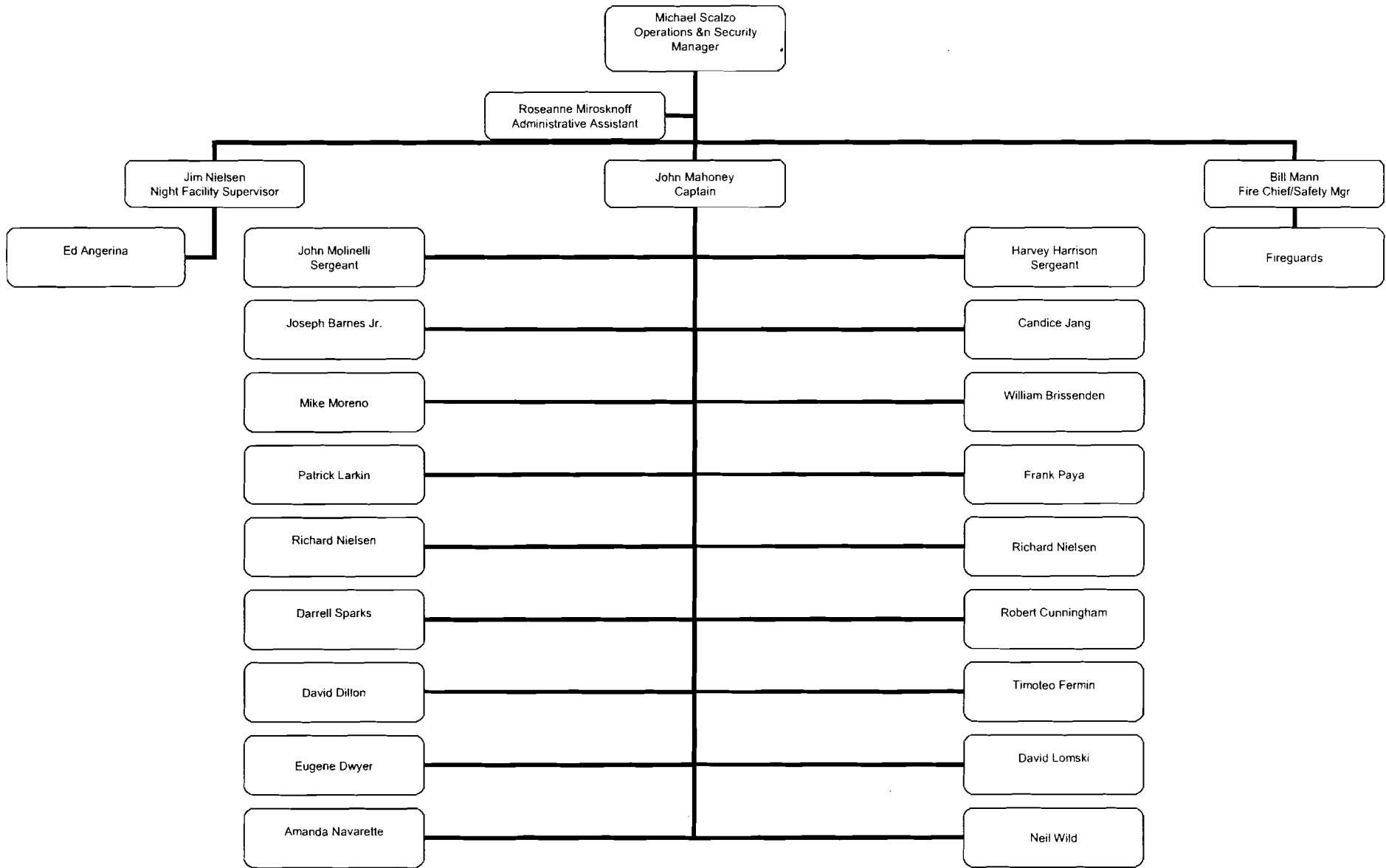

**Bay Meadows has five diesel electric generators that power backup lighting systems. Normally, the generators are run only in the case of a PG & E failure. On nights during which evening cards are conducted, the generator connected to the twenty-four 1,500 watt metal halide lights on the roof is turned on in order to insure that there is no transfer lag time should there be a PG & E failure. Three portable 4-lamp, 1,000 watt metal halide generator sets, one in the corporation yard, one at the quarter chute entrance, and one in the south parking lot adjacent to the jockeys room, are also utilized. The emergency lighting system provides power not only to the track lights, but to key areas such as totalizator, computer, phone, and money rooms, public address systems, and public areas in the grandstand and parking lots. Additionally, each barn is equipped with battery powered emergency lighting. To insure reliability, the generators are serviced bi-annually and are run for at least one hour each month.**





### Security Controls

Paragraph B (1) Surveillance of horses in races with a purse of \$100,000 or more:

Del Mar will provide payroll and administrative services for the coordinator for this project. "In today" horses in the Barretts Juvenile and Debutante, Las Madrinan, Pomona Derby and the Ralph M. Hinds Pomona Invitational Handicap will be subject to surveillance. The CHRB will provide hand-held cameras and the coordinator will be responsible to hiring non-union security to remain outside the stall of each horse in these races 6 hours prior to the running of the race. The security person assigned to a horse will escort the horse from the stall to the receiving barn. Anytime an authorized person enters the stall within the 6 hour period, the security person must operate the camera and memorialize the interaction of the authorized person and the horse.

### Paragraph B (2) Detention Barn

A) Barn 28A is our detention barn. Cameras are installed and will be operational every racing day. Video tapes will also be available for review by the stewards at their request. Upon written instruction from the CHRB, trainers may be required to place their "in today" horse in the detention barn 24 hours prior to the race.

With regard to TCO2 detention barn procedures, protocols and disciplinary procedures as set forth in agreements with TOC and CTT, these items are detailed in the TOC agreement.

B) Three Guards cover the Detention Barn, one per eight hour period.

### C) Camera Locations

Camera surveillance locations cover:

- West Gate: Pan Tilt Zoom Camera. View of vehicle entering into restricted CHRB area.
- East Gate: Pan Tilt Zoom Camera. View of vehicles exiting out of CHRB area.
- Triangle Parking: General coverage of parking lot.
- Barn 28A: Camera coverage of all 10 stalls and outside East/West stalls sides.

These cameras monitor for activities in these locations and are recorded for a specific number of days. Monitoring of surveillance cameras are done at Backside Security office, the West Gate, and Security Headquarters.

Barretts Barn 1 is our holding barn. All horses shipping in, except those accommodated by trainers assigned stalls, will be housed in the holding barn while on the grounds at Fairplex Park.

BACKGROUND

Business and Professions (B&P) Code Section 19420 provides that the Board shall have jurisdiction and supervision over meetings in this State where horse races with wagering on their results are held or conducted, and over all persons or things having to do with the operation of such meetings. B&P Code Section 19440 states the Board shall have all powers necessary and proper to enable it to adopt rules and regulations for the protection of the public and the control of horse racing. B&P Code Section 19590 provides that the Board shall adopt rules governing, permitting, and regulating pari-mutuel wagering on horse races under the system known as the pari-mutuel method of wagering. The proposed amendment to Rule 1978, Select Four is based on the recommendations submitted by the National Thoroughbred Racing Association (NTRA) Players Panel (Panel). The Panel is an advisory body charged with making policy recommendations of importance to bettors. In issuing policy recommendations the Panel in 2004 wrote that "when late scratches occur in the Pick Three and Pick Four wagering, after wagering pools have opened, most jurisdictions arbitrarily transfer the combinations that include the scratched horse to the betting favorites. The practice is . . . unfair to bettors." The Panel recommended: "Where late scratches occur in the first leg, refund all monies for the combinations that include the scratched horse(s) (and) where late scratches occur in the middle and final legs, provide consolation payoffs to the bettors that have combined the scratched horses with the winners in the other legs, similar to traditional procedures applied to late scratches in Daily Doubles."

In 2005 the Board considered the Player's Panel recommendation to amend Rule 1977, Pick Three and adopted a proposal to eliminate the substitution of the favorite for the scratched horse and to provide for refunds and/or consolation pools for scratched horses. It was particularly important to amend the Pick Three rule because totalizator programming does not support the selection of alternates for scratched horses in the Pick Three, whereas in the Pick Four and other wagers involving four or more legs, bettors do have the option of designating an alternate to replace a scratched horse. This option for the selection of alternates is contained in Rule 1976.8, Place Pick (n), and 1976.9, Pick (n) Pool. However, this language was not added to Rule 1978, so associations wishing to provide alternate selections for the Pick Four have been using 1976.9. The proposed amendment to Rule 1978 is consistent with the Pick Three amendment adopted by the Board in 2005. At the April 2007 Regular Board Meeting staff was directed to change the name of Rule 1978 from "Select Four" to "Pick Four" providing the public with a better understanding of the wager. The Board also directed staff to initiate a 45-day public comment period regarding the proposed amendment of Rule 1978.



## ANALYSIS

The proposed amendment of Rule 1978 eliminates the practice of substituting the off-time favorite for a horse scratched from any leg of the Select Four prior to the running of the first leg. The association may then allow patrons the option of selecting an alternate wagering interest. If an alternate wagering interest is not selected all wagers containing such horse(s) shall be subject to the refund/consolidation-pool requirements of the Select Four.

## RECOMMENDATION

No comments were received during the 45-day public comment period. Staff recommends the Board adopt the proposed amendment to Rule 1978 as presented.

(a) The ~~Select~~ Pick Four pari-mutuel pool is not a parlay and has no connection with or relation to any other pari-mutuel pool conducted by the association, nor to any win, place and show pool shown on the totalizator board, nor to the rules governing the distribution of such other pools.

(b) A valid ~~Select~~ Pick Four ticket shall be evidence of a binding contract between the holder of the ticket and the racing association, and the said ticket shall constitute an acceptance of ~~Select~~ Pick Four provisions and rules contained in ~~A~~article 18.

(c) A ~~Select~~ Pick Four may be given a distinctive name to be selected by the association conducting such races, such as "PICK 4", subject to the approval of the Board.

(d) The ~~Select~~ Pick Four pari-mutuel pool consists of amounts contributed for a selection for win only in each of four races designated by the association with the approval of the Board. Each person purchasing a ~~Select~~ Pick Four ticket shall designate the winning horse in each of the four races comprising the ~~Select~~ Pick Four.

(e) Those horses constituting an entry of coupled horses or those horses coupled to constitute the field in a race comprising the ~~Select~~ Pick Four shall race as a single wagering interest for the purpose of the ~~Select~~ Pick Four pari-mutuel pool calculations and payouts to the public. However, if any part of either an entry or the field racing as a single interest is a starter in a race, the entry or the field selection shall remain as the designated selection to win in that race for the ~~Select~~ Pick Four calculation, and the selection shall not be deemed a scratch.

(f) The net amount in the pari-mutuel pool subject to distribution among winning ticket holders shall be distributed among the holders of tickets which correctly designate the winners in all four races comprising the ~~Select~~ Pick Four.

(g) If a ticket in any race compromising the Pick Four designates a selection that was scratched, excused or determined by the Stewards to be a nonstarter in the race, the association may allow patrons the option of selecting an alternate wagering interest. The alternate betting interest will be substituted for the nonstarting selection for all purposes.

(h) If no ticket is sold combining the four winners of the ~~Select~~ Pick Four, the net amount in the pari-mutuel pool shall be distributed among the holders of tickets which include the winners of any three of the four races comprising the ~~Select~~ Pick Four.

(i) If no ticket is sold combining at least three winners of the ~~Select~~ Pick Four, the net amount in the pari-mutuel pool shall be distributed among holders of tickets which include the winner of any two races comprising the ~~Select~~ Pick Four.

(j) If no ticket is sold combining at least two winners of the ~~Select~~ Pick Four, the net amount in the pari-mutuel pool shall be distributed among holders of tickets which include the winner of any one race comprising the ~~Select~~ Pick Four.

(k) If no ticket is sold that would require distribution of the ~~Select~~ Pick Four pool to a winner under this rule, the association shall make a complete and full refund of the ~~Select~~ Pick Four pool.

(l) If for any reason one of the races comprising the ~~Select~~ Pick Four is cancelled, the net amount of the pari-mutuel pool shall be distributed as provided above in subsections (g), (h), (i) and (j).

(m) If for any reason two or more of the races comprising the ~~Select~~ Pick Four is cancelled, a full and complete refund will be made of the ~~Select~~ Pick Four pool.

~~(n) In the event a Select Four ticket designates a selection in any one or more of the races comprising the Select Four and that selection is scratched, excused or determined by the Stewards to be a non-starter in the race, the actual favorite, as evidenced by the amounts wagered in the win pool at the time of the start of the race, will be substituted for the non-starting selection for all purposes, including pool calculations and payouts. In the event a ticket in any race compromising the Pick Four does not designate an alternate wagering interest the following conditions will apply. If a wagering interest is scratched (which hereinafter includes being excused or declared a non-starter) from any leg of the Pick Four prior to the running of the first leg, all wagers containing such scratched wagering interest shall be refunded.~~

(o) If a wagering interest is scratched from the second leg after the start of the first leg, a consolation payout shall be computed for those wagers combining the winners of the first, third and fourth legs with such scratched horse(s) as follows: The amount represented by wagers on combinations involving horse(s) scratched from the second leg shall be deducted from the gross pool. The resulting pool, net of takeout, shall be distributed as a win pool among tickets combining the winners of the first, third and fourth legs with horse(s) scratched from the second leg.

(p) If a wagering interest is scratched from the third leg after the start of the second leg, a consolation payout shall be computed for those wagers combining the winners of the first, second and fourth legs with such scratched horse(s) as follows: The amount represented by wagers on combinations involving horse(s) scratched from the third leg shall be deducted from the gross pool. The resulting pool, net of takeout, shall be distributed as a win pool among tickets combining the winners of the first, second and fourth legs with horse(s) scratched from the third leg.

(q) If a wagering interest is scratched from the fourth leg after the start of the third leg, a consolation payout shall be computed for those wagers combining the winners of the first, second and third legs with such scratched horse(s) as follows: The amount represented by wagers on combinations involving horse(s) scratched from the fourth leg shall be deducted from the gross pool. The resulting pool, net of takeout, shall be distributed as a win pool among tickets combining the winners of the first, second and third legs with horse(s) scratched from the fourth leg.

(r) If wagering interests are scratched from the second, third and fourth legs after the start of the first leg, a consolation payout shall be computed for those wagers combining the winner of the first leg with horse(s) scratched from the second, third and fourth legs as follows: The amount wagered on the winner of the first leg combined with all other horse(s) scratched from the second, third and fourth legs shall be deducted from the gross pool. The resulting pool, net of takeout, shall be distributed as a win pool among tickets combining the winner of the first leg with horse(s) scratched from the second, third and fourth legs.

(s) ~~(n)~~ In the event of a dead heat for win between two or more horses in any ~~Select~~ Pick Four race, all such horses in the dead heat for win shall be considered as winning horses in the race for the purpose of calculating the pool.

(t) ~~(o)~~ No pari-mutuel ticket for the ~~Select~~ Pick Four pool shall be sold, exchanged or cancelled after the time of the closing of wagering in the first of the four races comprising the ~~Select~~ Pick Four, except for such refunds on ~~Select~~ Pick Four tickets as required by this regulation, and no person shall disclose the number of tickets sold in the ~~Select~~ Pick Four pool or the number or amount of tickets selecting winners of ~~Select~~ Pick Four races until such time as the Stewards have determined the last race comprising the ~~Select~~ Pick Four to be official. BACKGROUND

Business and Professions (B&P) Code Section 19440 provides that the Board shall have all powers necessary and proper for it to carry out the purposes of Chapter 4, B&P Code. Responsibilities of the Board shall include adopting rules and regulations for the protection of the public and the control of horse racing and pari-mutuel wagering. B&P Code Section 19703 states the Board, in cooperation with American Mule Association representatives, shall adopt rules governing, permitting, and regulating mule racing and wagering on the races under the pari-mutuel system. The American Mule Racing Association (AMRA), which is the recognized breed registry organization for mules, recently amended its Professional AMRA Racing Rules. Among its recommendations is a rule that allows mules to race without shoes. This is contrary to Board Rule 1853, Examination Required, which states that no horse shall be eligible to start in a race if it is found to be improperly shod. In addition, Rule 1402, Controlling Authority, states the rules of the Board supersede the conditions of a race meeting and govern mule racing. In April 2007 the AMRA requested an exemption to Rule 1853 so unshod mules could run in California. The AMRA stated shoeing mules was very difficult, and usually required that the mule be tranquilized. This was problematic; as if a mule needed shoeing immediately before a race the owner/trainer would face the possibility of a drug positive. The AMRA also claimed mules prefer to run "barefoot." The waiver was discussed at the April 2007 Regular Board Meeting. The AMRA representative stated on a case-by-case basis mules were currently excused from wearing shoes, but that had caused difficulties because the history of the practice was not always passed on to new stewards or horseshoe inspectors, and AMRA representatives often had to intervene when problems occurred. At the April 2007 Regular Board Meeting staff proposed the addition of Article 10.5, Mule Racing, Rule 1747, Mule Racing Rules and Rule 1748, Shoeing Mules. The Board directed staff to notice the proposed addition of Article 10.5, Rule 1747 and Rule 1748 for a 45-day public comment period. Staff was also directed to determine if Rule 1853 could be interpreted to allow mules to run unshod; thus eliminating the need for a waiver or a regulation. The Deputy Attorney General subsequently determined that Rule 1853 was applicable to mule racing, and as currently written did not easily suggest or necessarily support a conclusion that "no shoes" would equate to "properly shod."

At the May 2007 Regular Board Meeting a temporary waiver of Rule 1853 for mules was granted the AMRA until such time as an amendment or an addition to the Board's rules could be enacted.

## ANALYSIS

The Board currently promulgates Articles and regulations that are unique to harness and quarter horse racing; however, there are no regulations that address conditions specific to mule racing. While mule races may be run according to AMRA rules, those rules are superseded by the Board's regulations. The proposed addition of Article 10.5, Mule Racing, will add an Article to the Board's rules and regulations that exclusively addresses mules. The proposed addition of Rule 1747, Mule Racing Rules, will make it clear that mule races must still adhere to the Board's regulations, in general, but if there were a condition unique to mules, it would be placed under Article 10.5. The proposed addition of Rule 1748, Shoeing Mules, will allow mules to run unshod. If a mule does run "barefoot" it must be printed in the racing program, or announced over the public address system prior to the race in which such mule runs.

## RECOMMENDATION

No comments were received during the 45-day public comment period. Staff recommends the Board adopt Article 10.5 and Rule 1747 and Rule 1748 as presented.

## BACKGROUND

Business and Professions (B&P) Code Section 19440 provides that the Board shall have all powers necessary and proper to enable it to carry out fully and effectually the purposes of this chapter. Responsibilities of the Board shall include adopting rules and regulations for the protection of the public and the control of horse racing and pari-mutuel wagering. B&P Code Section 19580 states the Board shall adopt regulations to establish policies, guidelines, and penalties relating to equine medication to preserve and enhance the integrity of horse racing in California. Rule 1849, Nerving, states nerved horses may not be brought on the grounds of a racing association, nor entered in a race, or sold or offered for sale, except as provided under Article 15. Rule 1850, Posterior Digital Neurectomy, allows a horse that has been nerved or heel nerved to race provided the official veterinarian is satisfied the loss of sensation to the horse due to the posterior digital neurectomy will not endanger the safety of any horse or rider. Rule 1851, List of Nerved Horses, requires the racing secretary to maintain a list of nerved horses that are on the grounds of the association, and to make the list available for inspection by licensees participating in the meeting. Heal nerving was discussed at the March 2007 Medication Committee meeting. The Medication Committee determined it would recommend the amendment of Rule 1849 and the repeal Rule 1850 and Rule 1851. At the March 2007 Regular Board Meeting staff was directed to initiate a 45-day public comment period regarding the proposed amendment of Rule 1849 and the repeal of Rule 1850 and Rule 1851.

## ANALYSIS

The proposed amendment of Rule 1849 would ban “nerved” horses from the grounds of the racing association; from entry in a race; or from being sold or offered for sale on the grounds of a facility under the jurisdiction of the Board. It would also render Rules 1850 and 1851 superfluous and necessitate their repeal. A posterior digital neurectomy, commonly known as “nerving” or “heel nerving,” is a procedure where the posterior digital nerves of a horse’s hoof are transected with a scalpel, laser or other means to desensitize the posterior portion of the foot. In racehorses the procedure is primarily used for wing fractures of the coffin bone, navicular disease and other chronic conditions of the foot. A horse that has undergone a posterior digital neurectomy can feel its foot; it just cannot feel the heel of its foot. If the horse puts pressure on its foot it can feel where it is, or where it is running, and so it does not

cause the horse to lose stability. However, the procedure is not common among California racehorses due to improved diagnostics, medications and therapeutic shoeing. A recent informal survey of the Santa Anita race meeting revealed only two horses on the list of nerved horses (This list is a requirement of Rule 1851). Because the therapeutic value of posterior digital neurectomy is not vital to horse racing, and so few horses currently racing have undergone the procedure, the Board has determined that heel nerved horses should no longer be allowed to run in California.

A survey of several racing jurisdictions revealed that out of seven racing states, only Arizona prohibited nerved horses from running. States that allow nerved horses to run include: New York; Illinois; Indiana; Ohio; Kentucky and Texas.

During the 45-day public comment period staff received comment from Dr. Rick Arthur, CHRB Equine Medical Director. Dr. Arthur stated he was opposed to the proposed amendment of Rule 1849, and the repeal of Rule 1850 and Rule 1851. He said there was no veterinary medical or safety justification for the proposed action. Dr. Arthur also expressed concern with the ability to regulate a prohibition of nerved horses, as rules without enforcement schemes were nonsensical. Dr. Arthur commented that the principle behind Rule 1850 and Rule 1851 was full disclosure. Allowing nerved horses to run with the consent of the official veterinarian removes the incentive for owners and trainers to hide the true condition of a horse.

Dr. Dennis Meagher, professor emeritus of equine surgery at University of California Davis, and former CHRB Equine Medical Director, has also stated his opposition to the proposed regulatory action.

B&P Code Section 19481 provides that in performing its responsibilities, the Board shall establish safety standards governing equipment for horse and rider.

Board Rule 1685, Equipment Required, sets the weight; type of “popper;” and length of whips authorized for use by jockeys. Jockeys have recently indicated that an alternate, “kinder,” whip is available. If the Board determines it wishes to allow the use of alternate types of whips, it would necessitate the amendment of Rule 1685.

No bridle shall weigh more than two (2) pounds, nor shall any whip weigh more than one-half (1/2) pound. No whip shall be used unless it has affixed to the end a looped "popper" made of leather or other material approved by the stewards, not less than one and one-quarter (1 1/4) inches in width, and not over three (3) inches in length, and be "feathered" above the "popper" with not less than three (3) rows of "feathers" made of leather or other material approved by the stewards, each feather not less than one (1) inch in length. No whip shall exceed thirty-one (31) inches in length. All whips are subject to inspection and approval by the stewards.

BACKGROUND

A discussion regarding the status of racehorse retirement farms was held at the April 2007 Regular Board Meeting. The Board heard a presentation by Grace Belcuore of California Equine Retirement Foundation, Inc., as well as testimony from the industry at large. The consensus was that retired racehorses could be rehabilitated and used in a number of capacities, and that owners needed to become more involved. Additionally, a dedicated source of income was needed to finance and expand current voluntary efforts by concerned individuals and institutions. Representatives of Thoroughbred Owners of California (TOC) stated TOC had formed an Equine Retirement Committee to explore alternative sources of income for racehorse retirement. The issue was discussed again at the May 2007 Regular Board Meeting. TOC representatives presented a proposal to form a TOC managed California Retirement Management Account (CARMA) for retired thoroughbred horses. At the same time, the Board examined separate "Draft A" and "Draft B" proposals for an amendment to Rule 1467, Paymaster of Purses. It was determined that TOC would return to the Board with a more detailed proposal.

ANALYSIS

TOC has proposed to amend Board Rule 1467. The proposed amendment would direct the paymaster of purses to deduct 0.3 percent of the net purse earned by any thoroughbred horse at a thoroughbred racing association or fair meeting, which would be deposited into the California Retirement Management Account (CARMA). The CARMA, which is to be established by the TOC, is a charitable trust fund for the benefit of California Thoroughbred retirement/rehabilitation facilities. The proposed amendment defines "net purse earned" and provides a mechanism through which an owner may opt-out of the 0.3 percent contribution to CARMA. In addition, the amendment to Rule 1467 states the CARMA funds shall be distributed to qualified retirement/rehabilitation facilities as determined by the horsemen's organization. The TOC version of the proposed amendment (see Draft "A") would leave the decision regarding what is a "qualified" retirement/rehabilitation facility to the horseman's organization. The criteria for such organizations require that they must be not for profit, and exempt from federal or state income taxes. The Board's version ("B") of the proposed amendment requires that the Board also must approve such facilities. This requirement corresponds with criteria for organizations designated to receive charity race day proceeds under Board Rule 2047, Requests for Approval of Charity Fund Distribution. In the case of

charity race day proceeds, B&P Code Section 19556, Subsection (4), provides that the Board shall approve beneficiaries. The proposed amendment states the horsemen's organization must submit to the Board an annual audited financial statement regarding the CARMA within 90 days of the close of the horsemen's organization's fiscal year. This corresponds with Rule 2048, Horsemen's Organization Welfare Fund, which requires the horsemen's organization that maintains a welfare fund to submit a financial report within 90 days after the close of its fiscal year.

#### RECOMMENDATION

Two texts for the proposed amendment to Rule 1467 have been provided. Draft "A" is the text submitted by TOC. Draft "B" is a modified version of the TOC text.

## BACKGROUND

Business and Professions (B&P) Code Section 19420 provides that jurisdiction and supervision over meetings in California where horse races with wagering on their results are held or conducted, and over all persons or things having to do with the operation of such meetings is vested in the California Horse Racing Board (Board). B&P Code Section 19562 states the Board may prescribe rules, regulations and conditions under which all horse races with wagering on their results shall be conducted in California. In 1996 The California Veterinary Diagnostic Laboratory System (CVDLS) at the University of California, Davis, concluded a three-year study of shoeing and catastrophic injury in racehorses. The study compared the shoes of injured horses to those of uninjured horses to identify types of shoes associated with increased risk of injury. The toe grab was the type of traction device found on 90% of the injured horses and 80% of uninjured horses while rim shoes were found on 12% of injured horses and 30% of uninjured horses. The conclusion was that there appeared to be an association between toe grabs and increased risk of catastrophic injury in thoroughbred racehorses. The higher the toe grabs – the greater the risk. The three-year study of shoeing and catastrophic injury released in 1996 was not considered conclusive, so a second study was initiated in late 1999. The study was not complete when the Board heard the issue of toe grabs at its January 2000 Regular Board Meeting. The result of the discussion was a third CVDLS study that would record the type of shoes worn during competition of all thoroughbred racehorses in California for the year 2000. The information would be correlated with injuries sustained to determine patterns related to shoe type. In addition, the CVDLS would collect data from foreign jurisdictions that race on dirt without toe grabs. Subsequent to its initiation, the study was extended for a second year, to be completed in the spring of 2002.

In February 2006 the Board added Rule 1690.1, Toe Grabs Prohibited, which prohibited the use of toe grabs over four millimeters in height on the front shoes of thoroughbreds while racing. However, the implementation of the regulation was delayed. At the February 2007 Regular Board Meeting the Board determined it would enforce the regulation, and that quarter horses should be added to the provisions of Rule 1690.1.

The Board heard the proposal to amend Rule 1690.1 at its June 2007 Regular Meeting. After receiving testimony from interested parties the hearing was deferred until additional comment could be received from the quarter horse industry. In July 2007 the Pacific Coast Quarter Horse Racing Association requested the proposed amendment to Rule 1690.1 be deferred for up to six months to allow for a completion of a study relative to the use of toe grabs greater than four millimeters on the front shoes of quarter horses while racing.


