DISCUSSION AND ACTION BY THE BOARD ON THE APPLICATION FOR LICENSE TO CONDUCT A HORSE RACING MEETING OF THE FRESNO DISTRICT FAIR (F) AT FRESNO, COMMENCING OCTOBER 1 THROUGH OCTOBER 13, 2003, INCLUSIVE.

Jacqueline Wagner, CHRB staff, said the Fresno District Fair (FDF) proposed to run from October 1, through October 13, 2003, one day more than in 2002. The first post time would be 12:37 p.m. Saturday, 12:45 p.m. Sunday, and 1:37 p.m. Mondays, Wednesdays and Thursdays. Ms. Wagner stated staff recommended the Board adopt the application as presented. Chairman Licht said he questioned whether Racing Services should continue to receive the signal. T. Pat Stubbs of Del Mar Thoroughbred Club (DMTC) said Racing Services' handle went down dramatically as its customers turned to other sites. He stated Racing Services was current in its payments to DMTC. Chairman Licht said if Racing Services was current, there was no reason to cut off the signal. Vice-Chairman Harris **motioned** to approve the application for license to conduct a horse racing meeting of FDF. Commissioner Moretti **seconded** the motion, which was **unanimously carried**.

DISCUSSION AND ACTION BY THE BOARD ON THE ALLOCATION OF ONE ADDITIONAL RACE DAY, SEPTEMBER 28, 2003, TO SANTA ANITA RACE TRACK.

John Reagan, CHRB staff, said the additional race day was requested to allow the running of preparation races for Breeders' Cup at Oak Tree Racing Association (OTRA). Mr. Reagan stated after negotiations the industry agreed on one additional day of racing, September 28, 2003. The additional day required legislative action, which was accomplished through Assembly Bill 1128, Chapter 8 of the Statutes of 2003. Mr. Reagan said staff recommend the Board approve the additional day and allocate it to OTRA. Commissioner Landsburg asked if plans had been made for the types of races and purses to be offered on the additional race day. Sherwood Chillingworth of OTRA said four graded stakes would be offered. He added two of the races would be nationally televised, and OTRA was planning several promotional items it hoped would generate large crowds. Chairman Licht asked if there would be any labor problems. Mr. Chillingworth said OTRA was bringing in more self-service wagering terminals and was training upwards of 125 additional pari-mutuel clerks. Vice-Chairman Harris asked how the overlap with Fairplex Park Pomona (FPP) was resolved. Mr. Chillingworth said OTRA guaranteed FPP would receive what it earned in 2002. However, if FPP's first 16 days were down, the OTRA guarantee would be reduced by the same percentage. Commissioner Granzella **motioned** to approve the allocation of one additional race day to OTRA. Commissioner Landsburg **seconded** the motion, which was **unanimously carried**.

DISCUSSION AND ACTION BY THE BOARD ON THE APPLICATION FOR LICENSE TO CONDUCT A HORSE RACING MEETING OF THE OAK TREE RACING ASSOCIATION (T), AT SANTA ANITA, COMMENCING SEPTEMBER 28 THROUGH NOVEMBER 9, 2003, INCLUSIVE.

Jacqueline Wagner, CHRB staff, said Oak Tree Racing Association (OTRA) proposed to race 32 days, six more days than in 2002, for a total of 273 races. The first post time would be 1:00 p.m. weekdays, 12:30 p.m. weekends and holidays, and 9:40 a.m. on Breeders' Cup Day. The wagering program would use CHRB regulations. Ms. Wagner said the fire clearance was the only item missing from the application. She stated staff recommended approval of the application conditioned on receipt of the item noted as missing. Chairman Licht asked if everything indicated in the application would apply to the Breeders' Cup event. Ms. Wagner said it would. Vice-Chairman Harris said the availability of pari-mutuel clerks in California for Breeders' Cup could be an issue. Mr. Chillingworth said OTRA knew it could be a concern. He stated OTRA sent application to potential clerks in other states and in Northern California, and had received approximately 180 responses. A training session would be held beginning September 15, 2003. The clerks would be trained not only for Breeders' Cup Day, but also for the September 28 overlap. Chairman Licht suggested the newer pari-mutuel clerks staff the win-place-and show, and voucher windows as inexperienced clerks might not be as knowledgeable regarding the more exotic wagers. Mr. Chillingworth said OTRA would place experienced pari-mutuel clerks at the more frequently used windows. He stated OTRA would also experiment with having windows with a minimum wager of \$500 so fans who made larger wagers would not be shut out. Mr. Chillingworth added he thought tracks, in general, needed to look at windows for fans who made large wagers. He commented he noticed long lines at Del Mar's window. Commissioner Landsburg asked if there would be any handicapping seminars for the regular on-track fans. Mr. Chillingworth said there would be two Breeders' Cup handicapping seminars for

out-of-town fans. Commissioner Sperry **motioned** to approve the application for license to conduct a horse racing meeting of OTRA. Commissioner Landsburg **seconded** the motion, which was **unanimously carried**.

DISCUSSION AND ACTION BY THE BOARD ON THE 2004 RACE DATES.

Chairman Licht said the Race Dates Committee met twice to discuss the 2004 race dates. He stated the dates were in three segments: the Southern California race dates, the Northern California race dates, and the quarter horse/harness race dates. Chairman Licht said the committee recommended the Southern California race dates, as proposed by the industry, be approved. John Reagan, CHRB staff, said the proposed 2004 race dates for Southern California were: Los Angeles Turf Club at Santa Anita Park Race Track from December 26, 2003, through April 18, 2004, for 84 days; Churchill Downs California Operating Company at Hollywood Park (HP) from April 21, 2004, through July 18, 2004, for 65 days; Del Mar Thoroughbred Club at Del Mar Race Track from July 21, 2004, through September 8, 2004, for 43 days; Los Angeles County Fair at Fairplex Park Pomona from September 10, 2004, through September 26, 2004, for 17 days; Oak Tree Racing Association at Santa Anita Park Race Track from September 29, 2004, through October 31, 2004, for 26 days, with an additional day on September 28, 2004; Churchill Downs California Fall Operating Company at HP from November 3, 2004, through December 20, 2004, for 36 days. John Van de Kamp of Thoroughbred Owners of California (TOC) said for the past several years TOC requested a longer Christmas break. He stated his organization believed a longer break was good for the industry and made the opening of the meeting at Santa Anita Race Course more special. Mr. Van de Kamp said a couple years ago the industry had a good experience when there was a longer break.. He stated the Board had made a practice of

eliminating Monday closings, and he had not heard many complaints from the tracks. Mr. Van de Kamp said in 2004 the natural closing day for the meeting at HP would be Sunday, December 19. Closing on Sunday would give the industry an entire week's break. Mr. Van de Kamp said TOC objected to the Race Dates Committee's decision to revert back to a Monday closing. Chairman Licht commented every horseman would still have to work on Monday, December 20. Mr. Van de Kamp said the last time there was a week's Christmas break employees were able to take that afternoon off. He stated it was a much different situation than would occur on a normal race day. Ed Halpern of California Thoroughbred Trainers (CTT) said his organization agreed with TOC's position. Chairman Licht asked if employees would still have to work on the Monday. Mr. Halpern said clients would be billed and employees would have to work because horses had to eat and be exercised. However, when there was no racing, the pace was more relaxed and staff could be reduced. In the larger view, Mr. Halpern said it was the overall pressure to keep horses racing that did not benefit the industry. He stated it lead to horses breaking down, and ultimately shorter fields. Vice-Chairman Harris said probably three to four hundred thousand dollars in incremental purse money would probably be generated by racing. He stated he would not like to see the parties walk away from the potential income. Mr. Halpern said if there was no racing, no money would be made, however one would earn even less money if one's horses broke down. He stated the committee did allow for a five-day break, but the CTT believed a longer break would be better. Ron Liccardo of the Pari-Mutuel Employees' Guild (Guild) said a longer break would have an adverse effect on Guild members as well as other front side employees. Sherwood Chillingworth of Oak Tree Racing Association said the Thalheimer report would be issued in September. He stated the report could provide insight regarding the number of racing days in California and should be reviewed before any decisions

were made. He suggested the Board agree to the five-day break for 2004, then look at 2005 race dates after it had more data and empirical evidence. Rick Baedeker of HP said there was not much of a difference between a five or a six-day break. He stated HP intended to heavily promote the last day of its meeting and should be able to run a good field. If the last day fell short, there would be empirical data the Board could use in considering 2005 race dates. Lee Hall of Local 1877 said his organization was in favor of a five-day break. Commissioner Moretti **motioned** to adopt the 2004 Southern California race dates as proposed by the Race Dates Committee. Vice-Chairman Harris **seconded** the motion, which was **unanimously carried**.

Mr. Reagan said the proposed 2004 race dates for Northern California were: Pacific Racing Association at Golden Gate Fields Race Track from December 26, 2003, through April 4, 2004, for 74 days; Bay Meadows Operating Company (BMOC) at Bay Meadows Race Track from April 7, 2004, through June 20, 2004, for 55 days; Bay Meadows Operating Company at Bay Meadows Race Track from September 3, 2004, through November 7, 2004, for 49 days; Pacific Racing Association at Golden Gate Fields from November 10, 2004, through December 20, 2004, for 31 days. Mr. Reagan said the proposed 2004 race dates for the fairs were: San Joaquin Fair from June 16, 2004, through June 27, 2004 for ten days; Alameda County Fair (ACF) from June 30, 2004, through July 11, 2004, for 11 days; Solano County Fair from July 14, 2004, through July 25, 2004, for ten days; Sonoma County Fair from July 28, 2004, through August 9, 2004, for 12 days; San Mateo County Fair from August 11, 2004, through August 23, 2004, for 12 days; Humboldt County Fair from August 12, 2004, through August 22, 2004, for ten days; California Exposition and State Fair (CESF) from August 25, 2004, through September 6, 2004, for 12 days; Big Fresno Fair from October 6, 2004, through October 17, 2004 for 11 days. Chris

Korby of the California Authority of Racing Fairs (CARF) said ACF wished to race on Wednesday, July 7, 2003. He stated ACF would be able to take the signal from out-of-state and broadcast its signal to Southern California. ACF's signal would be sent free to Southern California, so it would generate incremental purses and commissions without running races. Mr. Van de Kamp said in the past the Board promoted concurrent racing. He stated July 7 was not a concurrent race day and would not be as strong. Mr. Van de Kamp said he recommended HP run concurrently with ACF, but its management concluded it did not wish to run a six-day week at that time. He recalled that ACF had an overpayment in 2003, which was mostly due to running on the same date. He stated he believed the Board was breaking its tradition of promoting concurrent racing. The result was management problems. When a track experienced overpayments, such as ACF's in 2003, the supplemental purse fund, which helped pay for some of the vanning and starter fees in Northern California, was affected. Mr. Baedeker said he would ordinarily appreciate a six-day week, however, HP would close on the July 4 weekend with a guaranteed Pick-6. He stated there would be full fields for the Pick-6. Filling the Pick-6 races, coupled with the approach of the Del Mar meeting, would be a struggle. Adding a sixth day to the week would impact HP's ability to put horses on the track for the balance of its meeting. Charles Dougherty of California Thoroughbred Trainers (CTT) said the general feeling among trainers was that if there was no racing in the south, it would be a weak day for handle. Commissioner Landsburg said he found the TOC position regarding HP unusual. If HP was closed on December 20, it would leave Bay Meadows open without concurrent racing in the south. Mr. Van de Kamp said TOC believed there should be concurrency. Mr. Korby said part of the reason for ACF's 2003 overpayment was its agreement with TOC to revise its purse schedule. The revision resulted in approximately half the overpayment. Mr. Korby added ACF

received no supplemental purse money, and the overpayment was paid out of its own account. Jack Liebau said overpayments were carried over to the next year. The ACF overpayment would come out of the 2004 purses, just as an underpayment would be added to the purses. Mr. Korby said CARF wanted to be on record as asking the Board to consider reducing or eliminating overlapping dates. Chairman Licht asked staff to read the proposed overlap dates and indicate which associations were overlapping. Mr. Reagan said from June 16 through June 20, 2004, BMOC would overlap with the San Joaquin Fair. And from September 3 through September 6, 2004, BMOC would overlap with CESF. Chairman Licht said the Race Dates Committee looked at four issues regarding overlap. The committee looked at the labor pool, field sizes, on-track attendance, income and how it was allocated between the overlapping tracks, and concluded income was the major issue overlap impacted. Commissioner Landsburg **motioned** to approve the Northern Thoroughbred and fair schedule as proposed. Commissioner Moretti **seconded** the motion, which was **unanimously carried**.

Mr. Reagan said the proposed race dates for quarter horses were: Los Alamitos Quarter Horse Racing Association (LAQHRA) at Los Alamitos Race Course from December 26, 2003, through December 19, 2004, for 203 days. The proposed race dates for standardbred horses were: Capitol Racing Association at Cal Expo from December 26, 2003, through July 31, 2004, for 133 days. Capitol Racing at San Joaquin Fair (SJF) from August 6, 2004, through October 2, 2004, for 26 days. Capitol Racing at Cal Expo from October 7, 2004, through December 24, 2004, for 45 days. Chairman Licht said the only issue was determining if Capitol Racing should receive the dates at SJF. He stated the estimated operational cost for the meeting was \$150,000 – or \$5,000 per day. Chairman Licht said the license fee would not off-set the cost of the meeting as

it was paid into the General Fund. Vice-Chairman Harris said even if the harness license fees could be used, he believed they were so low they would not generate enough revenue to cover costs. Alan Horowitz of CRA said his organization requested the Board approve the proposed dates for harness racing at Cal Expo and quarter horse racing at LAQHRA, and put over the dates for the SJF harness meeting. Commissioner Bianco motioned to approve the harness racing dates at Cal Expo and the quarter horse racing dates at LAQHRA as proposed. Commissioner Landsburg **seconded** the motion, which was **unanimously carried**.

DISCUSSION AND ACTION BY THE BOARD ON THE RESOLUTION TO PARTICIPATE IN THE NATIONAL LICENSING COMPACT A.K.A. INTERSTATE COMPACT ON LICENSURE OF PARTICIPANTS IN LIVE RACING WITH PARI-MUTUEL WAGERING.

Jacqueline Wagner, CHRB staff, said the Association of Racing Commissioners International (RCI) National Licensing Compact (NLC) simplified the licensing process for persons who wished to be licensed in more than one racing jurisdiction. Ms. Wagner stated the NLC issued licenses to qualified owners, trainers and jockeys, and was recognized in 22 racing jurisdictions. She added California was a participating member of the NLC. Ms. Wagner said the Federal Bureau of Investigation ruled it would only share fingerprint information with official NLC members. To continue participating in the compact, California needed to change its affiliation by adopting the proposed resolution to become an official member of the NLC. Ms. Wagner stated staff recommended the Board adopt the resolution to enter into the NLC. Chairman Licht asked if the National Thoroughbred Racing Association (NTRA) had a position on the NLC, and if the compact would affect the state's revenues. Executive Director Roy Wood, Jr. said the RCI and NTRA supported the licensing compact. The state would continue to collect its licensing revenue as the legislation enabling California to enter into the NLC required that revenue remain

at the same level. Commissioner Granzella **motioned** to adopt the resolution to participate in the NLC. Commissioner Moretti **seconded** the motion, which was **unanimously carried**.

**REPORT BY THE CALIFORNIA ANIMAL HEALTH AND FOOD SAFETY LABORATORY
ON THE POST MORTEM PROGRAM.**

Dr. Alan Ardans of the California Animal Health and Food Safety Laboratory Systems gave a slide presentation and reviewed the current activities of the equine post mortem program. Chairman Licht asked if any horse that died at any Race Track in California was sent for a post mortem examination. Dr. Ardans said every horse that died on a facility under the jurisdiction of the Board was subject to a post mortem examination. The racing associations paid for the transportation of the dead horses to the laboratory, and the Board and the laboratory paid for the necropsy. Dr. Sue Stover gave a slide presentation and reviewed the accomplishments of the post mortem program.

**DISCUSSION AND ACTION BY THE BOARD ON A REPORT BY THE CALIFORNIA
MARKETING COMMITTEE.**

Jack Liebau of the California Marketing Committee (CMC) said planning for the 2004 CMC marketing plan would commence in October or November, 2003. He stated the CMC would welcome input from all segments of the industry. Vice-Chairman Harris asked if the CMC enabling legislation had a sunset, and if so, did the committee plan to extend the program. Mr. Liebau said a decision on extending the program would be made in the near future. Commissioner Landsburg said marketing was not a science, however, there needed to be goals. He stated it seemed the industry's goal was to try to invigorate its fan base to bring back the somewhat lapsed fans, and to focus on new fans. He stated the three generators of any report

would deal with how much energy, effort and success the committee put in those areas. Mr. Liebau said he agreed with Commissioner Landsburg. He stated the CMC commissioned a study by a national advertising agency and used their recommendations. There were several things being tried to attract new fans. One item was "fair trials" wherein the fairs were seen as a venue for attracting new fans. Another method of attracting new fans was "supercharging" – were through marketing, the industry made its bigger days bigger at the track. The underlying assumption behind supercharging was it would be easier to generate new fans at on-track events than through off-track facilities. Mr. Liebau said the CMC also practiced "awareness." That meant making lapsed fans aware of racing in the hope they would be stimulated to visit an off-track facility. Mr. Liebau stated the CMC decided it needed a data base as it felt direct marketing would be more effective than print or broadcast/radio advertising. The database became the Golden State Rewards Program. Vice-Chairman Harris asked if there had been any independent studies to determine the effectiveness of the CMC. Mr. Liebau said there had been no studies. He stated if one looked at the decline in on-track attendance, one might conclude the marketing had not worked. However, due to the factors involved, and the number of alternatives available to the wagering public, it was difficult to tell. Vice-Chairman Harris said other industries looked at their marketing to attempt to understand if it was working. He stated it bothered him that there did not seem to be any assessment of the CMC's programs. Mr. Liebau said the tracks routinely evaluated their big-day advertising and compared it with a day that was not a big-day to determine if money expended in marketing resulted in incremental revenue over the promotional expenses. He stated the numbers spoke for themselves in regards to the Golden State Rewards Program. Under the program, the number of fans signing up, lapsed users, and other factors could be tracked. Commissioner Landsburg said he had been talking to people

outside racing who were familiar with marketing. He stated one of the comments from those in the general sports industry was the public recognized racing when special events occurred, but on normal race days, the industry had no personality. Commissioner Landsburg said he believed that was one of the issues the CMC might begin to look at in 2004.

DISCUSSION BY THE BOARD ON WAYS TO IMPROVE THE LICENSE APPLICATION AND TO REVIEW THE CURRENT REQUIREMENTS NECESSARY FOR CONDUCTING A RACE MEET.

Chairman Licht said Vice-Chairman Harris and Commissioner Landsburg were reviewing the license application to determine what could be done to improve the industry by holding licensees to a higher standard. Commissioner Landsburg said the purpose of the review was to examine what the industry and the Board could do as a condition of licensing that would foster improvements in the sport. He stated the committee discussed requiring associations to offer their signal to any licensed/approved advance deposit wagering (ADW) entity. Commissioner Landsburg said with the diminishing handle it was difficult to conclude ADW was incremental in any way. He stated the question was: were some ADW contracts keeping some fans from making wagers due to their exclusivity, and would it be a good idea to require licensees to make their signal available to any licensed/approved ADW provider? Commissioner Landsburg stated it was a radical step, but the industry did not seem to be progressing with its current situation. Vice-Chairman Harris said the committee also looked at backstretch security. He stated the committee would like to see those associations running more than 30-days a year have, in addition to their current security apparatus, a video surveillance system capable of long-term recording. He stated the committee would like to see monitoring of entrances and exits to the receiving barn, shed rows, and essentially all movement within those areas. Vice-Chairman

Harris said the industry needed to utilize up-to-date technology, such as video cameras, unless they wished to increase the number of security personnel. He stated he believed video cameras would enhance backstretch security. Vice-Chairman Harris said the associations also needed to provide sufficient pan shots to show all parts of a race so there would be no alleged blind spots, and provide direct head-on and rear shots of both the back and front stretch. The lack of such shots, including on turf courses, created problems for stewards in analyzing inquiries and dispelling controversy among fans. Vice-Chairman Harris said the tote boards needed to be updated to have sufficient space to list separately each wagering interest. Chairman Licht said the committee should hold a noticed public meeting in the near future to discuss all the issues it had brought forth.

John Reagan, CHRB staff, said Churchill Downs California Operating Company (CDCOC) saw large increases in advance deposit wagering (ADW), with decreases in on-track and satellite wager. He added when taken as a whole, the ADW figures tended to mask the decrease in other types of wagering. Mr. Reagan said the Solano County Fair (SCF) had a very good meeting. He stated, however, SCF went from an 11-day meeting in 2002 to a 10-day meeting in 2003, so staff expected to see an increase in the outcome. Mr. Reagan said the ADW handle was being included in the end of meeting reports. ADW represented approximately 10 percent of the handle, but was not causing increases in the overall handle. Chairman Licht said the CDCOC meeting had a lot of nice highlights, but also an inordinate amount of tote board and timer problems. He stated he hoped such problems would be corrected by the winter meeting. Rick

Baedeker of CDCOC agreed there were a number of problems with the tote board. He stated the industry had purchased new LED boards to supplement the tote boards. He stated the associations would be able to show up to twenty horses if needed. Mr. Baedeker said the boards would move from track to track without risk.

REPORT FROM THE PARI-MUTUEL OPERATIONS COMMITTEE.

Commissioner Landsburg said the Committee met on July 25, 2003. The committee heard a preliminary report on offshore wagering sites and venues in the continental United States. Commissioner Landsburg said a full report would be issued in the fall of 2003 by Thoroughbred Owners of California. He stated the nature of the report was, in part, confidential, and was subject to ongoing investigations. Commissioner Landsburg said the Committee revisited the proposed addition of Rule 1979.5, Beat the Odds. Based on support from racing associations, the Committee agreed to place the proposal back into consideration.

REPORT FROM THE RACE DATES COMMITTEE

Chairman Licht said the Committee made its report during the discussion of item 4 of the agenda.

MINUTES

Commissioner Landsburg said the last four lines attributed to him on page 1 of the minutes of July 24, 2003, were actually spoken by Vice-Chairman Harris. Chairman Licht asked for approval of the minutes of the Regular Board Meeting of July 24, 2003. Commissioner Sperry **motioned** to approve the minutes as amended by Commissioner Landsburg. Commissioner Landsburg **seconded** the motion, which was **unanimously carried**.

DISCUSSION AND ACTION BY THE BOARD ON THE APPLICATION FOR LICENSE TO CONDUCT A HORSE RACING MEETING OF THE PACIFIC RACING ASSOCIATION (T) AT GOLDEN GATE FIELDS, COMMENCING NOVEMBER 5, 2003 THROUGH APRIL 4, 2004, INCLUSIVE.

Roy Minami, CHRB staff, said Pacific Racing Association (PRA) proposed to run 109 days, five more than in 2003. The first post time would be 12:45 p.m. daily, with an 11:00 a.m. post time on November 27. Mr. Minami stated the horsemen's agreement, the fire clearance, and worker's compensation insurance were missing from the application. He said staff recommended approval of the application conditioned upon receipt of the items the analysis noted were missing from the application. Jack Leibau of PRA said the horsemen's agreement

was completed except for the stakes schedule. He stated discussion regarding the stakes schedule was ongoing and an agreement should be reached within a week. Chairman Licht asked if PRA wished to continue its agreement with Racing Services. Mr. Liebau said Racing Services was listed on the application in the event PRA wished to conduct business with the organization. Vice-Chairman Harris asked if the out-of-state hubs were working on transmitting wagering information instantaneously. Mr. Liebau said he believed the timeliness of transmission of such data was a totalizator issue. He stated all of the tracks thought the system could be improved, and were pressuring Autotote in that regard. Vice-Chairman Harris said it was clear some wagering information was being transmitted in a timely manner, while some was not. He stated some of the venues needed to be made aware of the problems they were causing California. Mr. Liebau said he agreed, but there were also regulatory problems in some states. Chairman Licht stated the Board would be receiving a report from Thoroughbred Owners of California and others in the industry regarding out-of-state hubs and overseas venues. Commissioner Bianco asked about the equine hospital at Golden Gate Fields. Mr. Liebau said the hospital building was finished and was being equipped by the foundation that was taking over its operation. Commissioner Moretti **motioned** to approve the application for license to conduct a horse racing meeting of PRA conditioned on receipt of the horsemen's agreement not later than September 25, 2003. Commissioner Bianco **seconded** the motion, which was **unanimously carried**.

DISCUSSION AND ACTION BY THE BOARD ON THE APPLICATION FOR LICENSE TO CONDUCT A HORSE RACING MEETING OF THE CHURCHILL DOWNS CALIFORNIA FALL OPERATING COMPANY (T), AT HOLLYWOOD PARK, COMMENCING NOVEMBER 11 THROUGH DECEMBER 21, 2003, INCLUSIVE.

Roy Minami, CHRB staff, said Churchill Downs California Fall Operating Company (CDCFOC) proposed to race thirty days, five days less than in 2002. The first post would be 12:30 p.m. daily and 11:00 a.m. on November 27. Mr. Minami said the application was missing the horsemen's agreement, fire clearance and stakes schedule. He stated staff recommended approval of the application conditioned on receipt of the items the analysis noted were missing. Chairman Licht asked if CDCFOC would continue its relationship with Racing Services. Eual Wyatt of CDCFOC said Racing Services was listed on the application because it wished to have the flexibility to send the signal to Racing Services if it wished. Commissioner Landsburg asked when the horsemen's agreement would be ready. Mr. Wyatt said some consensual language changes were made to the agreement, and as soon as the document was ready it would be signed. He stated the agreement would be ready within five business days. Commissioner Moretti **motioned** to approve the application for license to conduct a horse racing meeting of CDCFOC contingent on receipt of the horsemen's agreement not later than September 25, 2003. Commissioner Landsburg **seconded** the motion, which was **unanimously carried**.

DISCUSSION AND ACTION BY THE BOARD ON THE APPROVAL OF THE NOMINATION OF TWO DIRECTORS TO THE GOVERNING BOARD OF THE CALIFORNIA THOROUGHBRED HORSEMAN'S FOUNDATION, PURSUANT TO CHRB RULE 2049(A).

John Reagan, CHRB staff, said the California Thoroughbred Horsemen's Foundation (CTHF), the welfare organization for thoroughbred racing, has re-nominated two of its board members: Noble Threewitt and Mike Ames. Mr. Reagan said staff recommended approval of the nominations. Commissioner Sperry **motioned** to approve the nominations. Commissioner Bianco **seconded** the motion, which was **unanimously carried**.

DISCUSSION AND ACTION BY THE BOARD ON THE REQUEST OF THE OAK TREE RACING ASSOCIATION TO SUSPEND CHRB RULE 1606 - COUPLING OF HORSES, FOR THE FOUR OAK TREE RACES TO BE RUN AT SANTA ANITA ON BREEDERS' CUP DAY. THE BOARD HAS GIVEN PREVIOUS APPROVAL TO RUN THE BREEDERS' CUP UNCOUPLED.

John Reagan, CHRB staff, said the original request to waive Rule 1606, Coupling of Horses, was for Breeders' Cup races on October 25, 2003. He stated the additional four races to be run by Oak Tree Racing Association (OTRA) were not covered by the request. Mr. Reagan said there were certain racing jurisdictions whose tote systems would not accommodate mixing the rules. Such jurisdictions would drop the OTRA races in favor of the Breeders' Cup events. To achieve a consistent program, OTRA requested its races also be run with Board Rule 1606 waived. Vice-Chairman Harris asked how waiving the rule would work if there was an interference problem with an uncoupled horse with the same ownership. Would it reflect on the placing of the other horse? Mr. Reagan said that would be a matter for the stewards to decide. Vice-Chairman Harris said he did not understand what the out-of-state problem was as the wagers were only being placed on numbers. Mr. Reagan said there were a couple of out-

of-state locations that, once they set the parameters for the day, anything different would cause the races to be thrown out. Sherwood Chillingworth of OTRA said OTRA wanted to run a guaranteed pick-four during the last four races of the program. He stated OTRA wished to have large fields to encourage wagering, and one way to achieve the goal was with uncoupled entries. He stated he did not know why some jurisdictions were technically unable to handle eight races under one set of rules and four under another. Commissioner Sperry **motioned** to approve the request of OTRA to waive Rule 1606 for the four OTRA races to be run at Santa Anita on Breeders' Cup Day. Commissioner Bianco **seconded** the motion, which was **carried** with Commissioner Landsburg **abstaining**.

DISCUSSION AND ACTION BY THE BOARD ON THE REQUEST BY THE THOROUGHBRED OWNERS OF CALIFORNIA TO SUSPEND CHRB RULE 2040(A) – HORSEMEN'S ORGANIZATIONS FOR OWNERS OR TRAINERS, TO ALLOW TWO TOC DIRECTORS TO SERVE CONCURRENTLY ON THE BOARD OF A RACING ASSOCIATION.

John Reagan, CHRB staff, said two Thoroughbred Owners of California (TOC) board members were asked to join the Oak Tree Racing Association (OTRA) board. He stated such a move was contrary to subsection (a) of Board Rule 2040, Horsemen's Organizations for Owners or Trainers. Mr. Reagan said TOC was requesting a waiver of the rule. John Van de Kamp of TOC said at the September 5, 2003, TOC board meeting the acceptance of Robert Lewis and Trudy McCaffry to positions on the OTRA board was discussed. Mr. Van de Kamp said the TOC board was aware that CHRB Rule 2040(a) provided one could not be a TOC board member as well as member of OTRA's board. However, he stated Mr. Lewis and Ms. McCaffry were held in high esteem by the industry and, and after much discussion, the

TOC board voted unanimously to request a waiver under CHRB Rule 1406, Suspension of Rule. Mr. Van de Kamp said Mr. Lewis and Ms. McCaffry pledged to refrain from voting on issues that related to TOC while on OTRA's board, and OTRA while on TOC's board. Chairman Licht said he had three issues with regards to the request: 1). What is best for the industry? 2). Is it best to have Mr. Lewis and Ms. McCaffry on both boards? How much is diversity of value to the industry? and 3). The issue of conflict of interest. Mr. Van de Kamp in addressing the issue of conflict of interest, stated he did not think the issue would surface often. Regarding diversity – Mr. Van de Kamp said both individuals possessed a great deal of experience in the industry. He stated few had as much experience and he thought having Mr. Lewis and Ms. McCaffry serve on both boards would benefit the industry. The TOC board was composed of 15 members and diversity was encouraged. Mr. Van de Kamp said OTRA did a lot of charity work. Both individuals had a significant charity background, which was something that would not conflict with TOC's mission. The possibility of conflict of interest would surface with contracts between the two entities. In both instances, Mr. Van de Kamp said Mr. Lewis and Ms. McCaffry would recuse themselves from discussion and voting. Ed Friendly, a horse owner and ex-chairman and president of TOC, said he shared Mr. Van de Kamp's opinion of Mr. Lewis and Ms. McCaffry. He stated they were upstanding individuals who made great contributions to horse racing. Mr. Friendly stated, however, he did not believe Mr. Lewis and Ms. McCaffry's standing in the industry was the issue. He said he believed there was a serious issue of conflict of interest, and waiving Rule 2040 would set an improper precedent. Mr. Friendly stated though tracks and owners had the same interests, they were vying for the same dollars. He said by law, the only money owners received from

horse racing was from the handle. The wagering dollar was the only way purse money could be delivered. Mr. Friendly said owners could not boycott, strike, or negotiate for any form of compensation from programs, concessions, parking or sources. Mr. Friendly stated that was the conflict; owners wanted part of the tracks income, and the precedent of letting an owner serve on TOC's board and on a racing association's board was contrary to the reason TOC was founded. Sherwood Chillingworth of OTRA said he had been a director of OTRA for over 14 years. He said OTRA and TOC had always enjoyed an amicable relationship as they had common interests. Commissioner Landsburg asked if OTRA was expanding its board, or was filling vacancies. Mr. Chillingworth said OTRA's bylaws provided for a board of seven persons. The current board was composed of five persons, so OTRA was expanding its board from five to a full seven persons. Chairman Licht asked about diversity; the idea of having different people with different ideas. Mr. Chillingworth said Mr. Lewis and Ms. McCaffry had wide-ranging experience within the industry, and OTRA believed it could profit from their advice and knowledge. In addition, both persons had a history of being very involved. Mr. Chillingworth said there was always the possibility of getting board members who did not contribute. Commissioner Landsburg said he served on the TOC board with Mr. Lewis for a number of years, and no one had greater respect for his judgement and ability. Commissioner Landsburg reiterated his admiration for Mr. Lewis, but said if the Board continued to waive rules on behalf of those it admired, it would not be serving horse racing, the State, or itself. Commissioner Landsburg said he held Mr. Lewis and Mr. Van de Kamp in goodwill, but he could see no rational reason except "let's be nice guys" to waive the rule. He stated that was not what the Board was about, and he would urge the Board not to approve the request. Vice-

Chairman Harris said he agreed with Commissioner Landsburg. He stated there was no dispute regarding the credentials or the outstanding nature of those involved, but racing needed strong advocates from all segments of the industry. It was difficult to be an advocate when there was a conflict, or one could not participate in a discussion or had to abstain from voting. Vice-Chairman Harris asked if the rule had been researched. Executive Director Roy Wood, Jr. said staff researched the rule and found it had been in existence for quite some time, and was in effect when Thoroughbred Horsemen's Benevolent and Protective Association was active. The rule was amended to address the formation of TOC. Robert Lewis, a horse owner and member of the TOC board, spoke on behalf of himself and Ms. McCaffry. Mr. Lewis said he agreed with Vice-Chairman Harris that it was right and fair to give voice to as many facets of the industry as possible. However, he said it was difficult to find persons who would fulfill their duties. He stated over the past two years three TOC directors turned in their resignations due to an inability to keep their commitment. Mr. Lewis said it was his desire to serve the industry in every way possible, and neither he, nor Ms. McCaffry, intended to act inappropriately. If they did, he was sure TOC directors would be the first to inform them of their errors. Mr. Lewis said the TOC was a horsemen's organization. If one owned a race horse in California, one was automatically a member. There were owners who were on other commissions and boards. Commissioner Moretti said Mr. Lewis had made some good points, and she did not think there was anyone in the industry who did not hold him in high regard. Commissioner Moretti said Rule 2040 existed because the Board was charged with protecting the integrity of the industry, as well as the perception of integrity. She stated that was where she had difficulty approving a waiver. Commissioner Moretti said she would have to vote

“no.” Commissioner Bianco asked if it was possible to get an attorney general’s opinion. Deputy Attorney General Derry Knight said Rule 1406 provided for exemptions for good cause. He stated there had to be justification for an exemption, but there was no guideline for what “good” meant. Mr. Knight said within a government context such a waiver could not be granted as it would lead to direct conflicts of interest in at least a couple areas. However, as the issue did not involve public officials, he was not aware of anything in the law that prohibited a waiver, and the Board had authority to waive all or part of its existing regulations for just cause. Commissioner Sperry said he did not think OTRA was in danger of not being able to operate with only five board members. He stated he respected those involved, but he was not convinced there was a need to waive a rule. Vice-Chairman Harris **motioned** to waive Rule 2040(a) until the next TOC election. Chairman Licht asked for a second to the motion. Vice-Chairman Harris **withdrew** the motion for lack of a second. Chairman Licht said as there was no motion, the request was denied.

DISCUSSION BY THE BOARD ON A PROPOSED PROVISION THAT REQUIRED, AS A CONDITION OF LICENSING, EACH RACING ASSOCIATION TO PROVIDE THEIR SIMULCAST SIGNAL TO ANY ADW ORGANIZATION LICENSED BY THE CALIFORNIA HORSE RACING BOARD

John Reagan, CHRB staff, said if an advance deposit wagering (ADW) provider wished to provide services in California they must produce a contract with a licensed California horse racing association. Mr. Reagan said the question before the Board was whether the equation should be shifted to require that, as a condition of licensing, every racing association provide its signal to any licensed ADW provider. Commissioner Landsburg said fans who utilized ADW complained they had to reorganize their wagering every time a racing venue was

changed in California. He asked if California was limiting ADW alternatives and restricting the number of ADW providers under the current parameters. If there were more ADW providers with access to the signal, could more handle be realized? Commissioner Landsburg said the item was an examination of whether racing associations were doing the utmost under the current conditions, or should they, as part of their licensing agreement, be required to make their signal available to any licensed ADW provider. Chairman Licht said he saw two issues: 1). Whether it was legal for the Board to compel the tracks to provide their signal to any licensed ADW provider, and 2). Whether it would be proper policy to institute such a requirement. Deputy Attorney General Derry Knight said neither the enabling statute nor the Board's regulations address exclusivity, as there was nothing in either that suggested ADW providers would be limited to providing service for one or all tracks. Mr. Knight said there were currently three ADW providers. He stated XpressBet and TVG had exclusive contracts, while YouBet had arrangements with both providers. In addition, the fairs negotiated a non-exclusive arrangement with all providers. Mr. Knight said he reviewed the minutes of Board meetings where the ADW regulations were heard, and everything suggested the Board believed openness and availability of the signal to any ADW provider was to be encouraged. Mr. Knight stated the reality was that ADW providers negotiated exclusive contracts. He said he did not believe the Board was restrained from instituting a rule that would require non-exclusivity. Mr. Knight said horse racing was a heavily regulated industry and the ADW providers had to be aware there was a potential for rule changes when they entered into their contracts. He stated it was up to the Board to decide if it was in the best interest of horse racing to consider the changes it was discussing. The issue before the Board was not a

situation where the State was a party to a contract; instead, it was a matter of a regulatory body exercising its regulatory police powers. Chairman Licht said the issue was then how deeply did the Board wish to become involved in ADW business affairs. He stated it must be remembered the ADW providers had a large investment in the industry. John Van de Kamp of Thoroughbred Owners of California (TOC) said his organization was not a party to any of the foundation agreements. He stated TOC believed the best model for California was the racing fairs – where all three entities had contracts and were competing head to head. TOC believed that broader distribution of the signal was in the best interest of the industry. Mr. Van de Kamp said, however, the Board should remember contracts were in place that were negotiated many years ago, and large investments were made. The Board could limit what tracks could or could not do – but there was the potential for litigation – so the Board would have to assess the efficacy as well as the cost of any decisions. Mr. Van de Kamp said another issue was the price of the signal. He stated some ADW providers currently set extraordinarily high rates, and in some cases made it impossible for other ADW providers to enter the market. Commissioner Landsburg said the issue was accommodation to outside ADW providers. He stated he could not be concerned with contractual relationships that currently existed as the proposal for an open signal was in addition to such arrangements. Commissioner Landsburg added California currently had an open signal as its races were all broadcast somewhere, and allowing any licensed ADW providers to be involved could only increase handle. Craig Fravel of Del Mar Thoroughbred Club (DMTC) spoke in favor of the current ADW scenario. Ed Friendly of TOC said one issue that had not been raised was that the various signals were shown on different venues. One may be on a dish, and the other on direct television, and it

was difficult for fans to receive all three signals if they subscribed to only cable or satellite television. Mr. Friendly said the system needed fixing because fans had to subscribe to multiple services. He stated the wider the distribution, the more fans could watch. Mr. Friendly said he thought the Board should do everything in its power to see ADW had the widest circulation possible. He stated it was evident that one company wanted to monopolize as much television as possible. The entity did not want its signal used by another ADW provider because it did not want that provider to succeed. Mr. Friendly said he thought a previous Board made a mistake when it permitted one company to own three tracks in California as it put too much control with one entity. He stated TVG was not allowed to carry Golden Gate, Bay Meadows and Hollywood Park for individual corporate reasons, and he did not think the Board should allow one corporation's decisions to outweigh what was best for horse racing in California. Mr. Friendly stated the Board should find a way to let the tracks provide their signal to any ADW provider that wanted it, as the industry would grow and everyone would benefit. Chairman Licht asked how Mr. Friendly would differentiate between a political event, and baseball or a situation comedy on CBS. Why shouldn't ABC be able to show the situation comedy. Mr. Friendly said Federal Communication Commission rules stated any political event must be treated under the Fair Practices Rules. Baseball and situation comedies were not regulated by the government for the betterment of the public. Mr. Friendly said the Board was charged with protecting the interests of horse racing and the public. He stated the issue was the broadest possible circulation for horse racing's product, which was gambling. The industry should make it as easy as possible for fans at home to reach its signal and to be able to wager. Chairman Licht asked Mr. Friendly if he thought TVG would have

invested so many resources if it could not have an exclusive relationship with Santa Anita. Mr. Friendly said TVG would have done anything for Santa Anita, including sharing the signal. Drew Couto of TOC said the Board might look at the issue on two different levels. He stated there was the right to the signal and the right to wager. Mr. Couto said everyone understood TVG and HRTV's position regarding the value of exclusivity. However, the parties had not addressed the right to wager on each other's signal without the right to see the video. Mr. Couto stated allowing each of the ADWs to place wagers on the other's signals without video rights might be the best way to accomplish the Board's objectives. Commissioner Landsburg said when he and Chairman Licht were conducting informal discussions prior to presenting ADW licensing to the Board, XpressBet and TVG stated they would consider working with each other's signal. He stated the reality was that none was willing to negotiate a signal. Commissioner Landsburg said there were two valuable signals and two organizations that had two years to build an audience. He stated the audience had leveled off for both entities, and in the last six months there had been very little growth. There had to be another way to reach a broader expansion of the signal, and licensing the associations on the basis of providing the signal to licensed ADW providers would be one avenue. Mr. Couto said it was evident there were private wagering networks and other ADW providers that were thriving without a visual signal. He stated in the Caribbean such providers were doing well, and it might be appropriate to explore exchanging the right to wager without a visual signal. Mr. Friendly said if TVG could show Santa Anita's signal it would earn enough to make up for what it lost in exclusivity, and the same would be true for HRTV. Currently, fans generally subscribed to one service or the other and could get only one track. He stated he did

not think that was good for the industry. Mr. Friendly said the current system encouraged off-shore, or out-of-state wagering because fans could not get the signal or did not want to subscribe to more than one service. Chairman Licht said letting the public choose between the providers could be a benefit, but it seemed to be a business decision whether or not income would be recouped by giving up exclusivity. He stated he had not heard any evidence that it would result in better revenue for the State. Greg Badovinac, a horse racing fan, said there was not a single ADW provider that allowed access to every racetrack in the country. He stated the goal in California should be to give fans access to as many tracks as possible in a single account, and requiring racing associations to provide their signal to multiple ADW providers as a condition of licensing would only be beneficial. Rick Baedeker of Hollywood Park said TVG had shown growth in the last six months. He stated TVG added Direct TV with cable in Orange County and San Diego County. TVG was also in some parts of Northern California. Mr. Baedeker said when TVG entered into its exclusive agreements in 1996 the wagering platform was already available. TVG's agreements were based on a business plan that assumed exclusive content would translate to distribution. Mr. Baedeker stated TVG was in 7 million homes and there was every indication it would continue to grow. He said he hoped the Board would be reluctant to overturn contracts the associations had entered into. Commissioner Landsburg said when he referred to growth he meant numbers of subscribers, and the last numbers he saw were level. He stated the Board was grateful for the per capita growth in the amount of wagering – both at the track and through ADW. He stated, however, he was looking for a new customer base where ADW in California or around the country could exploit California's signal. Chairman Licht said the proper forum for further discussion of the

issue would be the Pari-Mutuel Committee. He asked Commissioner Landsburg, Chairman of the committee, to set a meeting for October 2003.

DISCUSSION AND ACTION BY THE BOARD ON A REPORT BY THE CHRB LEGISLATIVE COMMITTEE ON THE PROPOSED LEGISLATION ALLOWING THE ASSOCIATIONS AND HORSEMEN'S ORGANIZATION TO INCREASE THE TAKEOUT TO FUND WORKER'S COMPENSATION INSURANCE.

Commissioner Moretti said worker's compensation insurance (WCI) was one of the most important issue for California Business in 2003. The tremendous rise in costs caused innumerable problems for businesses of all sizes. She stated a conference committee of both political parties reached an agreement to control WCI costs, and the resulting legislation would soon be signed by Governor Davis. It was not known whether the legislation would lower WCI costs, but it was anticipated costs would be controlled by November 2003.

Commissioner Moretti said AB 900, the horse racing legislation sponsored by Assemblyman Horton, was designed to help the horse racing industry with its WCI dilemma. She stated the bill had a two-thirds requirement with an urgency measure in it, and Assembly Republicans refused to vote on it at the end of the current session – as they had with all such legislation. AB 900 did not pass out of the Assembly, so it would return in January 2004 for more committee hearings. Commissioner Moretti commented AB 900 was controversial because of its effect on takeout, which concerned a number of individuals. Chairman Licht said the industry would look at the legislation to add its input, and hopefully something would pass that would be workable for horse racing. Rod Blonien said attempts were made to convince the Republican leadership to relent and pass AB 900, but they were not successful. He said, however, it was possible that early in the next session the bill could be on the governor's desk

for signing. Vice-Chairman Harris said he would like to see a sunset attached to the bill. He stated the legislation involved a lot of money, and the Board would have no approval authority regarding how the money would be spent. Greg Badovinac, a horse racing fan, said he supported the concept, but saw benefits in the legislation for everyone in horse racing except those who would pay the bill; the fans. He stated if money was going to be taken out of horse player's pockets, they should be given something in return, such as full-card simulcasting. Chairman Licht said he agreed the wagering public would pay for the program. However, he stated as in any other business, when costs went up, the business was entitled to raise the price the public would pay. Chairman Licht said the fans would also benefit from the legislation with larger fields, more wagering opportunities and larger payoffs. Chris Korby of California Authority of Racing Fairs said his organization supported the legislation. He stated, however, the fairs were not mentioned in the body of the legislative language, and would like to be included.

REPORT BY THE STAFF ON THE IMPACT THAT THE FOUR-SECOND CANCELLATION DELAY THAT IS CURRENTLY USED IN THE CALIFORNIA THOROUGHBRED AND FAIR TOTALIZATOR NETWORK HAS ON FINAL ODDS CYCLES.

John Reagan, CHRB staff, said in the past few years the final cycles were the subject of scrutiny. Staff recently looked at the effect of the four-second cancellation delay available to pari-mutuel clerks. Mr. Reagan said after a survey of pari-mutuel managers it was determined there was little impact. He stated he conducted tests at the Del Mar Thoroughbred Club (DMTC) meeting and found the dollar amount, as well as the number of cancellations, was not significant. Mr. Reagan said staff would continue to monitor the four-second delay. Chairman

Licht said he would like the item to be discussed in depth at a Pari-Mutuel Operations Committee meeting. He stated he thought it was important that the public be made aware of the four-second delay. Many fans who initially thought wagering continued after the start of the race were now blaming the four-second delay for changes in the odds. Chairman Licht said he had in-depth statistics from RGS which negated any possibility of problems with last-second cancellations. In addition, he knew DMTC conducted studies with an auditor and their pari-mutuel department. Craig Fravel of DMTC said there was an incident at its meeting where the odds changed in the middle of a sprint race which created interest with the media and fans. He stated a report on the incident would be forthcoming. With regards to the four-second delay, Mr. Fravel said it was difficult to watch a monitor to see if a horse stumbled out of a gate and at the same time signal someone to cancel a wager. Mr. Fravel said DMTC reviewed the history of cancellations at its facility and found they occurred mainly on opening day and Pacific Classic Day when there were a lot of novice fans. He stated most cancellations were \$2 to \$6 wagers, which were not wagers that changed odds. Mr. Fravel also noted that it took 8 to 10 seconds for pools to be finalized because the tote system did not request out-of-state pools until the four-second delay expired. He stated the stop-betting button was hit, then after a four-second delay, a computer signal went out requesting the wagering pools to transmit.

John Reagan, CHRB staff, said the Humboldt County Fair (HCF) did not have a good meeting. He stated he looked at the five year average and found that in 2002 HCF had a very good meeting, then in 2003 it fell back to its five year average. Mr. Reagan said he did not know if there was a downward trend, or if it was a matter of having a good year followed by an average year.

GENERAL BUSINESS

Ed Friendly, a horse owner and past chairman of Thoroughbred Owners of California (TOC), said he gave staff a memorandum regarding ways to increase field sizes in California. Mr. Friendly said in the memorandum he suggested changing the also-eligible scratches from 24-hours before the day of the race, and secondly, he encouraged the racetracks not to run a mile race where they limit the field to only 10 entries. Mr. Friendly explained the rationale behind his suggestions. Chairman Licht thanked Mr. Friendly and said the issues would be discussed at a future committee meeting. Dr. Ron Jensen, CHRB Equine Medical Director, said the West Nile virus had been identified in Los Angeles, Imperial, and Riverside Counties. He stated the arrival of the disease had been anticipated for the past two or three years, and California was well prepared. Dr. Jensen said he believed most of the horses at the tracks had been vaccinated, but he suggested horsemen check with their veterinarians to be sure their

vaccination schedule was current. He stated staff encouraged tracks to do a good job of mosquito control. Mike Martin, CHRB staff, showed a three minute horse racing video that was produced in conjunction with a San Diego television station, and previously shown at the Del Mar meeting.





BACKGROUND

Business and Professions (B&P) Code Section 19440 provides that the responsibilities of the Board shall include adopting rules and regulations for the protection of the public and the control of horse racing and pari-mutuel wagering. B&P Code Section 19590 states the Board shall adopt rules governing, permitting, and regulating wagering on horse races under the system known as the pari-mutuel method of wagering. The proposal for a Beat The Odds (BTO) wager, which was developed by Mr. James Quinn, a Southern California horse player, was presented at the January 23, 2003, Pari-Mutuel Operations Committee meeting. The proposed regulation was heard again at the February 20, 2003, Pari-Mutuel Operations Committee Meeting, and subsequently approved for notice. Rule 1979.5 was heard at the June 26, 2003 Regular Board Meeting where it was not adopted. The rule was referred back to the Pari-Mutuel Operations Committee where it was heard on July 25, 2003. After modifications, the proposed regulation was put out for the 45-day public notice period.

ANALYSIS

The BTO wager requires selection of first-place finishers that are non-favorites in three or more races on the card for a single performance. If a favorite wins a race on a card, all tickets that selected the race are losing wagers. The BTO pool is calculated by identifying tickets that selected non-favorite winners in at least three races on the card and totaling the two-dollar win price of the winning runner for each race. Tickets having the highest total win price are winning tickets. If no ticket selects non-favorite winners in at least three races on a card, the entire net BTO pool is carried over to the next day's race card and added to the net BTO pool.

During the 45-day public comment period the Southern California Horse Racing Industry Fans Committee (SCHRIFC) endorsed the addition of Rule 1979.5. Attached is a copy of the SCHRIFC letter expressing support for the proposal.

RECOMMENDATION

The proposed addition of Rule 1979.5 was presented and approved for notice at the July 25, 2003, Pari-Mutuel Operations Committee Meeting, where it was endorsed by the Los Angeles Turf Club. Comments were received from the SCHRIFC during the 45-day public comment period.

Staff recommends the Board adopt Rule 1979.5 as presented.

TITLE 4. CALIFORNIA CODE OF REGULATIONS
ARTICLE 18. PARI-MUTUEL WAGERING
ADDITION OF RULE 1979.5
BEAT THE ODDS

Regular Board Meeting
October 23, 2003

1979.5 Beat the Odds

(a) The Beat the Odds pool is a separate pool consisting of amounts wagered on first place finishers that are non-favorites in three or more races for a single performance.

(1) For the purposes of this rule "favorite" means the wagering interest with the highest dollar amount wagered on it to win at the time the win pool is closed and final.

(2) "Non-favorite" means any wagering interest that is not a favorite when the win pool is closed and final.

(b) There shall be only one Beat the Odds pool for each performance, and it shall encompass every race on the card for that performance. The pool shall be closed when there are only three races left on the card .

(c) A Beat the Odds pari-mutuel ticket is evidence of a binding contract between the holder of the ticket and the association. The ticket constitutes an acceptance of the Beat the Odds provisions and rules contained in this article.

(d) The object of a Beat the Odds wager is to select runners that are non-favorites in three or more races on the card for a single performance. A basic wager is one in which one runner is selected in at least three of the races. Such races may be consecutive or non-consecutive. A selection of more than one runner in a race shall constitute multiple combinations of the wager.

(e) If the favorite wins in any of the designated races, all wagers that selected the races are losing wagers.

(f) Horses constituting an entry of coupled horses or those horses coupled to constitute the field shall be considered a single wagering interest for the purposes of the Beat the Odds wager.

(g) The net Beat the Odds pool shall be distributed equally to holders of winning wagers.

The Beat the Odds pool is calculated by:

(1) identifying wagers that correctly select non-favorite winning runners in three or more races on the card for a single performance, and

(2) totaling the two-dollar win price of the non-favorite winning runners.

(3) Wagers having the highest two-dollar win price total are winners.

(h) If there are no winning wagers for a Beat the Odds pool, the entire net pool shall be carried over to the next performance and added to that day's net Beat the Odds pool. In the case of the last performance of the meet, if there are no winning wagers pursuant to subsection (g) of this rule, wagers that correctly select non-favorite winning runners in fewer than three races shall be considered and the net pool, including any carryover, shall be distributed equally to holders of wagers with the highest two-dollar win price. If there are no wagers selecting the non-favorite winner, the net pool, including any carryover, shall be placed in an interest bearing account and carried over until the first performance of the next race meet at that same location.

(i) If a selected runner is scratched, combinations with the scratched runner shall be refunded. A scratch of a runner that is part of an entry or field will not result in a refund if any part of the entry or field is a valid starter for pari-mutuel purposes.

(j) In the case of a dead heat for win between two or more non-favorite runners, wagers selecting one of the runners will receive a score equal to the win price of the selected winning runner.

(k) In the case of a dead heat for win in which one of the runners is a favorite, wagers selecting the favorite are losing wagers; however, wagers selecting the non-favorite shall receive a score equal to the win price of the winning non-favorite runner.

(l) If fewer than three races constituting the Beat the Odds wager have been run and the remainder of the card is cancelled, the entire Beat the Odds pool, less any carryover, shall be refunded.

(m) If at least three races have been run before the remainder of the card is cancelled, wagers selecting any of the completed races shall be paid according to subsection (g) of this rule, but shall only be paid for that performance's net pool. If the application of subsection (g) of this rule does not result in any winning wagers, then all wagers, including wagers not selecting any completed races, shall be refunded.

(n) The Beat the Odds wager may be given a distinctive name by the association conducting the meeting, subject to Board approval.

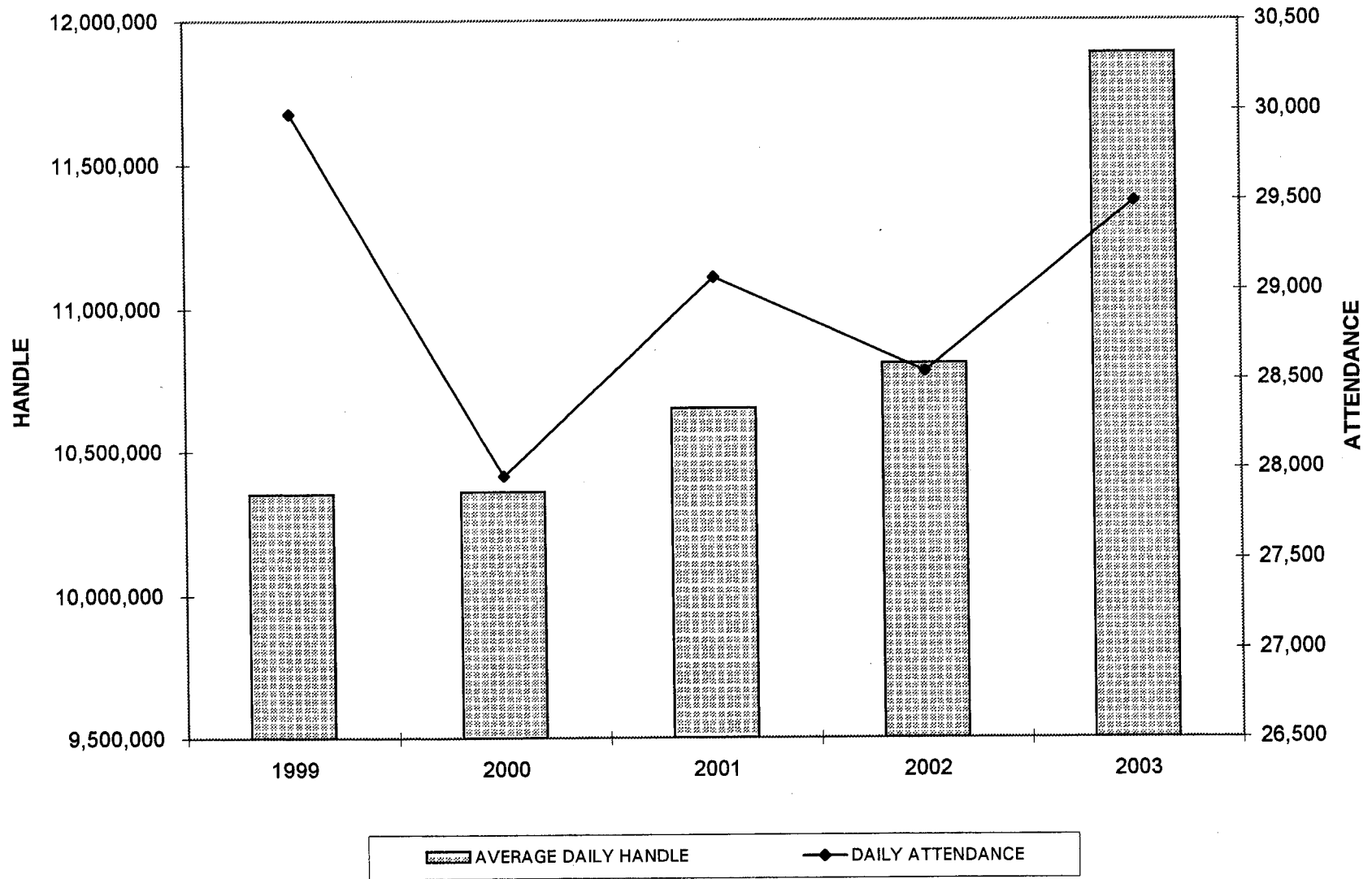

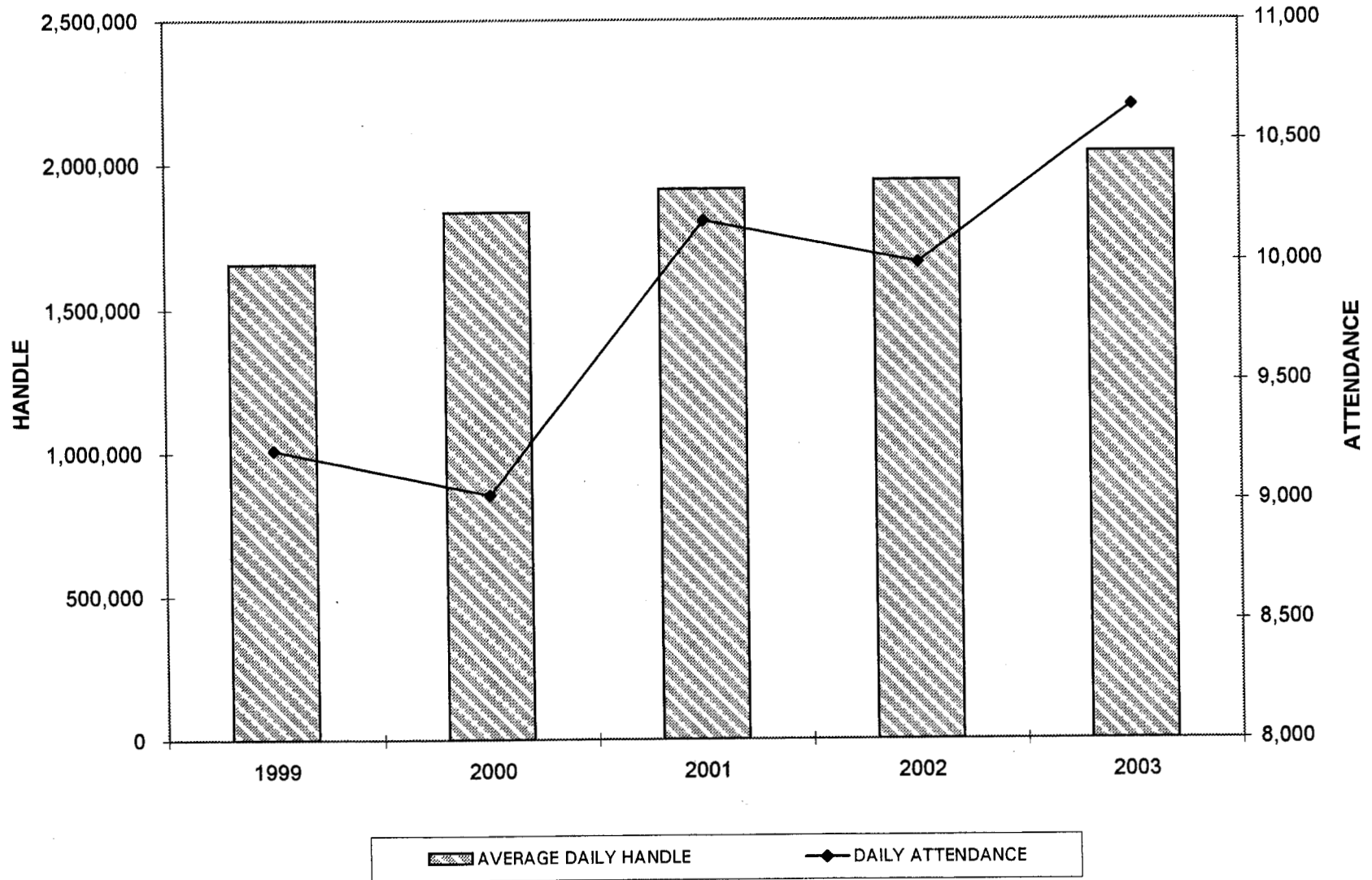
