**MINUTES**

---

Chairman Harris asked for approval of the minutes of the Regular Board Meeting of June 3, 2004. Commissioner Moss said he asked the Thoroughbred Owners of California to comment about the Thoroughbred Owners and Breeders Association (TOBA) race series, the TCT, not the TOBA in general. Commissioner Moss **motioned** to approve the minutes, subject to his correction. Vice-Chairman Licht **seconded** the motion, which was **unanimously carried**.

**DISCUSSION AND ACTION BY THE BOARD ON THE APPLICATION FOR LICENSE TO CONDUCT A HORSE RACING MEETING OF THE OAK TREE RACING ASSOCIATION (T), FROM SEPTEMBER 29 THROUGH OCTOBER 31, 2004, INCLUSIVE.**

---

Roy Minami, CHRB staff, said Oak Tree Racing Association (OTRA) proposed to run 26 days, six days less than in 2003, for a total of 223 races. The first post time would be 1:00 p.m. Wednesdays and Thursdays, 2:30 p.m. Fridays and 12:30 p.m. weekends and holidays. Mr. Minami stated the fire clearance was missing from the application. He stated staff recommended approval of the application conditioned upon receipt of the fire clearance. Vice-

Chairman Licht **motioned** to approve the application for license to conduct a horse racing meeting of OTRA. Commissioner Moretti **seconded** the motion, which was **unanimously carried**.

**DISCUSSION AND ACTION BY THE BOARD ON THE APPLICATION FOR LICENSE TO CONDUCT A HORSE RACING MEETING OF THE FRESNO DISTRICT FAIR (F), FROM OCTOBER 6 THROUGH OCTOBER 17, 2004, INCLUSIVE.**

---

Roy Minami, CHRB staff, said the Fresno District Fair (FDF) proposed to run 11 days for a total of 98 races. The first post time would be 12:37 p.m. Saturday and Sunday, 12:45 p.m. Friday and 1:30 p.m. Monday, Wednesday and Thursday. The fire clearance, the Thoroughbred Owners of California sign-off and the contract with Scientific Games were missing from the application. Mr. Minami said staff recommended approval of the application conditioned upon the receipt of the missing items. Commissioner Sperry **motioned** to approve the application for license to conduct a horse racing meeting of FDF. Vice-Chairman Licht **seconded** the motion, which was **unanimously carried**.

**DISCUSSION AND ACTION BY THE BOARD ON THE REQUEST OF THE BAY MEADOWS OPERATING COMPANY TO AMEND THEIR LICENSE APPLICATION TO CHANGE THE COMMENCEMENT OF THE RACING MEETING FROM SEPTEMBER 3, 2004 TO SEPTEMBER 4, 2004.**

---

John Reagan, CHRB staff, said Bay Meadows Operating Company (BMOC) submitted a request to commence its meeting on September 4, instead of September 3. This would reduce the overlap by one day. Mr. Reagan said staff recommended approval of the item. Scott Daruty of Magna Entertainment said the request by BMOC was made subject to the approval

of Thoroughbred Owners of California (TOC). He stated TOC did not support the idea, so he asked that the item be withdrawn from the agenda. Chairman Harris inquired if Cal-Expo supported the reduction. Dave Elliot of Cal-Expo said his organization supported BMOC's request. Drew Couto of TOC said the opposition within his organization came from Northern California directors who were concerned with Cal-Expo's decision not to run a day of overlap with Del Mar. Instead, Cal-Expo asked BMOC to give up a day of overlap, which was unnecessary from TOC's perspective.

**DISCUSSION AND ACTION BY THE BOARD ON THE APPROVAL OF THE RACE DATES CALENDAR FOR 2005.**

---

Commissioner Moretti said the Race Dates committee (committee) met on July 23, 2004, at Del Mar to discuss the 2005-racing calendar. She stated the committee first discussed the northern calendar. Bay Meadows Operating Company (BMOC) and Golden Gate Fields (GGF) proposed a compromise schedule wherein the number of days of thoroughbred racing was in order of zone. The entities would continue negotiations regarding overlap days. Commissioner Moretti said the committee then heard from the southern thoroughbred and fair circuit. She stated Los Angeles Turf Club (LATC) requested the committee expand the proposed 2005 dates by one week in April. This would move the other associations one week further into the racing calendar. The proposal was not well received by the other associations. A compromise was proposed but a resolution was not reached. Commissioner Moretti said the harness industry asked the committee to allocate a full year of racing, but as Capitol Racing would only run through July 2005, the calendar will remain open until Cal-Expo's request for quote process regarding its facility lease was completed. There was no controversy regarding

the proposed 2005 race dates for quarter horses at Los Alamitos Race Course (LARC). John Reagan, CHRB staff, said the proposed race dates for thoroughbred meetings in the central and southern zones were: LATC winter meeting, 85 days, from December 26, 2004, through April 18, 2005; Churchill Downs California Operating Company (CDOC), 65 days, from April 20 through July 17, 2005; Del Mar Thoroughbred Club, 43 days, from July 20 through September 7, 2005; LATC fall meeting, 31 days, from September 28 through November 6, 2005; CDOC, 31 days, from November 9 through December 19, 2005; Los Angeles County Fair Pomona, 17 days, from September 9 through September 25, 2005. For the northern zone: GGF, 28 days, from December 26, 2004, through January 30, 2005; BMOC, 72 days, from February 2 through May 8, 2005; GGF, 28 days, from May 11 through June 19, 2005; BMOC, 33 days, from September 3 through October 16, 2005; GGF, 46 days, from October 19 through December 19, 2005. Northern fairs: San Joaquin County Fair, 10 days, from June 15 through June 26, 2005; Alameda County Fair, 11 days, from June 29 through July 10, 2005; Solano County Fair, 11 days, from July 13 through July 25, 2005; Sonoma County Fair, 12 days, from July 27 through August 8, 2005; San Mateo County Fair and Exposition, 12 days, from August 10 through August 22, 2005; Humboldt County Fair, 10 days, from August 11 through August 21, 2005; California Exposition and State Fair, 12 days, from August 24 through September 5, 2005; Big Fresno Fair, 11 days, from October 5 through October 16, 2005. Night Industry: LATC, 204 days, from December 26, 2004, through December 18, 2005; Cal-Expo, 134 days, from December 26, 2004, through July 30, 2005. Vice-Chairman Licht said the issue with LATC was that it wished to continue an extra week, and it did not agree with the committee's solution. Commissioner Moretti said on the originally proposed

calendar LATC lost some days; however, the committee's subsequent proposal mitigated the loss. The committee attempted to seek a means of consensus, but there appeared to be none among the associations, so the committee arrived at its own compromise. Commissioner Moretti stated northern California thoroughbred days were divided and the northern fairs indicated they were satisfied with the 2005 date allocation. The harness dates were proposed through July 2005 as Cal-Expo was conducting an RFQ process regarding the extension of its facility lease. Commissioner Moretti said there were no issues with the quarter horse dates. Chairman Harris asked if there was any consideration given to the overlap with Fresno. Commissioner Moretti said the committee asked the fairs and association to discuss the overlap. The committee offered to present a pilot program to eliminate the Stockton and State Fair overlap for 2005 as it was concerned with field size. Chris Korby of the California Authority of Racing Fairs said his organization supported the committee's recommendation. Chairman Harris said he wondered if six-day weeks in January and February were well advised in northern California. Jack Liebau of BMOC said his organization endorsed the committee's recommendations. Chairman Harris asked if there was a Monday, or Wednesday in January or February where BMOC was dark, but the south was running, could BMOC open to simulcast the southern California program for that day? Mr. Liebau said BMOC opened several times under such circumstances, but was not very successful. He added BMOC did not believe six-day weeks would be a problem. Drew Couto of Thoroughbred Owners of California (TOC) said his organization favored five-day weeks. He stated a serious shortage of starters would make it difficult to sustain six-day weeks. Mr. Couto said the TOC board discussed the issue with the associations who believed the schedule developed by the committee

and northern California industry was the most productive. Charles Dougherty of California Thoroughbred Trainers (CTT) said his organization agreed with TOC. Northern California trainers favored a five-day week. Bob Marconi of the Southern California Fans Committee said his organization was concerned with shrinking fields. He stated he believed racing weeks should be cut to five and sometime four-days. Alan Horowitz of Capitol Racing (CR) said it appeared there was no discussion of his organization's proposal to conduct harness racing at Stockton. He stated CR had entered into a lease agreement with the Stockton fairgrounds. CR believed Stockton had a viable market for developing a new racing program. With the instability of northern California horse racing, Mr. Horowitz said it would be shortsighted not to explore an opportunity to expand to a new facility. He stated CR was successful in developing harness at Cal-Expo and asked that it be given a chance to do the same at Stockton. Chairman Harris asked what the committee thought would happen after August 2005. Mr. Horowitz said Cal-Expo put out the RFQ and would make a decision regarding a new operator on December 3, 2004. He stated it would be late fall before the committee revisited the issue. Dave Elliott of California State Fair said his organization requested that dates be allocated for the entire year, but it was satisfied with the current schedule. He said the RFQ would be finished in December 2004, early enough for the December Regular Board Meeting. Vice-Chairman Licht **motioned** to approve the 2005 northern California schedule, and 2005 harness and quarter horse schedule as proposed by the committee. Commissioner Sperry **seconded** the motion. The motion **failed** with Chairman Harris, and Commissioners Bianco and Moss voting "no." Chairman Harris said he voted against the motion because he was concerned with field size. He stated he would like to see data on the economic impact of simulcasting



racers from the south during northern dark days. Chairman Harris said he believed it would be beneficial, as it would generate commissions and purses. Executive Director Roy Wood, Jr. asked if the committee added the Mondays to the northern racing calendar based on changes in the southern calendar. Commissioner Moretti said the committee tried to accommodate north and south. Mr. Wood stated if the original northern California schedule had its Wednesdays reduced it would become what the industry originally submitted and agreed upon. The Wednesdays were added to have an overlap. Chairman Harris said he questioned the necessity of having the northern dates mirror southern dates. Would it be wise to experiment in 2005 to see what would happen if one sector raced without the other? Jack Liebau of BMOC said the northern signal was important to the south when it was running as it generated substantial commissions and purse money. He stated instead of making a decision regarding field size in the first months of 2005, the Board might grant some flexibility through staff or a committee that would make a decision about running on the two Wednesdays in question. Vice-Chairman Licht said he agreed with Mr. Liebau. There was no statistical evidence to suggest the impact would be any more severe in the north than the south. Chairman Harris said he could agree if the north could show field size of 7 or 8 for the weeks preceding the Wednesdays, but he was concerned with fields in the range of 6. Mr. Couto said TOC supported a 5-day week because it believed there was an inventory issue in the north. Vice-Chairman Licht asked why TOC supported an overlap with Cal-Expo. Mr. Couto said TOC believed the Cal-Expo overlap would benefit Del Mar and Cal-Expo. However, an overlap where three entities were running was not a good idea. Vice-Chairman Licht said he believed it was a business decision and had nothing to do with field size. Mr. Couto said it was more than a business decision. The

horsemen had some influence on the decision, and having meetings run simultaneously in the north and south benefited the entire industry. Preston Smith, a driver-trainer, stated moving a day out of the schedule would impact the entire racing community. He said the Board needed to give consideration to recent legislation that gave owners additional income for starting horses. The industry needed time to adjust to the new starter monies. Those finishing 10, 11 or 12 had something to look forward to, and maybe it would bring new horses into the state. Richard Castro of the Pari-mutuel Employees Guild (Guild) said his organization supported the added day. Chairman Harris said on dark days in the north the tracks were open for pari-mutuel wagering and employment on the front side was similar to a normal day. Mr. Castro said when a dual signal was run the Guild hired more workers. Vice-Chairman Licht **motioned** to approve the 2005 harness and quarter horse dates as proposed by the committee. Commissioner Moretti **seconded** the motion, which was **unanimously carried**. Chairman Harris **motioned** to approve the committee's recommendation regarding the 2005 northern California thoroughbred dates with January 19, February 23 and October 12 eliminated, subject to reconsideration based on adequate field size. Chairman Harris said he believed eliminating the Wednesdays would help field size. He stated he was concerned with the effect of 6-day weeks on the horse population and believed the Board needed to look at different ways to approach the issue. By eliminating one day, field sizes in subsequent days might improve. Vice-Chairman Licht said in 2003 a fair raced a day when there was no racing in the south and it was a disaster. Chairman Harris stated the difference was there would be racing in the south, but not the north. He said he would like to see data regarding such a scenario – was it done enough times to be relevant and what were the field sizes north and south during

those times? Commissioner Sperry suggested the issue be held over so more information could be provided. Mr. Castro said the northern schedule was a cooperative effort of the racing associations, trainers and TOC. In addition, the Board, in the past, supported concurrent racing in the north and the south. Eliminating dates from the northern California schedule would take away racing opportunities. Rick Baedeker of CDCOC said Hollywood Park ran one day uncovered during the 2004 spring summer meeting. He stated the total southern California handle for that day was \$464,000 with \$23,000 in purse money. Mr. Baedeker said wagering was on all products, not just northern California. The front-side employees were reduced, and although the association was happy to generate additional purse money, there was not the volume to realize revenue from admissions, parking, and food and beverages. Chairman Harris said he would like to see the experiment conducted with the south running and the north dark. Commissioner Moretti said based on the facts the committee came to the best consensus it could. She stated nothing was set in concrete and she was open to new ideas. Mr. Couto said TOC the northern California schedule was a joint industry effort. He stated the northern industry spend a lot of time resolving its issues and came to the recommendation that it was prepared to live with. Mr. Couto said TOC supported the committee's recommendation. Vice-Chairman Licht **motioned** to approve the committee's recommendations for the 2005 northern California thoroughbred race dates subject to the ability of the committee to eliminate any or all of the three Wednesdays based on field size. Commissioner Sperry **seconded** the motion, which was **carried** with Chairman Harris voting "no." Commissioner Moretti said the committee recommended maintaining a holiday break in southern California from December 20 to December 25, 2004. She stated TOC indicated

the break was essential. Commissioner Moretti said the schedule would not reduce race days but would allow Del Mar to post two days after Labor Day, and implement the racing schedules requested by all the southern California associations except LATC. In addition, the proposed 2005 southern California race dates maintained the cap of 8.6 races per day with no more than nine races on weekends and holidays. To address LATC's concerns the committee added three days to the winter schedule and was recommending 85 days, one more day than in 2004. Commissioner Moretti added the committee felt that to avoid future contention it might be advisable to issue a multi-year race date calendar. Scott Daruty of Magna Entertainment (ME) said his organization made an alternate proposal regarding the 2005 LATC race dates. He stated ME analyzed 25 years of racing calendars and compiled various reports and letters which were submitted to the Board. Mr. Daruty said five facts emerged from the research. The first point was the proposed racing calendar submitted by LATC was consistent with 24 of the past 25 years of racing wherein it opened the day after Christmas and ran for 17 full weeks. Mr. Daruty said the second point was CDCOC and Del Mar were supportive of the committee proposal because Del Mar was being allowed to close the Wednesday after Labor Day and CDCOC was receiving two extra days. The economic impact of such "gifts" would be detrimental. Mr. Daruty said MEC's financial analysis demonstrated that LATC's proposal was better for the industry. There would be 30-million dollars more handle, which would generate 1.13 million dollars more in purses. He stated the numbers were based on historical data. Mr. Daruty said the third point was the issue should not be looked at as two against one. The Board should balance the benefit to the entire industry, which would be positive under LATC's proposal. Historical data demonstrated if Del Mar was allowed to run a week past

Labor Day, it would handle seven percent less than one of its mid-meet weeks. That would equate to 4.5 million dollars in handle and \$250,000 in purses. CDCOC's two extra days would generate 15 million dollars in handle and \$600,000 in purses. The gains of both associations, combined with the losses LATC would suffer, would result in a loss to the industry. Mr. Daruty said the fourth point was that this was not a single year problem. If the committee's recommendations were adopted LATC would have a 16-week meeting in 2005, and the pattern would most likely continue through 2008. Based on the financial data, it was not clear why the Board would take that route. Mr. Daruty said his final point was the Christmas break. LATC supported the break because it was important to the horsemen and the industry. However, there was a less burdensome way to handle such a break. Chris McCarron of LATC said his organization sampled trainer opinion at a trainer's meeting on Del Mar's backstretch. The trainers were overwhelmingly in favor of LATC's 2005 race dates proposal. Part of the proposal was to open on December 26, 2005, then provide a break if needed. Jack McDaniel of LATC said his organization would suffer if the committee's recommendations were adopted. LATC had an increase in attendance in 2004 and wished to continue the trend. However, it could not keep the promises it had made, or maintain its level of investment in its facility under the proposed calendar. If LATC went into 2005 with a 16-week meeting it would lose handle and have to compress its stakes race schedule. That would mean races would have to be turned around more quickly and LATC's Derby week would be right against its closing week. Both weeks are big and having them so close would contribute to fan exhaustion. Mr. McDaniel said if LATC's proposal needed more analysis the issue could be postponed. Ed Halpern of California Thoroughbred Trainers (CTT) said LATC

might have had its proposal endorsed by trainers at Del Mar, but when trainers from various parts of the state add to the debate, issues become very complex. Mr. Halpern said the CTT board considered all the information and concluded it did not have a position. However, the CTT did not believe a random poll of trainers should be the determining factor. Commissioner Moretti asked what was CTT's position on the Christmas break. Mr. Halpern said CTT always believed that more breaks, longer breaks, and less racing was good for the industry. Mr. McCarron said when he was riding he thought breaks between meetings and a Christmas break would be a good thing. In the last few years he rode he took a vacation every year. Most jockeys would not take a break because they would lose business. Mr. McCarron said since he entered a management position, he had a different perspective and realized long breaks were not in the best interest of racing. In addition, fans would not stop wagering, they would simply find a different product. Mr. Baedeker read from a letter he submitted to the committee regarding the 2005 race dates. Upon conclusion of his letter, Mr. Baedeker stated he understood the committee's wish to mitigate the effect of the proposed racing calendar on LATC. However, CDCOC historically had a difficult opening day. In April CDCOC traditionally opened after as much as 17 weeks of racing and to have LATC close within two days of that opening would make it worse. Mr. Baedeker said the committee's proposal ensured a reasonable break before Christmas without a severe penalty for the industry. In addition, Mr. Baedeker said CDCOC added a Monday closing to add an additional day of employment as a mitigating factor. He added each employee had vacation time and could plan accordingly. Vice-Chairman Licht said trainers did not make money unless they won purses. If there were no races, trainers could incur substantial losses during a break. Mr. Baedeker

said based on such reasoning the industry would race up to seven days a week. There was a middle ground, and it was the committee's proposal. Chairman Harris **tabled** the item until the September 2004 Regular Board Meeting.

Barry Broad representing the Jockeys' Guild (Guild) introduced Mr. Burt Bacharach who read into the record three letters that supported the proposed amendment. The first letter was from James DiBonni, M.D., of the University of Southern California. The second letter was from Dr. David Eaber, a professor of medicine and director of the UCLA Center For Human Nutrition. The final letter was from Arilla Natif, an Associate Professor at UCLA Department of Family Medicine, Division of Sports Medicine. Mr. Broad said the Guild's proposal was in three parts. If one of the parts were not enacted, the whole would not work. He stated the Guild spoke with the industry, owners and trainers, and he believed the proposal was well understood. Mr. Broad acknowledged there were significant disagreements regarding the proposal's adoption and some wanted only part of the proposal adopted. However, the Guild believed its proposal worked as a system to protect the jockey's health and was transparent and fair to the public and the industry. Mr. Broad said the California Medical Association, the California Nurses Association and the American Dietetic Association (ADA) as well as many physicians wrote letter in support of the proposal. He stated jockeys were superb athletes but what they did to themselves to maintain weight had long-term consequences. Mr. Broad said a

few years ago several dietetic and sports medicine organizations made a statement on nutrition and sports. Athletes were to hydrate themselves, eat proper meals and stay away from activities that involved anything related to dehydration; yet everything jockeys did to themselves to make weight was the exact opposite of that statement. Mr. Broad said the three parts of the Guilds proposal worked together. Jockeys would have to maintain a minimum 5-percent body-fat content; a minimum weight of 118 pounds and the equipment would weigh 10 pounds. Mr. Broad said the equipment had been weighed at 10 pounds. Under the proposal it would be weighed when the jockey weighed in and out, and it should weigh 10 pounds each time. Currently, the equipment weight varied from track to track and race to race. Jockeys weighed out with one set of equipment and in with another. This led to a situation that was confusing and not transparent. Under the proposed regulation the jockey would be weighed nude and have their body fat measured before the commencement of the race day. The jockey would subsequently weigh out and back in with his 10-pounds of equipment. Mr. Broad said some had suggested the body fat minimum be enacted without raising weight limits. Others suggested implementing the body fat minimum, raising weight to 120 pounds and not separate out the equipment. That would mean a jockey could only weigh 110 pounds. He stated the problem with such suggestions was they all continued to create incentives for jockeys to do things that were destructive or made it humanly impossible to actually meet the standard. It was physically impossible for some people to weigh 110 pounds with 5 percent or more body fat. Therefore, it was important that an additional five or six pounds be added to the present minimum weight. Mr. Broad said the Board would hear that the proposal would hurt the horses. He stated the Guild fundamentally disagreed with that idea. Riders that weighed 140



to 160 pounds routinely exercised thoroughbred horses. In foreign racing jurisdictions jockeys weighed from 123 to 125 pounds. In South Africa there were 20 tracks that raced five days a week and the jockeys weighed 125 pounds. Mr. Broad said the racing industry was full of anxiety over its future. He stated the Guild understood and shared such anxiety. The concern regarding the Guild's proposal was the effect on field sizes in California if it was the first racing jurisdiction to implement a weight increase. The Guild did not believe that would happen. Mr. Broad said a common suggestion was to make the weight increase national so that all jurisdictions followed the same standard. He stated the Guild was willing to take its proposal national, but the federal system in the United States meant the changes would have to be adopted state by state. The change had to start somewhere, and as California had a tradition of leading the nation, the Guild believed it would receive the first hearing of its case. Mr. Broad said the jockey profession was inherently dangerous, but the acceptable risks of the sport did not include kidney failure, diabetes or a significantly greater risk of disease. He stated he was sure the Board would do the right thing. Vice-Chairman Licht said it seemed some of the physicians were not advocating an increase in the weights, but rather were stating the weight loss techniques used by jockeys were not healthy. Mr. Broad said the letters spoke for themselves. Different physicians had different things to say on the issue, however, he did not think he had mischaracterized anything. Vice-Chairman Licht asked why existing jockeys would be grandfathered into the body fat content requirements. Mr. Broad said the Guild wanted jockeys to change their behavior. As a model the Guild used the introduction of safety helmets in professional hockey. He stated hockey had significant compliance almost immediately, as older players voluntarily complied. Existing jockeys needed to learn how to

live differently, and that could take education and a period of time to comply. However, if the Board felt the proposal was deficient, the Guild would understand. It simply did not want to introduce changes that would be disruptive to the current jockey colony. Commissioner Moretti asked if the Guild had plans to educate jockeys regarding proper nutrition and what they would need to do to accomplish the transition to healthy living. Mr. Broad said there was nothing in the proposal to fund or establish a government program to teach nutrition. He stated, however, the Guild had a strong incentive to inform its constituency. Nutrition education was an issue the industry should consider. Commissioner Sperry asked if there were any studies that reinforced the Guild's notion that new jockeys would comply a lot quicker than older jockeys. Mr. Broad said approximately 70 percent of the Guild's members would simply have to eat a little more, stop heaving or taking drugs, and they would quickly be in compliance. It was about 30 percent who would conceivably have problems. The Guild did not have to rush the rule. It wanted the rule in place, but it could take 18 months to two years to fully implement all the changes. Chairman Harris said the ADA raised the issue of a different base line for body fat between men and women. He asked if the Guild would object if a standard were created for women. Mr. Broad said the Guild reasoned that within horse racing men and women competed head to head. He stated the Guild thought about creating a standard of 12 percent for women, but there were many women who weighted 118 pounds or less and would not have a problem meeting the 5 percent standard. Chairman Harris said the issue was at 5 percent body fat a woman would be doing more damage to her kidneys. Dr. Seftel, a physician, said the difference in the 5 percent versus the 12 percent body fat was that female body fat had a slightly different composition. The reason there was a 12 percent

standard for women was for the protection of the reproductive system, which required additional body fat as an energy source. Dr. Seftel said he was not opposed to a difference of 5 to 12 percent on that basis. He said the Guild took a different approach as a matter of simplification, but from a physiological prospective, the 12 percent standard was preferred. Dr. Seftel stated the issue affected the health and welfare of the jockey community. He stated there was no medical or ethical justification for what many jockeys had to do to maintain weight. Dr. Seftel said he worked daily with jockeys who were dry, dehydrated, confused, and who fell off their mounts because they did not have any energy left in them. During his four-year studies Dr. Seftel said he demonstrated a ten-fold increase in kidney damage and failure in the jockey community as compared to the average population. He stated the average jockey in his colony had proteinuria on a daily basis, which meant their kidneys were leaking protein. Dr. Seftel said jockeys had eight times increase in a number of conditions, including laryngitis, bronchiolitis, urinary tract infections, and pharyngitis. The amount of antibiotics he prescribed for the jockey colony was eight times as was necessary for the population as a whole. In addition, jockeys were subject to antibiotic-associated complications such as diarrhea and the emergence of other multi-drug resistant organisms. Dr. Seftel said the issues that were raised were important and he hoped California could lead the nation in bringing a positive change to the racing industry. Chris McCarron of Los Angeles Turf Club (LATC) said he was in favor of raising the scale of weights. He said, however, he was not in favor of the Guilds proposals. Mr. McCarron stated the industry was conducting an extensive dialogue to arrive at a proposal that would be meaningful and acceptable to the jockeys. He said he believed the horsemen would eventually agree. Mr. McCarron stated he researched the body

fat issue extensively. He suggested the Board adopt the practice of the National Wrestling Coaches Association wherein body fat was measured only once a year. Body fat measurements were subject to a lot of inaccuracy if the proper tools and practices were not used. Often measurement devices could be off by several points. If the body fat was measured only once a year it could be done in such a way that the measurements would be true and accurate. As a racetrack manager, Mr. McCarron said he was most concerned with the potential impact the regulation would have on field size. To be done properly, however, the policy had to be implemented on a national scale. Mr. McCarron reiterated he was talking to Churchill Downs Incorporated and New York Racing Association and he was confident a proposal could be reached by January 2005. He added he was also concerned with the confusion the new weights might cause patrons. Chairman Harris said the current system had the same flaw. A jockey said to be 118 pounds in California was really carrying 122 pounds. Chairman Harris asked if Mr. McCarron supported the concept of 10-pounds of equipment. Mr. McCarron said he preferred the current system. Chairman Harris said he would like to hear about the practicality of measuring body fat on a daily basis. Dr. Seftel said the methodology for using the scales was standardized. He stated the bioelectric impedance method was internally consistent and had a low error rate if it was done according to procedure. He commented there was no debate in the industry regarding the overall measurement of total body fat. The consensus was the technology was doable and was recommended. Chairman Harris asked if body fat could be measured daily and the hydration issue addressed. Dr. Seftel said there were requirements that had to be logged each time the instrument was used, but if they were met, the technology was consistent. Mr. McCarron said he would not argue with Dr. Seftel, however, when he

measured his body fat using the hand-held device it was 15.9 on that scale. Then, when he measured his body fat on a scale that made such measurements, his body fat was 5.9. Mr. McCarron said he then used a third scale and his body fat measured 11.7. He stated the industry needed to make sure it knew exactly which devices it would use and have a certified physiologist or exercise coach with a license take the measurements. Rick Baedeker of Churchill Downs California Operating Company (CDCOC) said his organization supported increasing the scale of weights, however, the change needed to be national. Mr. Baedeker said CDCOC was in talks with Magna Entertainment (ME) and NYRA to implement a national policy. Chairman Harris asked if other states would be encouraged to enact similar rules if California implemented a rule that could go into effect in one year. Mr. Baedeker said the fact that California was talking about the scale of weights had stimulated other discussions, but he did not know if a rule would encourage other jurisdictions. He stated if the Board did not see national action on the issue within 60-days it might need to take the lead and implement a rule. Ken Marino, a horse trainer, spoke against the proposed amendment to the scale of weights. Warren Stew, a horse trainer, spoke in favor of the proposed amendment to the scale of weights. He stated, however, the industry should determine what added weight did to the horse. Sammy Schulman, a horse trainer, spoke in favor of the proposed amendment to the scale of weights. He asked, however, if the new scale would make the overweight obsolete. Chairman Harris said Board rules would allow the jockey to be overweight, but the 10-pounds of riding gear had to be 10-pounds. It was not counted against the overweight. Ed Halpern of California Thoroughbred Trainers (CTT) said his organization was not opposed to most of the proposals. He stated the Board faced the same dilemma as trainers because it might appear

unsympathetic while denying the amended rules. Mr. Halpern said CTT suggested the Guild hire persons to create diet and exercise program, and training regimens customized to jockeys. The CTT also wished to see the 5 percent body fat provisions approved with a reasonable time to comply. Third, the CTT suggested the industry determine, list and enforce true equipment. The CTT also proposed that the industry take time to completely study the weight issue. Mr. Halpern said CTT commissioned a review of scientific literature regarding the effects of weight on horses. He stated the results demonstrated that even small increases in weight could increase the risk of breakdowns over time. Mr. Halpern said CTT's was concerned with jockeys as well as horses. Every time there was a breakdown on the track jockeys risked serious injury or death. Jeanine Mahatti of CTT spoke against the proposed amendment to Rule 1615. Chairman Harris asked if there were any comments regarding the 5 percent body fat requirement. Mr. McCarron said he believed the 5 percent requirement was important. One effect of the requirement would be to prevent larger exercise riders from attempting to reduce down to make jockey weight. If they dropped below 5 percent body fat they would not be qualified to ride. Ron Ellis, a trainer, said it was an uncomfortable position to be speaking against the proposed rule. He stated every trainer knew jockeys and counted them as friends. However, he was not sure raising weights would solve jockeys' nutritional or health problems. Instead, heavier riders who had given up on becoming jockeys would try to meet the new weights and a secondary group of riders with similar problems would be created. Mr. Ellis said he had been training for twenty years, and had noted horses were not as sound as they used to be. To implement a rule that would run counter to the trend was not good judgment. Mr. Ellis said many people have worked hard to bring horses into California by reforming

workers' compensation and the introduction of performance fees at thoroughbred meetings. He stated the proposed rule would only be one more reason not to send horses to California. Dr. Rick Arthur, a veterinarian, said he was sympathetic with jockeys' weight problems and believed some adjustment in the scale of weights was appropriate. However, he stated the reason jockeys ride horses and people like he did not was weight was bad for horses. Dr. Arthur said everyone should recognize that horses were raced to the limit of their abilities, and too often they exceeded their limits. He stated the greatest threat to a jockey was not his weight, but the horse breaking down. Dr. Arthur said there was no way the upper weight limit could be increased without increasing the workload of the horse. He stated there had to be a way to balance those interests. Mr. Couto said the real question was: "what was the fair minimum weight to be applied?" TOC made a proposal that the minimum weight in California be increased from 112 to 115 pounds, which was a three-pound increase. In addition, TOC proposed that the five pounds of equipment be included in the program to disclose to the public that the minimum weight was actually 120 pounds, and that silks be standardized so that they do not vary in weight. Mr. Couto said TOC would also like weighing in and weighing out conducted live, in front of the public, or via video. Finally, the TOC believed nutritional counseling would help jockeys properly maintain their weight. Darrell Haire of the Guild said the jockey equipment currently weighed ten pounds. The proposed regulation did not change that fact. Mr. Haire said the Guild wanted full disclosure so that when a jockey weighed out and then came back in he had the same weight. Additionally, the weight increase under the proposed regulation was six-pounds, not 11. Vice-Chairman Licht said under the Guild's proposal the jockey would weigh 118 pounds and get on the scale with all his riding

equipment, which weighed 10 pounds. Under the TOC proposal the jockey would weigh 112 pounds with five pounds of equipment that was counted and five that was not. Vice-Chairman Licht said he was not making a value judgment, he was asking for a true representation of the numbers. It appeared to him the TOC was adding 11 more pounds. Chairman Harris said if, under current rules, one looked at the 118 minimum the jockey would weigh 113 pounds and have five pounds of equipment, with another five pounds that was not disclosed. The horse would actually carry 123 pounds. Albert Fiss of the Guild said the trainer would add his own pad, which weighed two pounds more than the pad the jockey weighed out with. That constituted another hidden weight. Mr. Couto said the scale of weights to which the Guild refers was the historical scale that only applies in the absence of conditions. Based on the condition book and agreements with TOC and the racing office, 112 pounds was the accepted minimum weight. Under current regulations if the minimum were 112, the jockey would weigh 107 pounds and carry five pounds of equipment. Vice-Chairman Licht asked if the horse were assigned 118 pounds, how much would the horse carry? Mr. Couto said five pounds of equipment would be added for 123 pounds, and under the new regulation it would carry 134 pounds. Vice-Chairman Licht said he believed the minimum weight should be raised minimally; the proposed regulation was too extreme. If the five percent body fat requirement was retained, there should be no grandfather clause. Commissioners Sperry and Moretti stated they agreed with Vice-Chairman Licht. Commissioner Sperry added he thought there should be full disclosure of the ten-pounds of riding gear. Commissioner Moss said he believed a three-pound increase was appropriate. In addition, the concept of a national initiative in place by January 2005 should be looked at strongly. Commissioner Bianco stated he agreed with the



three-pound minimum weight increase. He commented an allowance should be made for female jockeys body fat requirements. Chairman Harris said the grandfather clause should be reduced for a shorter phase-in time. The ADA recommendations regarding body fat for female riders were important and needed consideration. In addition, more disclosure regarding the true weight of riding equipment was also important. Chairman Harris commented the current system was flawed and lacked transparency. He stated the proposed regulations needed to be reworked and brought back before the Board for further discussion.

**DISCUSSION AND ACTION BY THE BOARD FOR THE 45-DAY NOTICE ON THE PROPOSED REGULATORY AMENDMENT TO CHRB MEDICATION RULES 1843.5, 1844 AND 1845.**

---

Dr. Ron Jensen, CHRB Equine Medical Director, said the Racing Medication Testing Consortium (RMTC) was established to bring national uniformity to racing medication rules. He stated the RMTC was composed of industry representatives and included several persons from California's industry. The proposed amendments to Board rules 1843.5, Medication, Drugs and Other Substances Permitted After Entry in a Race, 1844, Authorized Medication and 1845, Bleeder List, would incorporate the recommendations of the RMTC. Dr. Jensen stated the Medication Committee met on August 13, 2004, at Del Mar and approved the proposed regulations with some modifications. Dr. Jensen reviewed the changes the Medication Committee made to the proposed text. Chairman Harris asked if all the changes were in compliance with the RMTC recommendations, and if there had been any concerns voiced about losing horses to Kentucky due to that states less strict regulations. Dr. Jensen said the recommendations were in line with the RMTC recommendations. He added several

California racing associations were represented on the RMTC committee and there had been no concerns about Kentucky voiced. Dr. Jensen said the Medication Committee recommended the proposed regulations be noticed for a 45-day public comment period. Commissioner Bianco **motioned** to direct staff to initiate a 45-day public comment period for the proposed amendment to Board rules 1843.5, 1844 and 1845. Commissioner Sperry **seconded** the motion, which was **unanimously carried**.

**PUBLIC HEARING BY THE BOARD ON THE ADOPTION OF THE PROPOSED REGULATORY AMENDMENT OF CHRB RULE 1846.5 - POSTMORTEM EXAMINATION.**

---

Dr. Ron Jensen, CHRB Equine Medical Director, said the proposed amendment to Board Rule 1846.5, Postmortem Examination, would add two items to the CHRB-72, Necropsy Submission Form. The form was incorporated by reference into the regulation, so any changes to it necessitated an amendment. Dr. Jensen said the first change provided a place to indicate if there had been a human injury associated with the horse submitted for postmortem examination. The second change involved one word. Test samples take from the carcass during the postmortem examination "may" be take instead of "shall" be taken. Dr. Jensen stated it was not always necessary to take such test samples. The change will allow taking of test samples on a case-by-case basis. Commissioner Moss **motioned** to adopt the proposed amendment to Board Rule 1846.5. Commissioner Sperry **seconded** the motion, which was **unanimously carried**.

**DISCUSSION AND ACTION BY THE BOARD ON THE REQUEST OF THE LOS ANGELES TURF CLUB TO DISTRIBUTE \$262,800 IN CHARITY RACING PROCEEDS TO 44 BENEFICIARIES.**

John Reagan, CHRB staff, said the request by the Los Angeles Turf Club (LATC) to distribute \$262,800 in charity racing proceeds was in order and staff recommended approval. Commissioner Sperry **motioned** to approve the request by LATC to distribute charity racing proceeds. Commissioner Moss **seconded** the motion, which was **unanimously carried**.

**DISCUSSION AND ACTION BY THE BOARD ON THE REQUEST OF THE PACIFIC RACING ASSOCIATION TO DISTRIBUTE \$60,000 IN CHARITY RACING PROCEEDS TO 12 BENEFICIARIES.**

John Reagan, CHRB staff, said the request by the Pacific Racing Association (PRA) to distribute \$60,000 in charity racing proceeds was in order and staff recommended approval. Vice-Chairman Licht **motioned** to approve the request by PRA to distribute charity racing proceeds. Commissioner Moretti **seconded** the motion, which was **unanimously carried**.

**DISCUSSION AND ACTION BY THE BOARD ON THE REQUEST BY CAPITOL RACING, LLC CONCERNING THE LOCATION AND AVAILABILITY OF THE SATELLITE SIGNAL AT THE LOS ALAMITOS RACE COURSE.**

Executive Director Roy Wood, Jr., stated the parties requested the item be **tabled**.

**REPORT BY REPRESENTATIVES OF THE CALIFORNIA ANIMAL HEALTH AND FOOD SAFETY LABORATORY ON THE POSTMORTEM PROGRAM.**

Chairman Harris said the item was **tabled**.

**DISCUSSION BY THE BOARD ON THE RECENTLY PUBLISHED REPORT OF THE CALIFORNIA PERFORMANCE REVIEW COMMISSION AND ITS SPECIFIC RECOMMENDATIONS CONCERNING THE CALIFORNIA HORSE RACING BOARD.**

---

Executive Director Roy Wood, Jr., said the California Performance Review (CPR) committee scheduled hearings to receive information from the public regarding its recommendations. Executive Director Wood stated the industry was encouraged to become involved in the process so the importance of horse racing to California could be explained. Chairman Harris said he did not envision the CHRB disbanded without some way for the industry to be regulated for the benefit of the fans and the public, unless it was completely deregulated. He stated there might be functions that could be integrated into different parts of government. Executive Director Wood said the CPR recommendation was to fold the Horse Racing Board into the Consumers Affairs Protection Agency and some of the investigative functions into the Department of Justice. He stated the CPR recommendations had a long way to go before they were approved. Chairman Harris asked if there was a plan to move the recommendations forward. Executive Director Wood stated the CPR hearings would determine how the recommendations would be adopted. They might have to go through the legislature, or they might require a constitutional amendment.

He stated the compact also prohibited any other entity within a 35-mile radius from having slot machines. Chairman Harris commented the industry needed to be aware of the compact. Commissioner Moss asked if anything had been done to accomplish what racing interests in other states enacted. He said in some states tracks were receiving money from Indian gaming without having slots at racetracks. Commissioner Harris said overtures were made but nothing resulted from them. Mary Frances Rowe, a horse owner, said she wished to receive a list of all the drug positive tests results from the years 2001 through July 2004. She wished to have the trainer's name, the name of the horse and the illegal drug detected, as well as any disciplinary action taken. Deputy Attorney General Derry Knight said the Horse

Racing Board responded to Ms. Rowe in a letter dated August 18, 2004, which he signed. He stated Ms. Rowe would be provided with the information she requested.



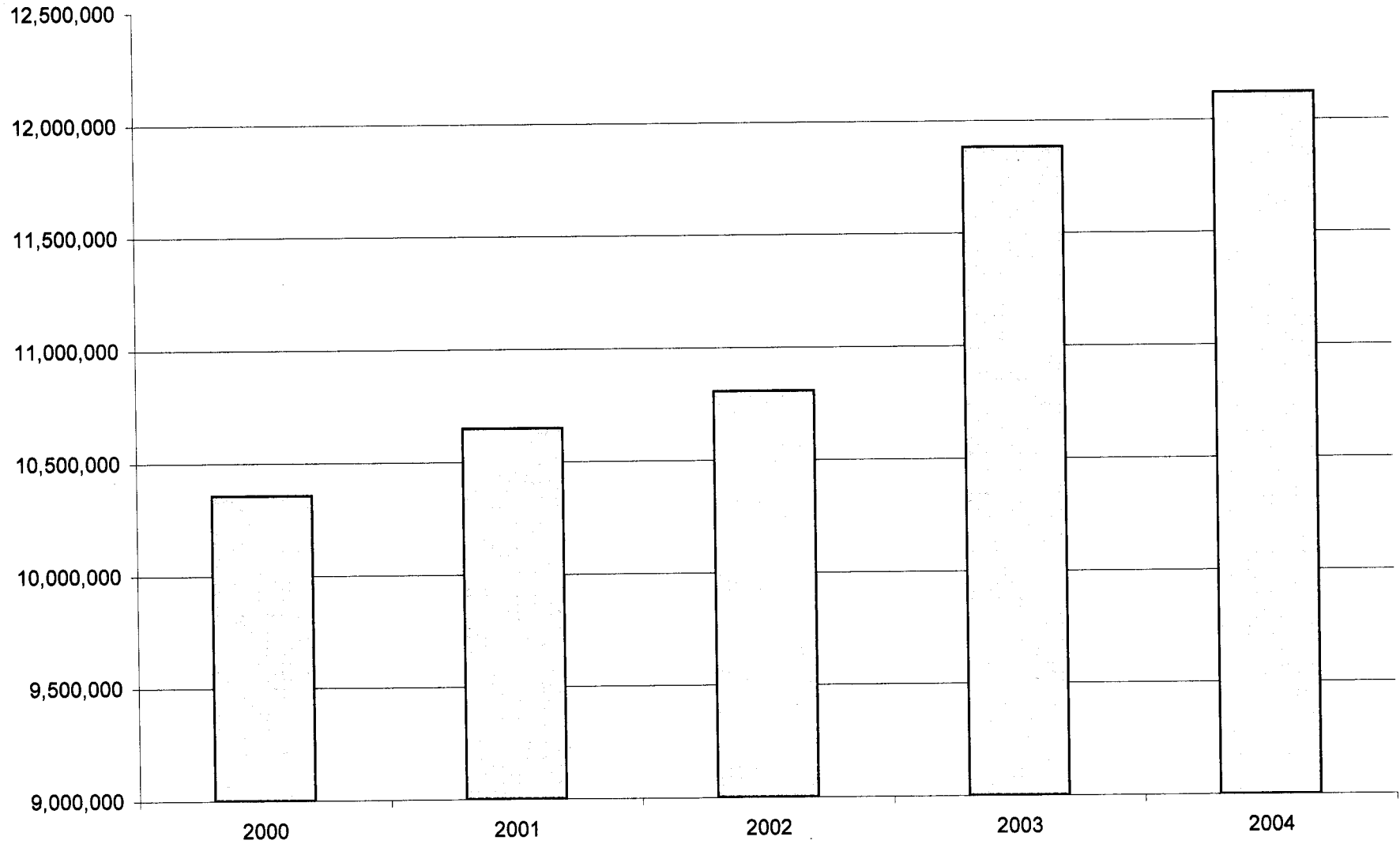

PARIMUTUEL LICENSING FEES



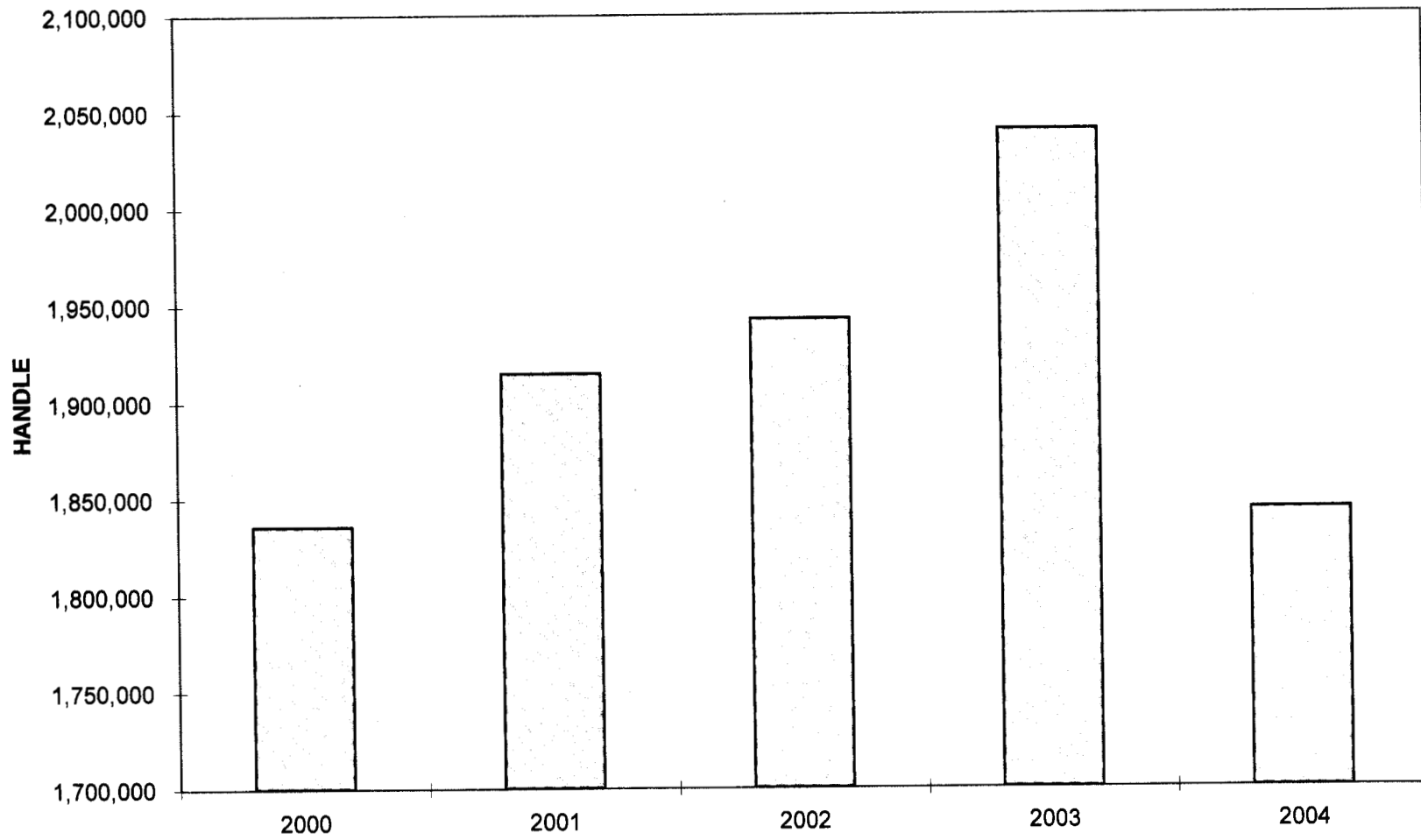
