STAFF ANALYSIS UPDATE AND DISCUSSION REGARDING LATE ODDS CHANGES AND STEPS BEING TAKEN TO PROTECT THE INTEGRITY OF THE PARI-MUTUEL POOLS

Pari-Mutuel Operations Committee February 21, 2007

BACKGROUND

While significant late odds changes seem to be occurring less frequently, they do occasionally still occur. At the January 2007 Regular Board Meeting, representatives of Scientific Games updated the Board on technological changes that address this issue. Scientific Games is prepared to provide a more detailed presentation to the Committee, including a description of improvements in technology and data transmission related to its new data center in Sacramento and a national update on the issue.

STAFF ANALYSIS DISCUSSION REGARDING WAYS TO PROTECT THE WAGERING PUBLIC WHEN SIGNIFICANT LATE CHANGES OCCUR

Pari-mutuel Operations Committee February 21, 2007

BACKGROUND

The Board has received comment regarding the need to protect the wagering public when significant late changes occur that affect one or more horses in a race about to be run. One issue is the late announcement that a horse was gelded since its last start. Another concern involves the late scratch of part of an entry. Such late changes can be particularly significant if they occur after the first leg of a multiple-race wager has been run, as patrons already locked into their selections could not use the new information to their advantage. Board Rule 1974, Wagering Interest, provides that when one part of an entry is scratched, the remaining part of the entry continues as a viable wagering interest. The National Thoroughbred Racing Association Player's Panel has recommended that if one part of an entry is scratched, the remaining part runs for purse only. The Committee may wish to consider the Player's Panel recommendation. Board Rule 1865, Altering Sex of Horse, requires the reporting of a gelding within 72 hours of such gelding. However, the gelding of a horse is not always reported in a timely manner. Although gelding and scratched entries are the most common late changes, other issues arise from time to time. To protect the wagering public, it has been suggested that the Board adopt a more general rule that would give the stewards the option to have a horse race for purse money only when significant circumstances warrant such action.

STAFF ANALYSIS DISCUSSION REGARDING PARI-MUTUEL ISSUES THAT COULD BE ADDRESSED AT FUTURE COMMITTEE MEETINGS

Pari-Mutuel Operations Committee February 21, 2007

BACKGROUND:

The Pari-Mutuel Operations Committee encourages the industry and the public to suggest ways of improving the operation of California's pari-mutuel wagering system, including but not limited to suggestions for new wagers, ways of improving existing wagers, and other matters relating to the overall wagering experience. For example, one such discussion led to the amendment of CHRB Rule 1976.9, Pick (n) Pool to allow for alternate selections in the Pick 6, a popular change that has since been adopted in other racing jurisdictions.

RECOMMENDATION:

Staff recommends that the Committee hear from interested parties regarding this matter.
