Attached with this email are four spreadsheets containing two proposals, versions A & B, for 2006 races dates at Hollywood Park. Those proposals are shown both with and without anticipated dates for other associations.

1. The first proposal, 2006 A, mirrors the calendar approved by the Board for 2005. The only change is the elimination of Wednesday racing following Memorial Day.
2. The second proposal, 2006 B, is offered in response to Santa Anita's anticipated proposal to extend its winter meet by one week. The same argument was made last year, at which time we reminded the Commissioners that the week in question was eliminated by the CHRB in 2001 when it mandated a Christmas break. Please note the following from a letter I sent to the CHRB a year ago:

Christmas Break. Magna has argued that running through Christmas Eve has been the traditional calendar. But to refresh both fans and the horses, the CHRB mandated a Christmas break in 2001 and began a new tradition.

In mandating the break, the Board reasoned that it would be unfair to penalize Hollywood Park by cutting off the final week of its Fall meet while rewarding Santa Anita with a business windfall for the beginning of its ensuing winter meet. In other words, Santa Anita would have been dramatically helped, Hollywood Park dramatically harmed. So the Board shifted the calendar forward, eliminating the final week of the Santa Anita winter meet.

Our proposal "B" provides an alternative for the Board if it determines that Santa Anita should receive an extra week of racing. The calendar is returned to its pre-2001 format with the calendars for all associations

moved forward (towards the end of the year) by one week, thus eliminating the Christmas break.

Please note that Proposal A is our strong preference.

Finally, Hollywood Park is open to experimenting with four day weeks during the final two weeks of our Fall meeting, should the Board, after concurring with labor and horsemen, desire to do so.

Oak Tree would like to request alternative racing dates:

**Alternative 1**

Should Hollywood Park no longer be owned and operated by Churchill Downs Inc., Oak Tree requests the following dates for 2006. Open on Friday, September 29, and run through December 10 with the exclusion of Mondays and Tuesdays occurring during this time period except for Columbus Day, October 9, when we would operate.

We are asking for a later than normal opening to allow a break between Fairplex's closing Monday and Oak Tree's opening day and, in addition experiment with a Friday opening which would provide for good racing the entire weekend. We would propose ending the meet on December 10 (54 days) to allow a 15-day break before the commencement of Santa Anita's historical opening. This break has been sought by TOC over recent years and we believe it should be attempted on a trial basis.

**Alternative 2**

Oak Tree's policy has been not to request dates normally allocated to other racing association; therefore, if Hollywood Park continues to be owned and operated by Churchill Downs, Inc., we would request the dates September 27 through October 29 excluding all Tuesdays falling within this time period and all Mondays within this time period except Monday, October 9, Columbus Day. (26 Days)

Per the attached chart which displays our suggestions for the 2006 racing calendar, Bay Meadows and the San Mateo County Fair propose the following:

Bay Meadows Racing Association:

Racing on a Wednesday through Sunday schedule, with exceptions noted:

Winter/Spring meet: 70 days  
Wednesday, February 1<sup>st</sup> through Sunday, May 7<sup>th</sup>  
Exception to normal schedule—open Monday, February 20<sup>th</sup> (Presidents' Day), dark  
Wednesday, February 22<sup>nd</sup>

Fall meet: 33 days  
Saturday, September 2<sup>nd</sup> through Sunday, October 15<sup>th</sup>  
Exceptions to normal schedule—open Monday, September 4<sup>th</sup>, (Labor Day), dark  
Thursday, September 7<sup>th</sup> (assumed to be a dark day in Southern California)  
Open Monday, October 9<sup>th</sup> (Columbus Day)

Total 103 days, one less than in 2005

The proposed schedule is similar to that in place for 2005, excepting the elimination of the six day live race week conducted during the Presidents' Day holiday week.



The California Authority of Racing Fairs, on behalf of San Joaquin Fair, Alameda County Fair, Solano County Fair, Sonoma County Fair, Humboldt County Fair, San Mateo County Fair, California State Fair and Fresno District Fair, would like to thank you for the opportunity to respond to your request for proposals regarding the 2006 Racing Calendar.

Northern California racing Fairs propose that June 14 through September 4, 2006, and October 4 through October 15, 2006, inclusive, be allocated as Fair racing dates in Northern California. This schedule represents a total of 89 racing days. We request that these dates be allocated with no overlapping dates in the Northern zone.

As the Board deliberates on the 2006 Racing Calendar, we ask that it bear in mind the following considerations.

**1) Fairs have the longest commitment to racing in this state, having conducted racing in California for over 150 years.** Fairs and racing also share a political heritage, one that has served the racing industry well for over seventy years. To this day, horse racing law cites "supporting the network of California Fairs" and "Encouraging agriculture and the breeding of horses in this state" as the statutory reasons for allowing parimutuel wagering on horse racing. Fairs are a vehicle through which the Legislature has chosen to distribute the economic benefits of horse racing to local communities and to the agricultural sector. Revenues derived from horse racing help sustain overall Fair activities, activities which are an important part of the fabric of California life.

**2) Development of fan base: Last year over 2,650,000 Californians attended the Northern California Fairs that conduct racing.** Fairs represent one of the best ways to create new racing fans. Last year over 2,650,000 Californians attended the eight Northern California Fairs that conduct racing. Fairs are strengthening

their fan education programs to introduce new fans to racing. Come to the races at Pleasanton or Santa Rosa or Fresno and you'll find a Grandstand filled with racing fans. Fairs connect racing to wholesome, family-oriented activities.

**3) Fairs have a major stake in the future of California racing.** Seven of the nine race tracks in Northern California are located at Fairs. In the last five years, the seven Northern California Fairs that own and operate race tracks have invested over \$8,000,000 in racing facility improvements: \$ 5,000,000 in back stretch improvements and \$3,000,000 in racing surface upgrades through our Race Track Safety and Maintenance program. In addition, Sonoma County Fair has just invested \$3,000,000 in a new Turf Course. Statewide, Fairs operate twenty-three satellite wagering facilities; these facilities represent a substantial capital commitment to horse racing. In that same five-year time frame, Fairs have invested over \$7,500,000 in satellite facilities; \$3,500,000 in satellite facility equipment, maintenance and upgrades plus another \$4,000,000 to build a new satellite facility in Lancaster. These investments reflect Fairs' commitment to California racing for the long run.

**4) Fairs are publicly-owned venues that will continue to offer racing after privately owned race tracks are developed for other purposes.** Privately owned race tracks are coming under increasing economic pressure to develop the real estate on which they sit. We are seeing that scenario unfold as the present owners of Bay Meadows actively pursue plans to develop their race track property for commercial and residential use. Fairs, on the other hand, are planning for and investing in a long, active future in racing. We believe that economic forces will move California racing toward the prevailing economic model for most major league sports: privately-owned franchises operated at publicly-owned venues. Fairs intend to be a part of that future. Del Mar, one of the most successful racing operations in the country, already operates under such a model, with grounds and grandstand owned by the San Diego County Fair leased to the Del Mar Thoroughbred Club.

**5) Fairs need racing dates without overlap to ensure that they will be financially strong, viable and active participants in the future of racing in Northern California.** It's the consensus of most industry observers that overlapping dates are not good for racing. Fairs agree. We propose that a simple standard be applied to the decision: reduce overlapping dates in favor of those who are investing and building for the future. Fairs are investing in their racing facilities in anticipation of a long future in the racing industry. Why should Fairs, who have demonstrated a commitment to racing, be obliged to conduct racing on dates that overlap with a race track whose owners' stated intention is to leave Northern California racing? We urge the Board to lay the groundwork for a successful future beyond 2006, when the Northern California Racing Calendar may no longer include both the privately-owned race tracks that presently operate.


**6) California's Central Valley is one of the fastest-growing regions in the state; San Joaquin Fair, State Fair and Fresno Fair deserve dates without overlap to present high quality racing in this important and growing market.** We ask that the Board consider population trends as it considers the public interest in the allocation of dates. The California public is on the move: population is shifting from coastal urban areas to inland locations. San Joaquin Fair (Stockton), the California State Fair (Sacramento) and Fresno District Fair are all located in this important and growing inland market. Californians in these markets deserve the same high quality racing as that offered at other venues in Northern California.

In closing, we would like to emphasize again that Fairs have the longest heritage of racing in California and that Fairs are committed to preserving the value of that heritage by investing and building for the future. Fairs have a major stake in California racing, owning nine race tracks and twenty three satellite facilities. Fairs are publicly-owned entities whose racing profits stay in California and are re-invested in their local communities, generating jobs and significant economic impact. Fairs will continue to be an important part of California's social fabric and agricultural economy long into the future.

As an indication of the Fairs' commitment and accord, this letter is signed by CEO's of Fairs that conduct racing in Northern California.


In response to recent correspondence distributed by the California Horse Racing Board, please accept this letter as representing the Humboldt County Fair Association's request for racing dates in 2006.
