### **OPENING DAY ENTRIES**

The Cal Expo stewards' office was open today during the first day of entries. Following the recently concluded (August 2<sup>nd</sup>) standardbred meeting, the racing and stewards' office have been well cleaned with walls cleaned and floors waxed. The stable area appears in good shape. Numerous stalls have been repaired and many stalls leveled with material. This has been a large undertaking in a short amount of time as many standardbred trainers have been stabled in the same location since the last time the thoroughbreds raced here (September 2004).

License approvals, designated race list and horse eligibility checks were some of the duties today.

# **SECOND DAY ENTRIES / SCRATCH TIME**

Entries were taken today for the second day of racing. Scratch time was at 9:00 a.m. with only two (2) jockey changes taking place.

## **THIRD DAY ENTRIES / SCRATCH TIME**

Entries were taken today for the doubleheader card (16 races total) that was originally scheduled for Friday, August 22<sup>nd</sup>.

The doubleheader card of sixteen (16) races scheduled was not successfully filled. Only ten (10) races were filled. Director of Racing **Dave Elliott** contacted CHRB Executive Director Kirk Breed on this Sunday afternoon and was given permission to conduct a single card only with a post time change to 2:45 p.m.

#### **WEDNESDAY**

## 08-20-08<sup>1</sup> **OPENING DAY**

The mules, quarter horses and thoroughbreds returned to the California State Fair for the first time since 2004. The only holdovers from the Cal-Expo 2004 Racing Official ranks and their current positions are Will Meyers (Steward), Grant Baker (Racing Secretary/Steward), Danny Winick (Patrol Judge), Matt Nichols (Assistant Clerk of Scales), Cheryl White (Clerk of Scales), Darrel Sparks (Horse Identifier), Troy Thomas (Horseshoe Inspector) and Robert Mooneyhan (Starter).

The majority of the racing office staff are racing officials who have worked Golden Gate Fields, Bay Meadows and the first three (3) stops of the summer Fair Circuit. This is the first time since 1988 that the California State Fair has been held as the lone racing meet (non overlapped) in Northern California.

# 08-20-08<sup>2</sup> JUDGES' STAND VISITORS

CHRB Executive Director **Kirk Breed** came 'across the street' to visit the stewards' stand during this opening day card. The State budget situation was discussed as California Horse Racing Board stewards (contractual employees) are, as of today, three (3) weeks late in receiving their July 2008 paychecks. Later in the afternoon Jockey's Guild Regional Manager **Darrel Haire** visited the stewards as he often does on 'opening days' throughout the West.

# 08-20-08<sup>3</sup> INQUIRY – NO CHANGE – Ninth Race

The stewards posted the inquiry sign immediately following this race in order to review the start. Second place finisher #6 PRANCIN' N DANCIN' (Roberto Gonzalez) was turned inward at the break in an incident which involved first place finisher #4 RUSTRIDGE BO (Kyle Kaenel), seventh place finisher #5 INVESTIGATOR WUNNO (William Antongeorgi) and fifth place finisher #7 LORD LATIGO (Frank Alvarado).

Race replays show that #6 PRANCIN' N DANCIN' caused the majority of his own problems by breaking inward and tipping himself badly at the start. #4 RUSTRIDGE BO does contribute to the incident by breaking outward, however, the stewards unanimously voted that no change be made in the order of finish. Jockey Kyle Kaenel was ordered to the stewards' office for film review tomorrow.

### 08-21-08<sup>1</sup> **RULING NO. 1 – DEKELAITA**

Jockey Agent **NATE DEKELAITA** is fined the sum of one hundred dollars (\$100.00) pursuant to California Horse Racing Board rule #1530 (Cases Not Covered by Rules and Regulations) for failure to conduct his business in the proper manner on Sunday, August 17, 2008.

REFUND: \$ 351.10

The stewards informed jockey agent **Nate Dekelaita** of the ruling above via telephone. Agent Dekelaita mistakenly entered the horse FLAMING PRINCESS (# $1-9^{th}$  race, August  $22^{nd}$ ) for the claiming price of \$25,000. This horse was claimed for \$25,000 on August  $9^{th}$  and was still 'in jail' at the time of entry. This translates to entering an ineligible horse.

# 08-21-08<sup>2</sup> KYLE KAENEL FILM REVIEW

Jockey **Kyle Kaenel** appeared in the stewards' office to review the start of yesterday's ninth race. Kaenel was aboard the winner #4 RUSTRIDGE BO. This horse broke outward in this mile and one-sixteenth race. Jockey Kaenel's efforts in straightening his mount were reviewed.

The stewards informed Kaenel that swifter efforts should be made at the start.

## 08-21-08<sup>3</sup> **ROOF VISITOR**

CHRB Assistant Executive Director **Richard "Bon" Smith** trekked upstairs to visit the stewards today.

## 08-21-08<sup>4</sup> INQUIRY – NO CHANGE – Fifth Race

The stewards posted the inquiry sign to review the start of the fifth race. #8 SWORD LEGEND (odds 7/2) was fractious prior to dispatch. This horse was set; however, when starter Robert Mooneyhan opened the gates, SWORD LEGEND threw his head and was off eight (8) lengths behind the rest of the field. All horses were given a fair start. No change was made in the order of finish.

## 08-22-08<sup>1</sup> **VET'S LIST ISSUES**

Trainer **Ronnie Wallace** called the stewards today regarding a Vet's List issue. Trainer Wallace is currently stabled at the Alameda County Fairgrounds in Pleasanton and is seeking a licensed track veterinarian in order to observe a morning workout with the goal of having his horse removed from the Vet's List.

Cal Expo has chosen not to provide a track vet at auxiliary stable areas which is counter to what prior CARF (California Authority of Racing Fairs) affiliates (Pleasanton, Vallejo, Santa Rosa and San Mateo) have done.

# 08-22-08<sup>2</sup> INQUIRY / OBJECTION – DISQUALIFICATION – Second Race

The stewards posted the inquiry sign immediately following this race to review an incident in mid-stretch. There was also a jockey's objection in this race when original second place rider **Edgar Montehermoso** (#5 BAR JF ROCK ON ) claimed foul against original first place finisher #3 BAR JF FLYIN J (**Jesus Arriaga**).

#3 BAR JF FLYIN J veered out sharply in mid-stretch forcing #6 BAR JF ROCK ON off his straight path. The stewards spoke with both riders involved and received a patrol judge report.

The majority of the stewards (Steward Nicolo dissenting) ruled that this incident cost #6 BAR JF ROCK ON an opportunity for a better placing. **#3 BAR JF FLYING J** was disqualified and placed second.

Jockey Jesus Arriaga was ordered to the stewards' office tomorrow.

# 08-22-08<sup>3</sup> INQUIRY – NO CHANGE – Seventh Race

#2 FRISCO FOX

The stewards posted the inquiry sign in order to review the stretch run of the seventh race. First place finisher #7 SEA GULL SEZ (Catalino Martinez) drifted outward from the 1/16 pole to the finish line. Second place finisher #8 CRAIG'S STORM (Barrington Harvey) followed this horse outward as jockey Harvey was utilizing a left handed whip during the final 1/16 of a mile in this race.

The stewards spoke with both riders involved and received a patrol judge report. The stewards determined that there was no contact between horses. It was unanimously decided that no change be made in the order of finish.

Jockey Catalino Martinez was ordered to the stewards' office tomorrow.

Jockey **Catalino Martinez** appeared in the stewards' office as ordered to review his winning ride aboard #7 SEA GULL SEZ in yesterday's (August 22) seventh race. During the stretch drive in this race jockey Martinez allows his mount to drift out from the 1/16 pole to the wire. There was an inquiry into this race with no change being made.

Jockey Martinez has ridden well (safely) for the last twenty four (24) days of Fair Circuit racing. The stewards considered this before deciding not to issue a penalty in this matter. Warning issued.

Starter **Robert Mooneyhan** was feeling the effects of the heat (95 degrees) today and took off the ninth and tenth races. Licensed backup starter **Eddie Garza** dispatched the fields for these races.

# FILM REVIEW - RULING NO. 3 – ARRIAGA (Ref: 08-22-08<sup>2</sup>)

Jockey **Jesus Arriaga** appeared in the stewards' office to review his ride aboard the mule BAR JF FLYIN J who was disqualified and placed second in the second race on August 22<sup>nd</sup>. In this race jockey Arriaga drifts all over the racetrack with both a left and right handed whipping action.

Jockey Arriaga was instructed to concentrate on keeping mules and horses straight by using his bridle reins and not with his whip. He understood the stewards reasoning in issuing the following ruling.

Jockey **JESUS ARRIAGA**, who rode **BAR JF FLYIN J** (mule) in the second race at the California State Fair on Friday, August 22, 2008, is suspended three (3) racing days (August 30, September 2 and 3, 2008) for failure to make a proper effort to maintain a straight course in mid-stretch and causing interference resulting in the disqualification of his mount from first to second; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

# 08-24-08<sup>2</sup> NEW TRACK RECORD

In today's second race the mule BAR JF RED TICKET set a new track record for the distance of three hundred and fifty (350) yards. The final time of 20.25 eclipses the former track record set by world champion mule BLACK RUBY (20.61) on September 2, 2004.
