OFFICE OPEN

Steward Will Meyers was on duty today. Completion of Alameda County Fair (Pleasanton) minutes, office set-up and a conversation with racing supervisor Kate Phariss were on the docket.

OFFICE OPEN

Steward Grant Baker was on duty today. Review of workout and licensing issues for the first three (3) days of the California State Fair meet were addressed. The judges' stand was inspected in order to assure functionality for tomorrow's (July 14) opening day card.

Wednesday07-14-10¹**ADMISSIONS**

The general admission price for the 2010 California State Fair is twelve (12) dollars. This is the general admission price for entrance to the fair and/or racing grandstand.

07-14-10²**VETERINARIAN VISIT**

Track/Fitness Veterinarian Audrey Clifton stopped by the stewards' office this opening day morning. Dr. Clifton is in her third season here at Cal Expo. The stewards reviewed communication protocol with her track veterinarian position that will take place during this ten (10) day stand.

07-14-10³**ED-AED VISIT**

CHRB Executive Director Kirk Breed and Assistant Executive Director Richard 'Bon' Smith traveled across the street from headquarters to discuss racing matters with the stewards on this opening day of the California State Fair.

07-14-10⁴**RULING NO. 1 – BURMAN**

Jockey **JENNIFER BURMAN**, who was scheduled to ride FEVER RELIEVER in the sixth race at the Alameda County Fair (Pleasanton) on Sunday, July 11, 2010, is hereby fined the sum of one hundred dollars (\$100.00) for violation of California Horse Racing Board rule #1872 (Failure to Fulfill Jockey Agreement) causing a late rider change.

Jockey Jennifer Burman called the stewards prior to the sixth race Sunday, July 11 at Pleasanton. She hasn't ridden for a while and she told the stewards she felt she was not ready to ride today's one (1) mile and seventy (70) yard distance.

07-14-10⁵ **RULING NO. 2 – ARRIAGA**

Jockey **Gregorio Arriaga** appeared in the stewards' office today to review his ride aboard #5 CHECK THIS DREAM, who finished third in the first race July 11, 2010 at Pleasanton. #5 CHECK THIS DREAM was disqualified and placed fourth in this race for failure to maintain a straight course in this Quarterhorse race. (Ref: 07-11-10⁵)

Film review with the stewards shows jockey Arriaga veer in under right handed whip in this race's later stages putting much pressure on #3 BARRY SNOW MERRI (Rodrigo Maldonado). Jockey Arriaga told the stewards he felt he could have done a better job in this race. The stewards unanimously ruled to issue the following ruling.

Jockey **GREGORIO ARRIAGA**, who rode CHECK THIS DREAM in the first race at the Alameda County Fair on Sunday, July 11, 2010, is suspended three (3) racing days (July 21, 22 and 23, 2010) for failure to make the proper effort to maintain a straight course in the stretch and causing interference resulting in the disqualification of his mount from third to fourth; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

07-14-10⁶ **ANOTHER VISIT**

Jockeys' Guild Manager Darrell Haire and Johanna Alvarez (AOC Insurance Services – San Francisco) visited the judges' stand on this opening day. Ms. Alvarez was here to provide insurance information to Cal-Expo jockeys.

07-14-10⁷ **INQUIRY – NO CHANGE – Second Race**

The stewards posted the inquiry sign following this race after viewing fourth place finisher #3 QUICK SPANISH SLICE (Rodrigo Maldonado) drift out in the last one hundred (100) yards of this race. This action forced fifth place finisher #4 HI DOLLAR HART (Luis Godoy) out of any chance of racing in a straight course.

#4 HI DOLLAR HART was beaten a 'neck' for fourth place. The stewards spoke with both jockeys involved and received a patrol judge report. The majority of the stewards (Baker dissent) felt this incident did not warrant a disqualification. No Change.

07-14-10⁸ **INQUIRY – DISQUALIFICATION – Seventh Race**

The stewards posted the inquiry sign after viewing a three (3) horse incident inside the 1/8 pole. Three (3) horses are across the track at this point. From inside out, a) original eighth place finisher #5 MT. ORIENT (Frank Alvarado) b) original sixth place finisher #7 TACO WILLY (Enrique Gonzalez) and c) original third place finisher #3 BALLETT WAY (Abel Cedillo).

Race replays show #3 BALLETT WAY veer inward under apprentice jockey Cedillo's right handed whip. This action forces #7 TACO WILLY to steady very sharply from between horses. #5 MT. ORIENT also was forced to 'check' during this incident. The stewards also received a patrol judge report following this race.

In a unanimous decision the stewards ruled to disqualify #3 BALLETT WAY and place him eighth. Apprentice jockey **Abel Cedillo** was ordered to film review.

07-14-10⁹ **CAMERA PROBLEMS**

Pegasus Communications (Video Production) experienced camera difficulties during races six (6), seven (7) and eight (8). The head on (7/8th shot) had a horizontal bar running through the middle of the TV screen making the live and replay views very difficult to discern for officials and fans alike.

Thursday07-15-10¹ **PRE-HEARING MEETING**

An informal hearing was held today in the stewards' office to address a matter involving Pony Boy/Exercise Rider **ADAN CHAVEZ**. Golden Gate Fields stable security issued Chavez a 'violation notice' on July 11, 2010. The violation notice alleged that Chavez failed to care for his horse (pony) and that at least one (1) horse was without water for several hours.

Along with the stewards present today were Pony Boy/Exercise Rider Adan Chavez, interpreter Jennifer Lee, CHRB Supervising Investigator I Martin Snezek and CHRB Senior Special Investigator Barbara Chimero.

After much discussion it was decided that this matter will be heard in a formal hearing proceeding on Saturday July 24, 2010 at 10:00 a.m. at Cal Expo.

07-15-10² **INQUIRY – NO CHANGE – Second Race**

The stewards posted the inquiry sign following this race after viewing first place finisher #6 THE RIGHT SUSPECT (Jesus Arriaga) and second place finisher #1 BENS BAC (Gregorio Arriaga) make contact about fifty (50) yards before the finish. Race replays show #1 BENS BACK drift out and bump the first place finisher #6 THE RIGHT SUSPECT. In a unanimous vote, the stewards made no change in the order of finish. Jockey Gregorio Arriaga was ordered to film review with the stewards.

Friday07-16-10¹ **PROVISIONAL EXERCISE RIDER TESTS**

Francisco Maldonado, Jesus Garcia and Arturo Castaneda were given the written test this morning. Maldonado passed with 88%. Garcia (71%) and Castaneda (55%) both failed and will retake the written after 30 days.

07-16-10² **GREGORIO ARRIAGA FILM REVIEW**

Jockey Gregorio Arriaga appeared in the stewards' office to review his ride in yesterday's (July 15) second race. There was a stewards' inquiry (Ref: 07-10-10²) following this second race. Jockey Arriaga was aboard second place finisher #1 BENS BAC (Gregorio Arriaga) who drifted out and bumped first place finisher #6 THE RIGHT SUSPECT (Jesus Arriaga).

The stewards issued a warning in this matter.

07-16-10³ **ABEL CEDILLO FILM REVIEW**

Apprentice jockey Abel Cedillo appeared in the stewards' office along with interpreter/trainer Efrain Miranda to view his ride aboard #3 BALLEWAY in the seventh race on July 14. Apprentice Cedillo's mount finished third in this race (Ref: 07-14-10⁷) but was disqualified and placed eighth for interference inside the 1/8th pole.

Film review shows apprentice Cedillo veer inward under right handed whipping and severely impede two (2) rivals. Cedillo received a five (5) day suspension last month at Golden Gate Fields (Ref: GGF Ruling #97 – 06-13-10). The Sacramento stewards told Cedillo that clearance is mandatory before altering from a straight course. Apprentice Cedillo understood the reasoning behind the stewards' unanimous decision to issue the following ruling.

RULING #3 Apprentice Jockey **ABEL CEDILLO**, who rode **BALLEWAY** in the seventh race at the California State Fair on Wednesday, July 14, 2010, is suspended five (5) racing days (July 22, 23, 24, 25 and 28, 2010) for failure to make the proper effort to maintain a straight course in the stretch and causing interference resulting in the disqualification of his mount from third to eighth; a violation of California Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

07-16-10⁴ **CATALINO MARTINEZ FILM REVIEW – RULING NO. 4**

Jockey **Catalino Martinez** appeared in the stewards' office as ordered to review his ride in yesterday's (July 16) eighth race. Jockey Martinez rode seventh place finisher #2 CENTRIFUGE. Race replays show jockey Martinez whip his horse several times while 'backing up' (tiring) through the stretch run.

Jockey Martinez said he knew immediately why the stewards had 'called him in' for this film review today. He said he has never been fined for over whipping. A license history review confirmed this. License history and jockey Martinez' acceptance of responsibility mitigated this penalty. The stewards unanimously ruled to issue the following ruling.

Jockey **CATALINO MARTINEZ**, who rode CENTRIFUGE in the eighth race Thursday, July 15, 2010 at the California State Fair (Sacramento) is hereby fined two hundred dollars (\$200.00) for violation of California Horse Racing Board rule #1688 (Use of Whips).

07-16-10⁵ **INQUIRY – NO CHANGE – Second Race**

The stewards posted the inquiry sign after viewing first place finisher #3 GENUINE GUY (Chris Russell) race very green down the homestretch. Race replays show #3 GENUINE GUY veer out sharply under left hand whipping by jockey Russell. Film review shows that #3 GENUINE GUY was clear of second place finisher #4 MACHO MAURY (Gustavo Ortiz) when this incident took place.

The stewards unanimously ruled to make 'no change' in the order of finish.

07-16-10⁶ **OBJECTIONS – NO CHANGE – Third Race**

Jockey **Kayla Stra** and **Chad Schvaneveldt** filed separate jockey objections against first place finisher #2 FLYING GWEN (Michael Martinez) following this race. Jockey Stra was aboard third place finisher #3 POPULAR DATE, who finished third. Jockey Schvaneveldt was aboard #5 BOMBING TWO, who finished second.

#2 FLYING GWEN raced erratically in the stretch at one time causing #3 POPULAR DATE slightly off her straight course at the 1/8 pole. #5 BOMBING TWO did not appear to be affected whatsoever by the actions of #2 FLYING GWEN. After patrol judge input and after speaking with jockeys involved, the stewards unanimously ruled to make 'no change' in the order of finish.

Saturday07-17-10¹ **INQUIRY / OBJECTION – DISQUALIFICATION – First Race**

The stewards posted the inquiry sign to view two (2) incidents following this first race. The first incident involved seventh place finisher #5 ALVIN EDDIE (Anthony Ayala) who caused his own problems by rearing at the start.

In the second incident sixth place finisher #4 JJS HOTDIXIECHICK (James Wooten, Jr.) veers in sharply in front of eighth place finisher #3 AUNTIE RUBY (April Boag) severely impeding that rival. This incident happened in mid-stretch.

Jockey April Boag also lodged an objection against #4 JJS HOTDIXIECHICK following this race. After film review the stewards unanimously voted to disqualify #4 JJS HOTDIXIECHICK and place her eighth (last).

07-17-10² **INQUIRY / OBJECTION – DISQUALIFICATION – Second Race**

The stewards posted the inquiry sign after viewing a three (3) horse incident inside the ¼ pole. Also in this race, jockey Barrington Harvey (#8 OOH LAY LA, 8th place) lodged a claim of foul against #2 LELY ROTERRA (Chris Russell, 3rd place) and #5 GLEIRY (Jorge Ayarza, 4th place).

Race replays show #2 LELY ROTERRA veer out inside the ¼ pole bumping #8 OOH LAY LA forcing that horse into another horse on his outside #5 GLEIRY. Both of the riders on these horses (Jockey Harvey & Jockey Ayarza) were forced to check very sharply and lose all opportunity for a better placing. A patrol judge report was made and the stewards unanimously voted to disqualify #2 LELY ROTERRA and place him eighth. Jockey Chris Russell was ordered to film review with the stewards.

JAMES WOOTEN, JR. FILM REVIEW

Jockey **James Wooten, Jr.**, appeared in the stewards' office to review his ride aboard the mule #4 JJS HOTDIXIECHICK in yesterday's (July 17) first race (Ref: 07-17-10¹). #4 JJS HOTDIXIECHICK finished sixth and was disqualified and placed eighth following mid-stretch interference.

This mule was ruled unmanageable to ride in this race. Jockey Wooten was held blameless.

RULING NO. 5 – MALDONADO

Jockey **RODRIGO MALDONADO**, who was scheduled to ride **AUNTIE RUBY** in the first race at the California State Fair (Sacramento) on Saturday, July 17, 2010, is hereby fined the sum of one hundred dollars (\$100.00) for violation of California Horse Racing Board rule #1872 (Failure to Fulfill Jockey Agreement) causing a late rider change.

The foregoing ruling was issued after jockey Rodrigo Maldonado appeared in the stewards' office with interpreter/trainer Ramon Pulido.

07-18-10³

CHRIS RUSSELL FILM REVIEW – Ruling No. 6

Jockey **Chris Russell** appeared in the stewards' office to review his ride aboard #2 LELY ROTERRA in yesterday's (July 17) second race. #2 LELY ROTERRA was disqualified (Ref: 07-17-10²) and placed eighth in this race inside the ¼ pole.

Video review shows jockey Russell point his mount's head out and subsequently veer outward while attempting to 'pull out' his left handed whip. At this juncture jockey Russell loses control of his mount and he interferes with #5 GLEIRY (Jorge Ayarza) and #8 OOH LAY LA (Barrington Harvey). Jockey Russell agreed with the stewards that this was a substandard ride. The stewards unanimously voted to issue the following ruling.

Jockey **CHRIS RUSSELL**, who rode **LELY ROTERRA** in the second race at the California State Fair (Sacramento) on Saturday, July 17, 2010, is suspended three (3) racing days (July 25, 28 and 29, 2010) for drifting out entering the stretch and causing interference resulting in the disqualification of his mount from third to eighth; a violation of California

Horse Racing Board rule #1699 (d) & (f) (Riding Rules – careless riding).

The term of this suspension shall not prohibit participation in designated races in California.

07-18-10⁴ **TRAINERS' TEST**

Trainer Ramon Pulido administered a trainer's exam (Part II – Practical) at his barn today. New assistant trainer Marian Stansfield passed this test today along with Part III – Oral Exam, administered by CHRB Veterinarian Don Dooley. Ms. Stansfield is employed by her husband Chuck Stansfield. Steward Grant Baker proctored the test.

07-18-10⁵ **SMOOTH CARD**

Today's nine (9) race card went well, as it was free of steward inquiries and/or jockey objections.
