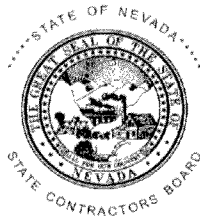

3. Discussion Concerning Legislative Initiatives by the Subcontractors Legislative Coalition

Mr. Dan Musgrove, legislative advocate for the Subcontractors Legislative Coalition, presented information on Bill Draft Request (BDR) 30, which seeks to add language to Nevada Revised Statutes Chapter 444

concerning the Uniform Plumbing Code, and BDR 441, which seeks to address the contractor exemption in NRS 624.031(5).

4. Discussion and Review of Pending Bill Draft Requests for the 2015 Legislative Session

Ms. Grein provided an overview on two BDRs submitted by the Board. BDR 386, which seeks to provide discretion for the Board to determine whether to issue a citation for work performed outside the scope of a contractor's license classification, and BDR 387, which makes various changes relating to the regulation of contractors by the Board.

Ms. Grein also presented on BDRs being tracked during the legislative session from various sponsors/authors.

5. Discussion Concerning Draft Financial Statement for the Period Ending September 30, 2014

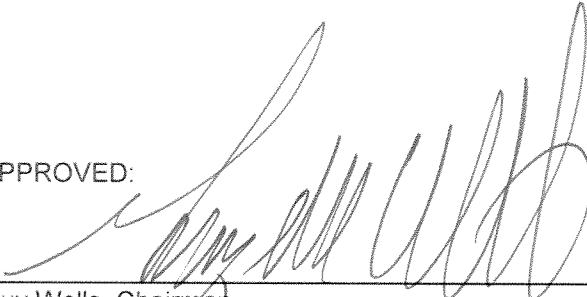
Ms. Grein and Ms. Deborah Lumbert presented on the draft financial statement.

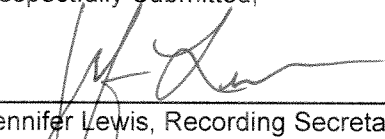
