The agenda was posted in compliance with the open meeting law **JUNE 5, 2014** at Washoe County Court House, Washoe County Library, Reno City Hall, Paseo Verde Library, Sawyer Building, and Clark County Library, both offices of the Board, on the Board's Internet Website and the Nevada Public Notice Website.

ADJUDICATING BOARD MEMBER: MARGARET CAVIN

1. DISCIPLINARY HEARING:

FUSION FABRICATION CORPORATION, LICENSE NO. 59834A

Licensee was not present.

Hearing Officer Cavin dismissed all charges in the complaint.

2. DISCIPLINARY HEARING:

ADVANCED GREEN BUILDERS INC., LICENSE NOS. 69549, 76325 AND 77731

Licensee was present and was represented by Philip Kreitlein, Esq.

Hearing Officer Cavin found Respondent Advanced Green Builders Inc., license numbers 69549, 76325 and 77731 guilty of violating NRS 624.301(1) by abandoning without legal excuse a construction project or operation engaged in or undertaken by the licensee as a contractor; NRS 624.301(5) by willfully failing or refusing without legal excuse on the part of a licensee to comply with the terms of a construction contract or written warranty, thereby causing material injury to another; NRS 624.302(5) by failing or refusing to respond to a written request from the Board or its designee to cooperate in the investigation of a complaint; NRS 624.3016(1) by committing a fraudulent or deceitful act in the capacity of a contractor, including, without limitation, misrepresentation or the omission of a material fact; NRS 624.3014(1) by acting in the capacity of a contractor under any license issued hereunder except: (a) in the name of the licensee as set forth upon the license; NRS 624.3018(2) which states in pertinent part that the performance by any partnership, corporation, firm or association of any act or omission constituting a cause for disciplinary action likewise constitutes a cause for disciplinary action against any licensee who is a member, officer, director or associate of such partnership, corporation, firm or

association, and who participated in such prohibited act or omission; NRS 624.3013(3) failing to establish financial responsibility. Respondent must pay fine of \$1,000 for the First Cause of Action, \$1,000 for the Second Cause of Action, \$250 for the Third Cause of Action, \$250 for the Fourth Cause of Action, \$100 for the Fifth Cause of Action, no fine imposed for the Sixth Cause of Action and \$500 for the Seventh Cause of Action for a total fine in the amount of \$3,100 and investigative fees in the amount of \$4,613.

3. DISCIPLINARY HEARING:

HEARTWOOD HOMES LLC, LICENSE NO. 77237

Licensee was present.

Hearing Officer Cavin has taken this under advisement.

5. FINANCIAL RESPONSIBILITY HEARING:

SIERRA DISPLAYS, LICENSE NO. 43038

Licensee was present.

Hearing Officer Cavin approved the financial review.

6. FINANCIAL RESPONSIBILITY HEARING:

FALANISESI MAKAKOLOAM PATETA DBA, KEYSTONE CONCRETE, LICENSE NO. 77177

Licensee was not present.

Hearing Officer Cavin found the licensee guilty of NRS 624.3013(3) failure to establish financial responsibility and NRS 624.302(5) failure to comply. License number 77177 is revoked. Respondent must pay investigative fees in the amount of \$477.89.

7. FINANCIAL RESPONSIBILITY HEARING:

RAUL INIGUEZ PAINTING, LICENSE NO. 77660

Licensee was present.

Hearing Officer Cavin found the licensee guilty of NRS 624.3013(3) failure to establish financial responsibility and NRS 624.302(5) failure to comply and reduced the monetary license limit to \$30,000.00.

8. FINANCIAL RESPONSIBILITY HEARING:

SNOWTECH INC. DBA NATIVE PAINT AND STAIN, LICENSE NO. 76695

Licensee was present.

Hearing Officer Cavin found the licensee guilty of NRS 624.3013(3) failure to establish financial responsibility, reduced the monetary license limit to \$50,000.00 with a one (1) year financial review.

9. FINANCIAL RESPONSIBILITY HEARING

V P DRYWALL, LICENSE NO. 77474

Licensee was not present.

Hearing Officer Cavin found the licensee guilty of NRS 624.3013(3) failure to establish financial responsibility and NRS 624.302(5) failure to comply. License number 77474 is suspended for thirty (30) days to provide requested information and pay the investigative fees in the amount of \$466.64. If not paid within thirty (30) days, the license will automatically be revoked.

10. FINANCIAL RESPONSIBILITY HEARING

DURO CONSTRUCTION LLC, LICENSE NO. 73908

Licensee was present.

This matter is continued for thirty (30) days.

11. FINANCIAL RESPONSIBILITY HEARING

TELECOMMUNICATIONS CABLING SERVICES LLC, LICENSE NO. 76667

Licensee was present.

Hearing Officer Cavin approved the financial review.

12. REACTIVATIVE DENIAL HEARING:

UTILITY SERVICES OF NEVADA INC, LICENSE NO. 69086


Licensee was present.

Hearing Officer Cavin approved the reactivation of the license and reduced the monetary license limit to \$10,000.00.
