NEVADA STATE CONTRACTORS BOARD MINUTES OF APRIL 22, 2015

Upon the Stipulation of the parties, ALJ Allison found Respondent guilty of one (1) violation of NRS 624.3013(5), as set forth in NAC 624.640(5) failure to include its license number and monetary license limit on its contracts and one (1) violation of NRS 624.3018(2) certain persons are prohibited from serving as officer, director, associate or partner of licensee. The Fourth Cause of Action was dismissed. Respondent was assessed a fine of \$50.00 for the Third Cause of Action and investigative costs of \$2,822.00. All fines and investigative costs are to be paid within 120 days of the April 22, 2015 hearing or license numbers 72238 and 72239, Majestic Flooring, Inc. shall be suspended. The Respondent shall hire a cleaning company who will be supervised by David Anderson using his cleaning protocol. Mr. Groover shall pick out the test area.
