ALJ Allison found Respondent Alpine Construction & Development, LLC, dba Energy Efficient Contracting, license number 77505 in default and adopted the Findings of Fact and Conclusion of Law as set forth in the Administrative complaint. The Respondent was found guilty of one (1) violation of NRS 624.3013(5), as set forth in NAC 624.640(5) failure to include its license number and monetary license limit on its contracts; one (1) violation of NRS 624.3013(4) failure to keep in force the bond for the full period required by the Board; one (1) violation of NRS 624.3013(5), as set forth in NAC 624.640(3) failure to notify the Board of a change of address; and one (1) violation of NRS 624.3013(3) failure to establish financial responsibility. Respondent was assessed a fine of \$500.00 for each of the First and Third Causes of Action; a fine of \$1,000.00 for the Fourth Cause of Action for total fines of \$2,000.00 and investigative costs of \$1,725.00. Respondent was found in violation of the Second Cause of Action; however a fine was not assessed. License number 77505, Alpine Construction & Development, LLC, dba Energy Efficient Contracting was revoked. Respondent is required to make full restitution to all damaged parties and reimburse the Board for any monies paid out of the Residential Recovery Fund plus pay the fines and investigative costs prior to consideration of future licensure.

The Respondent was found guilty of one (1) violation of NRS 624.3014(3) any attempt by a licensee to assign, transfer or otherwise dispose of a license or permit the unauthorized use thereof; two (2) violations of NRS 624.301(5) failure or refusal to comply with the terms of a construction contract; one (1) violation of NRS 624.3013(5), as set forth in NAC 624.700(3)(a) failure to comply with Board's Notice to Correct; one (1) violation of NRS 624.3013(5), as set forth in NAC 624.640(3) failure to notify the Board of a change of address; one (1) violation of NRS 624.3011(1)(b)(4) willful disregard and violation of the laws of this State regarding industrial insurance; one (1) violation of NRS 624.3013(5), as set forth in NRS 624.165(3)(e)(2) failure to hold a business license; one (1) violation of NRS 624.3013(4) failure to keep in force the bond for the full period required by the Board; and one (1) violation of NRS 624.3013(3) failure to establish financial responsibility. Respondent was assessed a fine of \$2,000.00 for each of the First, Second Third, Fourth, Sixth and Ninth Causes of Action; a fine of \$1,000.00 for each of the Fifth, Seventh and Eighth Causes of Action for total fines of \$15,000.00 and investigative costs of \$2,182.00. License number 74331, Professional Handyman Services, dba Flooring and Construction Services was revoked. Respondent is required to make full restitution to all damaged parties and reimburse the Board for any monies paid out of the Residential Recovery Fund plus pay the fines and investigative costs prior to consideration of future licensure.

The Respondent was found guilty of one (1) violation of NRS 624.3013(3) failure to establish financial responsibility; one (1) violation of NRS 624.302(5) failure or refusal to respond to a request to cooperate in the investigation of a complaint; and two (2) violations of NRS 624.302(6) failure or refusal to comply with a request for information or records. Respondent was assessed a fine of \$2,000.00 for each of the First, Second, Third and Fourth Causes of Action for total fines of \$8,000.00 and investigative costs of \$2,112.00. License number 57578, Double A Electric, LLC was revoked. Respondent is required to make full restitution to all damaged parties and reimburse the Board for any monies paid out of the Residential Recovery Fund plus pay the fines and investigative costs prior to consideration of future licensure.
