MINUTES OF THE WORKSHOP BEFORE THE NEVADA STATE CONTRACTORS BOARD HELD JULY 9, 2015

The workshop was called to order at 9:00 A.M. on Monday, July 9, 2015 at the offices of the State Contractors Board, 2310 Corporate Circle, Henderson, Nevada and video-conferenced to the Reno office. Exhibit 1 is the Notice of Intent to Act Upon a Regulation and a copy of the proposed regulation.

BOARD MEMBER PRESENT: Jan B. Leggett

STAFF MEMBERS PRESENT: Ms. Margi Grein, Executive Officer Ms. Nancy Mathias, Licensing Administrator

Ms. Grein explained the purpose of the workshop is to receive comments on proposed amendments to Chapter 624 of the Nevada Administrative Code to add a sub-classification to the B-General Building classification to allow remodeling and improvement of interior spaces, including structures which exceed more than three stories in height and buildings with fewer than three stories that are connected to structures which exceed three stories.

It was noted that the notice of the workshop was posted in compliance with NRS 233B at the Paseo Verde Library, Sawyer State Building, Clark County Library, Washoe County Courthouse, Washoe County Library, Reno City Hall and the offices of the State Contractors Board in Reno and Henderson. In addition, the notice was posted on the Board's website and the State of Nevada's Public Notice website.

Ms. Grein noted for the record that the proposed regulation under consideration was adopted as a temporary regulation on March 18, 2015 to comply with rules of the Legislative Counsel Bureau that are in place during a legislative session. This workshop and a hearing that will be held on July 16, 2015 is required in order for the Board to consider adopting the temporary regulation as a permanent regulation.

Two members of the public, Ms. Jeanette Belz, lobbyist for the Nevada Chapter of Associated General Contractors and Mr. Parker Stremmel of the Ferrari Public Relations Group representing AGC South were present. Neither offered comment.

Ms. Grein also noted that no additional written comments had been received since the adoption of the temporary regulation.

Since there were no comments, Ms. Grein stated that a hearing on the matter will be held July 16, 2015 at 9:00 a.m. at the same locations.

The workshop was adjourned at 9:07 a.m.
