Hearing Officer Quinn dismissed the First Cause of Action. The license limit for Respondent Sequoia Electric, LLC's license, number 54261, was lowered to \$518,000.00. The license limit for Respondent Sequoia Electric Underground, LLC license, number 72343, was lowered to \$534,000.00. The Board accepted the voluntary surrender of license number 52529, Blake John Barsy, Owner, dba Sequoia Electric Company.

Hearing Officer Quinn found Respondent guilty of one (1) violation of NRS 624.3017(1) substandard workmanship; one (1) violation of NRS 624.3011(1)(b)(1) violation of the building laws of the State; one (1) violation of NRS 624.3014(2)(a) aiding or abetting an unlicensed person to evade the provisions of this chapter; one (1) violation of NRS 624.302(6) failure to comply with a written request from the Board; one (1) violation of NRS 624.3013(3) failure to establish financial responsibility; and one (1) violation of NRS 624.3018(2) certain persons are prohibited from serving as officer, director, associate or partner of licensee. The Second, Third, Sixth and Eighth Causes of Action were dismissed. Respondent was assessed a fine of \$250.00 for each of the First, Fourth and Seventh Causes of Action; a fine of \$500.00 for each of the Fifth and Ninth Causes of Action for total fines of \$1,750.00 and investigative costs of \$2,509.00. Restitution is ordered to Melissa Steinberg in the amount of \$3,500.00. All fines, investigative costs and restitution are to be paid within ninety (90) days of the July 22, 2015 hearing or license numbers 32494 and 76268, Triangle Construction, Inc. shall be suspended. License number 32494 is suspended until a current financial statement along with bank verification form that supports a license limit of \$240,000.00 is provided to the Board. If the financial statement does not support a \$240,000.00 license limit, the license limit shall be lowered to the amount the financial statement supports.

Hearing Officer Quinn found Respondent Bob Glenn Lewis, Owner, dba Bob Glenn Lewis, license number 59335 in default and adopted the Findings of Fact and Conclusion of Law as set forth in the Administrative complaint. The Respondent was found guilty of one (1) violation of NRS 624.3017(1) substandard workmanship; one (1) violation of NRS 624.3013(5), as set forth in NAC 624.700(3)(a) failure to comply with Board's Notice to Correct; one (1) violation of NRS

624.3013(5), as set forth in NAC 624.640(5) failure to include its license number and monetary license limit on its contracts; one (1) violation of NRS 624.3011(1)(b)(4) violation of the laws of this State regarding industrial insurance; and NRS 624.3013(3) failure to establish financial responsibility. Respondent was assessed a fine of \$1,000.00 for each of the First and Fourth Causes of Action; a fine of \$500.00.00 for each of the Second, Third and Fifth Causes of Action for total fines of \$1,500.00 and investigative costs of \$2,510.00. License number 59335, Bob Glenn Lewis, Owner, dba Bob Glenn Lewis was revoked. Respondent is required to make full restitution to all damaged parties and reimburse the Board for any monies paid out of the Residential Recovery Fund plus pay the fines and investigative costs prior to consideration of future licensure.

d. ADAY SOLUTIONS, LLC, License No. 79039

Licensee was present but not represented by counsel at the hearing.

Hearing Officer Quinn continued this matter to August 19, 2015. License number 79039, Aday Solutions, LLC was suspended, Board Action.

e. CREATIVE INTERIOR SOLUTIONS, LLC, License No. 78348

Licensee was not present nor represented by counsel at the hearing.

The Respondent was found guilty of three (3) violations of NRS 624.3017(1) substandard workmanship; four (4) violations of NRS 624.3013(5), as set forth in NAC 624.700(3)(a) failure to comply with Board's Notice to Correct; four (4) violation of NRS 624.301(4) failure to prosecute a construction project with reasonable diligence; fifteen (15) violations of NRS 624.3013(5), as set forth in NRS 624.520(1) failure to provide Residential Recovery Fund notice to owner; fourteen (14) violations of NRS 624.301(2) abandonment of a construction project when the percentage of the project completed is less than the percentage of the total price of the contract paid to the contractor at the time of abandonment; two (2) violations of NRS 624.3011(1)(b)(1) violation of the building laws of this State; fifteen (15) violations of NRS 624.3013(5), as set forth in NAC 624.640(5) failure to include its license number and monetary license limit on its contracts; four (4) violations of NRS 624.302(5) failure to respond to a written request from the Board; four (4) violations of NRS 624.302(6) failure to comply with a written request from the Board; four (4) violations of NRS 624.3016(5), as set forth in NRS 624.600(1)(a)(b) failure to provide the required notices; twelve (12) violations of NRS 624.301(5) failure to comply with the terms of a construction contract; eleven (11) violations of NRS 624.301(1) abandonment of any construction project engaged in by the licensee as a contractor; and one (1) violation of NRS 624.3013(3) failure to establish financial responsibility.
