Hearing Officer Cavin found Respondent Parmac Builders LLC dba, Reliable Painting & Drywall, license number 73120 in default and adopted the Findings of Fact and Conclusions of Law as set forth in the Administrative complaint. Licensee was found guilty of violating NRS 624.305(1) and (2) Unlawful use, assignment or transfer of license; revocation of license. No license may be used for any purpose by any person other than the person to whom such license is issued, and no license may be assigned, transferred or otherwise disposed of to permit the unauthorized use thereof. The license of any person who violates any provision of this section shall be automatically cancelled and revoked; NRS 624.720(3) unlawful advertising; (3) all advertising by a licensed contractor must include the name of the contractor's company and the number of the contractor's license; NRS 624.3013(5) pursuant to NAC 624.640(3) if any change occurs in a licensee's address or personnel which affects the accuracy of the statements in the application upon which his or her license is based, the licensee shall report the change in writing to the Board within 30 days after the change occurs and NRS 624.3013(3) failure to establish financial responsibility. License number 73120 was revoked. Respondent shall pay a fine of \$500.00 for the First Cause of Action, \$1,000.00 for the Second Cause of Action, \$500.00 for the Third Cause of Action and \$500.00 for the Fourth Cause of Action, \$500.00 for the

revoked. Hearing Officer Cavin found the Respondent Maraton Construction LLC, license number 78359 guilty of violating NRS 624.3015(2) bidding or contracting for a sum for one construction contract or project in excess of the limit placed on the license by the Board; NRS 624.302(5) failing or refusing to respond to a written request from the Board or its designee to cooperate in the investigation of a complaint and NRS 624.3013(3) failure to establish financial responsibility. License number 78359 remains suspended. Respondent shall pay a fine of \$1,000.00 for the First Cause of Action, \$250.00 for the Second Cause of Action and \$500.00 for the Third Cause of Action for a total fine in the amount of \$1,750.00 and reimburse the Board for investigative costs of \$2,615.00. Fines and costs shall be paid within ninety (90) days and provide a current financial statement that supports the monetary license limit within ninety (90) days or license number 78359, Maraton Construction LLC, will automatically be revoked.
