Information/Comments:

The purpose of the CRC is to provide emergency housing, counseling and intervention for both the youth and the family. Placer County initiated the RFP in 2001 and in 2003, doorsopened as a Group Home Facility under Koinonia Group Homes, a division of Koinonia Foster Homes, Inc.. Youth ages served are 12-17.

The program staff works closely with the youth on social, life and return to the family setting skills.

Residents and staff have all meals together in a family setting. There is ample availability of exercise and sports interactive participation. There are at least 2 staff members on duty 24 hours a day. During the night hour's staff is required to swipe their I.D. every ½ hour to ensure the safety and supervision of all residents. The Parents/Guardians of the resident are also required to participate in the skills and communication building techniques. 2 phone calls a day are permitted with a time limit of 15 minutes per call. The only concern on the Commission's part is the funding availability for this program. Koinonia has proven that this program does save the County thousands of dollars and has been very effective since opening.

Youth interviewed stated that this was first time at the CRC. When asked about the rules, she stated they were good, fair and consistent. When asked about grievance policy, stated she did not know but did understand that if there was a problem to go to Supervisor Jeff. She stated she had had no problems with any of the staff. She stated all amenities were very satisfactory. When asked about the activities of the house, she stated that program check in is at 9:00 a.m., then P.E., Mind Stimulation, quiet time, Journal writing, etc. When asked what she liked about this C.R.C., youth responded, "Being away from home & and no one will yell or get mad at you." The youth stated that all staff is very helpful, encouraging & that the youth felt safe. The youth also stated that Supervisor Jeff has helped in the preparing for transition back to the family home.
