VI. 2013 Inspections

Commissioner Stodolski made clear that the Commission is obligated to have each member participate in at least one inspection. Inspection teams will be assembled to include at least one experienced Commissioner on each team. All reports are due June 1.

The Grand Jury does not have access to as many records as this Commission does at Juvenile Hall. If the Grand Jury sees an issue they are not able to pursue during their inspection in the fall, they will pass that concern on to Commissioner Stodolski and this Commission will follow up during our inspection in the spring.

Title XV inspections happen all the time at these facilities, so our Commission will instead concentrate on interviewing the kids at the facilities to flush out any concerns. Commissioner Richardson will modify the interview forms for this changed emphasis.

Commissioner Stodolski led a discussion on the best way to get a representative from Koinonia to present to the Commission in April.

Commissioner Richardson created a google group for this Commission and will resend invitations out for all to accept.

X. Probation Report

<u>Commissioner Urquidez moved and Commissioner Richardson seconded; Motion approved:</u> To simplify Probation Reports at Commission meetings, we will have rotating reports at each meeting from Probation, Juvenile Hall and CSOC instead of covering all 3 of these areas at each meeting.

Debra Smith, Division Manager for Juvenile Division, reported on Juvenile Hall, CSOC and Probation. A low number of kids are in group homes right now. This is being attributed to services provided at the very beginning of the process, which keeps them out of getting to the point of being on probation. In 2007, 127 kids were in out of home placement and today there are 21 in the same areas. Since a Probation Officer has fewer kids, they're able to spend more time with early intervention efforts.
