### **VIII. Inspection Committee:**

Commissioner Bader reported that the committee reviewed the questionnaires and the process used for inspections. She expects to have recommendations ready to propose at the August meeting. Commissioner Stodolski suggested this committee take responsibility for rewriting the Inspection section of the Policies and Procedures manual. They are considering a Master Schedule and an organizational meeting in January with the intent to have inspections completed by May. She would like to invite Judge Nichols to the August or September meeting to ask her what she would like to see done during the inspections.

### **IX. Hearing Committee:**

Commissioner Shinstock reported that a complaint has been received that more and more children are being prosecuted as adults. The committee plans to schedule an appointment with the District Attorney to look at the statistics to see how strong the trend is. They also want to determine what criteria the district attorneys are using to determine if a child is prosecuted as an adult.

### **X. Executive Committee:**

Commissioner Stodolski reported that the Policies and Procedures are still being worked on. This committee is also recruiting new commissioners and will publish an ad in the local newspapers.

### **XI. New Business:**
