Nevada Gaming Revenues and Collections

Win Revenue Summary – July 2013

Nevada’s nonrestricted gaming licensees reported a total “gaming win” of \$925,729,767 for the month of July 2013. This amounts to a 7.97% decrease compared to July 2012, when licensees reported a gaming win of \$1,005,877,250.

Percentage Fee Collections for the Month of August 2013

The State collected \$61,177,073 in percentage fees during the month of August 2013*, based upon the taxable revenues generated in July 2013. This represents a 9.40% (or \$6,344,724) decrease compared to the prior year's August, when percentage fee collections were \$67,521,797.
