

Judicial Branch – Supreme Court Commissions Project

The lawyer reporting modules (continuing legal education and client security) were placed in production operation in late February of 2006. Over eight percent of the total filings of each form were filed online during the 2006 filing season. In addition, lawyers are using the online system to submit applications for extension of time to complete CLE requirements, to submit CLE programs for review, and to request inactive or retired status. Once implementation of the final module of the project is substantially complete in December, the commissions' staff members will begin outreach activities to encourage lawyer use of the online system during the 2007 reporting period. Commissions' staff members expect significantly higher online filing rates by lawyers during the 2007 reporting period.

The public information module was placed in production operation in April of 2006. Members of the public now may search the lawyer database and the lawyer discipline database for public information regarding lowa lawyers, including source documents for approximately the past twenty years of public discipline, at: <u>http://www.iacourtcommissions.org</u>.

The CLE sponsor module was placed in production operation in August of 2006. The Commissions staff is bringing CLE sponsors online gradually as users of the module. Since the CLE sponsor module was activated, approximately 10% of the sponsor CLE applications have been submitted online. That percentage is increasing each month as additional sponsors receive their instructions and registration information for use of the site.

Development of the certified shorthand reporter module is complete. It was activated for CSR reporting the week of October 16th. Announcements regarding availability of online CSR reporting were mailed to the reporters on October 24, 2006 in time for the annual CSR reporting period, which concludes on December 30th. Slightly less than one-third of the CSR annual reports filed so far have been submitted using the online reporting module.

The remaining module to be implemented is the Interest on Lawyer Trust Account (IOLTA) interest reporting module. Final testing of the production edition of the IOLTA module is expected to begin with a limited set of banks during early December, with full implementation expected in January.

Iowa Board of Medical Examiners (IBME) Iowa Credentialing

At this point in the Iowa Credentialing Project, we are awaiting Iowa Interactive's finalization of the Board of Medical Examiners Database and the connected Iowa Credentialing Coalition's database. In addition, Iowa Interactive and the Iowa Medical Society and the Iowa Medical Group Management Association need to complete the contracting process for the Credentialing Coalition's database. Once these aspects come together, we will be ready to load the systems with real data from the physicians who are already licensed in Iowa. Future users will pay for data entry and use of the data; these aspects are defined in the contract.



Department of Natural Resources (DNR) Field Office Compliance Database

DNR has met twice with ITE. ITE has developed a project plan (including weekly meetings) and a high level outline of use cases. The plan is that ITE will develop a detailed design document in time to submit a proposal to IOWAccess at the March meeting to fund the project implementation.

Department of Natural Resources (DNR) Onsite Wastewater Permitting

The Onsite project was approved by the TGB after confirming there was no duplication in other government agencies, including ITE. The RFP was posted for Targeted Small Business and then on the DNR public website December 21. The venders' meeting is January 3 at 10:00 am. Bids are due on January 26. The plan is to have a decision made as to the vendor award by Feb. 12. The contract would start about April 1 contingent upon the approval of the DNR's Environmental Protection Commission.

Department of Natural Resources (DNR) Hunter Education

The Hunter Education project is on schedule. On December 19 and 20 a team of eleven DNR staff, one volunteer Hunter Education Instructor and the Project Manager of ITE gathered at Walnut Woods State Park Lodge for a project retreat. Prior to that meeting two ITE staff met with three DNR staff actors and case rolls were defined as to how the team was to map out each actor and the function description. The result was 23 page draft document representing everything from the public to the volunteer instructor to the person that enters the information for records retention and actual system functions. The new system tasks will save time and money for the state and make it more accessible and convenient for the public. The 23 page draft will be reviewed and approved the DNR before proceeding with ITE early in January.

Department of Natural Resources (DNR) NDPS

Several meetings have taken place between project staff and DNR staff. Project staff have indicated that they need more time and money to complete the planning phase of the project. DNR was expecting implementation with the funds allotted, but have been advised to seek additional funding from IOWAccess to complete the project.

Planning continues, until DNR makes a decision to move forward with another request for IOWAccess funds.
