NATO Editing Committee Meets

Operational leaders report a lack of training specifically geared to help them deal with unit member psychological stress on operations. These results were from a recent survey of 172 military leaders from 16 nations conducted by NATO Research & Technology Task Group (RTG-020). Survey results also identified specific areas for training improvement and suggestions about what leaders need to know regarding unit stress before, during and after NATO operations. The NATO Task Group is integrating these recommendations in a Leader's Guide to Psychological Support.

The information in this guide highlights:

- The role of leaders in supporting unit member mental health,
- · How to assess individual fitness and unit morale,
- · What to do in the aftermath of critical incidents, and
- How to provide family support over the course of the deployment cycle.

Members of the editing committee, Lt COL Cuvelier, Chair of the Task Group and an officer in the Belgian Armed Forces, Dr. Hacker Hughes, Vice-chair of the Task Group and military

scientist at Kings College in the UK, LTC Bliese and Dr. Adler edited the chapters (21-23 AUG 06).

The Task Group then met in Toulon, France for the final full meeting. The Task Group continued editing the Leader's Guide and developed plans to ensure operational leaders review the chapters before publication (17-22 SEP 06).

APA Symposium Provides Soldier Perspective on Traumatic Stress

Dr. Adler and LTC Bliese chaired a symposium entitled "Traumatic Stress Symptoms: The View from Combat" at the 114th meeting of the American Psychological Association held in New Orleans, LA (10-13 AUG 06).

The symposium included WRAIR presentations that addressed the epidemiological issues associated with traumatic stress, predisposing characteristics of Soldiers who report traumatic stress, Post-Deployment Health ReAssessment (PDHRA) of traumatic stress and comorbid symptoms, and issues of validity in diagnosing post-traumatic stress disorder in combat veterans.

USAMRU-E Completes Data Collection on Combat-to-Home Transition Study

The final data collection to assess the long-term efficacy of post-deployment psychological debriefing and Battlemind Training compared to traditional stress education was conducted from 19 JUN to 7 JUL 06.

In all, 2,254 surveys were administered. These surveys represent the 10 month follow-up to assess the efficacy of transition training conducted with units during the first week of reintegration following a year in Iraq. LTC Kruger, Deputy BCT Commander, was outbriefed on 6 JUL 06. (WRAIR protocol #862, Dr. Adler and LTC Castro, Principal Investigators).

Consulting on Soldier Risk-Taking at Post-Deployment

USAMRU-E provided subject matter expert (SME) support to the Europe Regional Medical Command (ERMC) on the topic of deployment and risk-taking. Results from recent USAMRU-E analyses linking risky drinking and driving with deployment experiences were integrated into a briefing prepared by ERMC for the USAREUR Safety Council chaired by GEN McKiernan, Commander, U.S. Army, Europe.

The brief, conducted by LTC Tryniszewski, Director, Soldier and Family Support Services, ERMC, was provided to GEN McKiernan and the Safety Council with LTC Bliese serving as a Subject Matter Expert (SME: 13 SEP 06). The brief was also developed by Dr. McCollum, Drug and Alcohol Control Officer, Installation Management Agency-Europe and Ms. Fontanese, Safety Officer, ERMC.

ERMC conducted preliminary briefs with BG Rubenstein, Commander, ERMC (6 SEP 06), COL Ciesla, Chief of Staff, ERMC (8 SEP 06), and CSM Diggs, ERMC (6&8 SEP 06). Dr. Adler served as the SME for these briefings.

Meeting in New Orleans

COL Hoge, LTC Bliese, and Dr. Adler met with Dr. Pennebaker, consultant on the unit's new post-deployment transition protocol (#1171), to discuss methodological design issues (12 AUG 06). The meeting was co-located with APA in New Orleans.

Force Health Protection Conference Features USAMRU-E Research

The 9th annual Force Health Protection conference sponsored by the Army's Medical Command featured three presentations involving USAMRU-E personnel. The presentations highlighted the work that USAMRU-E, in
