Subj: CHIEF OF NAVAL AIR TRAINING DISTRIBUTION LISTS

- 1. Purpose. To issue revised distribution lists for the Chief of Naval Air Training (CNATRA) directives and publications.
- 2. Cancellation. CNATRAINST 5215.1R
- 3. Definition. Distribution lists are defined as follows:
- a. List I provides for distribution throughout the Naval Air Training Command  $\overline{(\text{NATRACOM})}$ .
- b. <u>List II</u> provides for internal distribution to CNATRA Staff divisions, special assistants, and additional duty officers.
- 4. Requests for CNATRA Directives. In meeting paperwork reduction goals, the number of copies furnished by each list in enclosure (1) is considered sufficient to fulfill the requirements specified. If you need additional copies you are able to access CNATRA directives by going to the CNATRA homepage at https://www.cnatra.navy.mil/publications.htm.
- 5. NATRACOM Directives. CNATRA no longer requires or desires blanket copies of NATRACOM local command directives. Unless required by authority higher than CNATRA, only the following NATRACOM directives are to be submitted to CNATRA at the time of issue, revision or change.
  - a. Command Organizational Manual 2 copies

b. Command Index of Effective Instructions and Notices (5215s) - two copies. A 5215 Notice will be reviewed upon receipt and required directives requested only when absolutely necessary on a case-by-case basis.
